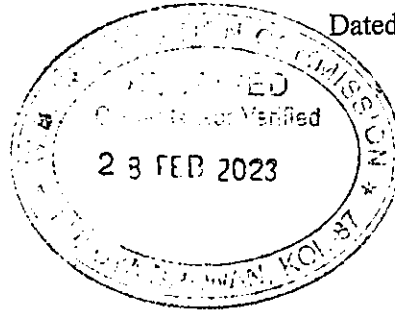




Facts on Record:

2. The SPIO & DC (HQ), Bidhannagar Police Commissionerate provided information received from Inspector-in-Charge, Cyber Crime Police Station, BDNPC to the appellant vide memo. no. 400/BDNPC/RTI dated 13.10.2022.
3. Ground for second appeal was dissatisfaction with the reply of SPIO and relief sought for is to provide the authentic information.
4. The SPIO & Jt. CP (HQ), Bidhannagar Police Commissionerate submitted action taken reports vide memo. nos. 851/BDNPC/RTI dated 17.11.2025 that the information had

already been provided to the appellant vide memo. no. 400/BDNPC/RTI dated 13.10.2022.
