Sir,

With reference to the above subject, this is to inform that Indira Mithya Das had sought information under RTI Act 2005 through RTI Application dated 30/04/2022 and 06/07/2022 from Mahitosh Das, T-I-C, Gopalkata Jelepura High School. Since the applicant received no reply from the school authority in response to her RTI applications she applied to the First Appellate Authority, Office of the DI/S(SE), South 24 Parganas. The RTI application of Indira Mithya Das dated 30/04/2022 was transferred to the school authority vide Memo No. RTI/16 dated 10/05/2022 **(Copy Enclosed)** and the RTI application of Indira Mithya Das dated 06/07/2022 was transferred to the school authority vide Memo No. RTI/34 dated 12/07/2022**(Copy Enclosed)**. The school authority did not reply to any of the RTI applications. Therefore a hearing was scheduled on 21/12/2022 but Mahitosh Das, T-I-C, Gopalkata Jelepura High School did not attend the hearing. Another hearing was scheduled on 29/12/2022 which he did not attend. A final hearing was scheduled on 10/01/2023 **(Copy Enclosed)** but he did not attend that too. A show cause letter (vide Memo No. RTI/07 dated 10/01/2023) **(Copy Enclosed)** was issued to him for dereliction of duty and insubordination. He was given a period of three days to reply to the show cause letter. However he did not give any reply to the show cause letter.
