Appellate Authority but a copy of the letter dated 15/02/2023 vide No. HF/O/GA/421/3A-46/23 addressed to the MSVP & SPIO, Medical College & Hospital, Kolkata, 88, College Street, Kolkata – 700 073, was forwarded through speed post to me the applicant/appellant herein, wherefrom it transpires that the said 1st. Appellate Authority had advised the said MSVP & SPIO, Medical College & Hospital, Kolkata, to look into the cause of my (i.e. applicant's/appellant's) dissatisfaction and accordingly furnish specific, unambiguous and complete information, if not exempted from disclosure, as was sought for in the original RTI application to me (i.e. applicant/appellant) Positively by 28.02.2023.

(A self attested photocopy of the aforesaid copy of the letter dated 15/02/2023 vide No. HF/O/GA/421/3A-46/23 addressed to the MSVP & SPIO, Medical College & Hospital, Kolkata, 88, College Street, Kolkata – 700 073, as was forwarded through speed post to me the applicant/appellant herein, is attached herewith). In utter disregard to the directions / advise of the aforesaid 1st. Appellate Authority the MSVP & SPIO, Medical College & Hospital, Kolkata, did not furnish specific, unambiguous and complete information, as was sought for in the original RTI application, to me (i.e. applicant / appellant) within the said stipulated date i.e. by 28.02.2023. Surprisingly on 11/03/2023 I (i.e. the applicant / appellant), received an envelope sent through speed post addressed to me (i.e. the applicant / appellant) from the 1st. Appellate Authority Swasthya Bhawan, GN-29, Sector - V, Salt Lake City, Kolkata - 700 091 wherefrom it transpires that the said 1st. Appellate Authority vide his cover letter dated 03.03.2023 under No. HF/O/GA/628/3A - 46/2023 have informed me that with reference to my 1st. Appeal dated 09/02/2023, the information, as received from MSVP & SPIO, Medical College Hospital, Kolkata vide memo no. MCH/2201/2023 dated 27.02.2023 is being furnished to me as enclosed/annexed with the said cover letter. The first enclosed/annexed letter was a copy of the aforesaid reply to the 1st. Appellate Authority vide memo no. MCH/2201/2023 dated 27.02.2023 wherefrom it was revealed that they are sticking to and in fact have not changed their initial response to Original RTI application in utter disregard to the order passed by the 1st Appellate Authority and have in fact have informed not to me but to the 1st Appellate Authority that their previous reply i.e. dated 11/01/23, Vide Memo No. MCH/433 along with its annexure i.e. Reply from Tender Inviting Committee, MCH, Kolkata, dated 10.02.23, which are to remain unchanged in respect to reply to the letter of the 1st. Appelate Authority vide Memo No. HF/0/GA/421/3A-46/23 dated 15/02/23. Hence the said MSVP & SPIO, Medical College Hospital, Kolkata have annexed therewith the said letter a verbatim copy of their said previous initial reply dated 11/01/23 to my original RTI Application, which was dissatisfactory on account of being incomplete, misleading or false information as per Sub Sec. (e) of Section 18 of the RTI Act, 2005 and far from being specific, unambiguous and complete information as was directed by the 1st. Appellate Authority.

#### (11). Ground of $2^{nd}$ . appeal and the relief sought (Specify):

#### **Grounds:**

- (1) The MSVP & SPIO, Medical College Hospital, Kolkata having replied to the original application under the RTI Act, 2005 and subsequently after the 1<sup>st</sup>. appeal was preferred, with incomplete, misleading or false information as per Sub Sec. (e) of Section 18 of the RTI Act, 2005.
- (2) The 1<sup>st</sup>. Appellate Authority did not fix any date for hearing of the matter and/or having not summoned me (i.e. the appellant) to personally be present at the time of such hearing as per the provisions of the RTI Act, 2005.
- (3) The 1<sup>st</sup>. Appellate Authority having failed to pass necessary final order within the stipulated time as mandated by the RTI Act, 2005 on the contrary the 1<sup>st</sup>. Appellate Authority having acted as a mere messenger of the MSVP & SPIO, Medical College Hospital by merely forwarding the same and original initial dissatisfactory reply of the MSVP & SPIO, Medical College Hospital to me the

appellant without passing any final speaking order as per the provisions of the RTI Act, 2005.

#### Relief sought for:

It is therefore most humbly prayed that this Ld. Commission be graciously pleased to pass:

- (a) necessary Order/Orders thereby directing the MSVP & SPIO, Medical College Hospital to furnish specific, unambiguous and complete information, as was sought for in the original RTI application, to me (i.e. applicant / appellant)
- (b) necessary Order/Order thereby imposing penalty upon the MSVP & SPIO, Medical College Hospital as per the provisions of Sub Section (1) of Section 20 of the RTI Act, 2005
- (c) necessary Order/Order thereby recommending for disciplinary action against the MSVP & SPIO, Medical College Hospital as per the provisions of Sub Section (2) of Section 20 of the RTI Act, 2005.
- (d) Necessary Order/Orders as to Cost and Compensation to be paid to me the appellant / applicant
- (e) Any other relief/reliefs that the appellant herein is entitled to in law and equity.
- (12). If 2<sup>nd</sup>. appeal is filed after 90 days from the date on which the decision of the 1<sup>st</sup>. Appellate Authority was received or after 135 days from the date of filing of the 1<sup>st</sup>. appeal, explain the reasons for the delay along with supporting documents:


