

- 2. The appellant/complainant may present his/her case(s) in person or through his/her duly authorized representative either in physical mode or in virtual mode, as may be suitable to him / her. Details of link for joining in virtual mode are given below.
- 3.The Public Authorities may attend the hearing physical mode or in virtual mode, as per convenience.
- (a) SPIO should personally join the hearing; if for a compelling reason(s) he/she is unable to be present, he/she has to give reasons for the same and shall authorise an officer not below the

equivalent rank of SPIO, fully acquainted with the facts of the case and bring complete file/file(s) with him.

- (b) If the SPIO attending the hearing before the Commission does not happen to be the concerned SPIO, it shall still be his/her responsibility to ensure that the SPIO(s) concerned must attend with complete file concerning the RTI request, the hearing along with him.
- 4. All the parties may submit their written submission, if any, to the Commission at least 7 days before the date of hearing. A copy of the same shall be served upon opposite party. If any party wishes to make online submission, the same may be sent to the Commission's link only viz., https://www.wbic.wb.gov.in/online-link-paper-compliance/add
- 5. SPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.
- 6. The authorised representative or the officer of the public authority and the appellant/complainant/third party is advised to carry a "proof of identity" along with the authorization letter.
- 7. Take notice that in default of your appearance on the time and date mentioned aforesaid, the case shall be heard and decided in your absence and that there will be no adjournment and review.
- 8. The parties concerned should reach the venue at least 30 minutes before the scheduled time of hearing. They are also requested to intimate their telephone/mobile numbers and email address to the undersigned.





Upon receipt of all Hearing Notices it is found that all the Appeals are related to DIT, WB and the SPIO, DIT on being contacted it appears that the 'Applicant in all cases is the single person named Sri Ayan Chaudhury of Durgapur in Paschim Burdwan. Mr. Ayan Chaudhury is an employee under administrative control of DIT and joined as LDC in Durgapur and subsequently promoted to UDC in Durgapur and he was assigned the work of Storekeeper. Later, he was transferred to Tung in Darjeeling district. Being aggrieved with the order he has not yet joined his new assignment. Instead he preferred to file a case in SAT which had been disposed on 01.12.2023 by the Hon'ble Chairperson of the Tribunal .Thereafter he appealed before Hon'ble High Court at Calcutta under WPST 197of 2023 and the Hon'ble Court had been pleased to dismiss the Appeal on 04.01.2024 on the ground that the transfer was made on administrative ground.

This is the backdrop of the Applicant who has filed all the five above noted Appeals which are scheduled for Hearing on 29.04.2025 before Hon'ble SCIC.

Darjeeling is still existing and the petitioner is free to join the transferred post.

Heard the learned advocates appearing for the respective parties and considered the materials on record.

Transfer is an incidence of service and such order should not be interfered with unless the same is palpably illegal, arbitrary or mala fide.

The argument of Mrs. Dhabal that the transfer order was issued in derogation to the conditions incorporated in the advertisement, particularly Clause 4 of the same, is not acceptable to us. The said condition was as regards appointment and not transferability. The 2010 Rules which came into effect after the petitioner's appointment have no manner of application. The transfer order was issued on 22nd October, 2022 and the petitioner approached the learned Tribunal almost about 10 months thereafter in the month of August, 2023. The petitioner has failed to establish any arbitrariness or mala fide in the order of transfer.

In view thereof, the learned Tribunal rightly did not exercise discretion in favour of the petitioner and accordingly, no interference is called for in the present writ petition and the same is dismissed.

There shall, however, no order as to costs.

2010 (in short, the 2010 Rules). The order of transfer and the order of release were issued on the same date in hot haste. Such issues, as urged, were glossed over by the learned Tribunal and no finding was returned on the same and the original application was dismissed by a cryptic order. Such infirmity warrants interference of this Court.

Mrs. Dhabal further submits that after issuance of the impugned order of transfer repeated representations were submitted by the petitioner but the same were not responded to. Aggrieved thereby the petitioner was constrained to approach the learned Tribunal.

Mr. Mukherjee, learned Additional Government Pleader appearing for the State respondents denies and disputes the contention of the petitioner and submits that transfer is purely an incidence of service. On administrative ground the petitioner was transferred from ITI, Durgapur to ITI, Tung in the district of Darjeeling. The petitioner deliberately did not join the transferred post and had continued in unauthorised absence till date. In the said conspectus, the learned Tribunal did not interfere with the order of transfer and there is no infirmity in the same.

Answering our query, Mr. Mukherjee, however, submits that the vacancy in ITI, Tung in the district of

The present writ petition has been preferred challenging an order dated 1st December, 2023 passed by the learned Tribunal in the original application being O. A. No. 595/2023.

Mrs. Dhabal, learned advocate appearing for the petitioner submits that the petitioner was initially appointed as a Lower Division Clerk in a selection process initiated by an advertisement being no. 4/2008. Subsequent thereto, he was promoted to the post of Upper Division Clerk and was working at ITI, Durgapur. Clause 4 of the advertisement specifically provided that 'the candidate will have to opt for one particular district from the schedule 'A' given below and he/she will be considered for vacancy in that district only according to his/her option'. In violation of such condition, as specified, the petitioner was transferred by an order dated 20th October, 2022 from ITI, Durgapur to ITI, Tung in the district of Darjeeling. The said transfer order was also not in consonance with the West Bengal (Recruitment to Clerical Cadre) Rules,

The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Affidavit of service filed be kept on record.

The applicant being a UDC was issued a transfer order along with another government employee by an order dated 20.10.2022 on administrative grounds from ITI, Durgapur to ITI Tung, Darjeeling. Subsequently, the Director, ITI, Durgapur issued his release order with further direction to join his new place of posting at ITI, Tung, Darjeeling. Since he had not complied with the transfer order, the applicant was also issued a show-cause notice by the Director of Industrial Training on 24.04.2023. It is submitted that the applicant has not responded to the show-cause notice nor joined his new place of posting on transfer. It is also noteworthy that the show-cause points out that he did not handover the charge of store of ITI, Durgapur, his last place of posting. From the show-cause notice, it appears that a disciplinary proceedings against him is being contemplated. Earlier, by a representation he had expressed his difficulty in joining the new place of posting due to personal reasons.

Having heard the submissions of the learned counsels and considering the facts and circumstances of the case, this Tribunal is of the firm opinion that transfers are part of service life of a government employee and transferring on administrative grounds without any malice is the prerogative of the respondent authorities. It appears in this case, the applicant has refused to join his new place of posting from Durgapur to Darjeeling citing personal reasons. It is the view of this Tribunal that it should not interfere in the routine administrative matters of the department.

Accordingly, this application is disposed of without passing any orders.

  - ii) What is transfer on 'administrative ground' and what are the criterias/reasons/clauses of transfer on 'Administrative Ground'?
  - iii) Whether in the body of each and every transfer order, issued by this directorate, the term that the transfer has been made on 'Administrative Ground' is mentioned or not?
  - iv) Can an employee of main land/plain land, who has not prayed for transfer, be transferred to the Nepali speaking district of Darjeeling?
  - v) Is seniority (Service Seniority and station seniority) taken into consideration while issuing any transfer order under this department? AND
  - vi) Can a clerical staff, who is on pre-sanctioned leave, be released from a particular post before expiry of leave?
- B) SPIO, Directorate of Industrial Training sent a reply to the appellant vide no. 11R-2/Estb(Recruit)/5513 dated 24.01.2023.

  - iv) Please state whether Sri Arun Duary [erstwhile instructor (machinist) of ITI Durgapur], presently instructor (machinist) of ITI., Midnapur, had taken departmental permission [in accordance to clause 5(2) of West Bengal Services (duties, rights and obligations of government employees) rules 1980] before selling 3.3183 decimal land (RS. plot no. 324 & RS khatian no. 543) on 29/07/2022 and subsequently before buying 19 decimal land (LR. plot no. 41 & LR. khatian no. 119) on 25/08/2022 or not? And
  - v) If the answer of question no. 4 is positive then please send an attested/certified photocopy of Sri Duary's "prayer for permission" letter and also an

- attested/certified photocopy of the "permission given" letter from your end to my under-mentioned address.
- B) SPIO, Directorate of Industrial Training sent a reply to the appellant vide no. 11R-2/Estb(Recruit)-Nil dated 20.02.2023.
- C) Grounds for 2<sup>nd</sup> appeal is incomplete information.
- D) Relief sought for by the appellant is to provide proper information in respect of question no. 1, 2, 4 & 5.

#### 6. Appeal no. 104340 of 2025

- 7. An ATR received from SPIO, Directorate of Industrial Training & Technical Education vide memo no. 55-TETSD/2025 dated 24.04.2025 stating that earlier reply sent to the appellant vide para 2(B), 3(B), 4(B), 5(B) and 6(B) & (C).

#### Decision & Deliberations:

- 8. The appellant along with his father Shri Ajoy Chaudhury is present in person.
- 9. The SPIO and the First Appellate Authority both are present in person.
- 10. The appellant stated that he is an employee of Technical Education, Training & Skill Development. He discussed about RTI application dated 23.12.2022 Appeal No. 104339 vide para 3 above. He stated that the reply to the query no. iv), v), vi) is not proper. SPIO submitted that these are personal information and it has been denied under S. 8 (1) (j) RTI Act. The Commission observed that query no. 4 is about general qualification of the

candidates for recruitment test which was conducted in 2008 (as per the appellant). After laps of 15 years the appellant has filed RTI application and asking the general qualification of that recruitment test. Reply to this query will not serve any public interest. This is wastage of time of Public Authority and therefore, need not be replied. Query no. 5 is a personal information exempted under S. 8 (1) (j). Query no. 6 is vague, general, wide and need not be replied. This Case is closed.

- 11. Appeal no. 104433 dated 31.01.2023 vide para 4 above In query no. 1, the appellant has been asking for the reason for his transfer. SPIO submitted that it has been done on administrative ground and for this a writ petition vide WPA no. 187/2023 dated 04.01.2024 was filed in the Hon'ble Calcutta High Court also. The appellant reportedly did not get any relief. More so, the reason is not part of RTI Act and it is not information under S. 2 (f) (j), RTI Act. The Case is closed.
- 12. Appeal No. 104331 of 2025 vide para 2 above, Appeal no. 104434 of 2025 vide para 5 above and Appeal no. 104340 of 2025 vide para 6 above. After going through the queries of the RTI applications, the Commission observed that all these queries are general, wide, vague, omnibus & voluminous. The reply to these queries will not serve any public interest and even any bonafide personal interest. This is mere a harassment of Public Authority and at the same time a complete misutilisation of RTI Act. Therefore, this need not be replied. This has reference to the following provision of RTI Act and case law.
  - (a) The preamble of the RTI Act, 2005 says that democracy requires informed citizenry and transparency of information which are vital to contain corruption and to hold Govt. accountable. This aim of the Act has to be harmonized with other public interest including efficient operation of Govt., optimum use of limited fiscal resources etc.
  - (b) Section 6 (1), RTI Act.
  - (c) Section 7 (9) of the RTI Act.
  - (d) Hon'ble Supreme Court judgement of 2011 in case of Aditya Bandyapadhya vs. CBSE.
  - (e) Hon'ble Supreme Court judgement dated 02-09-2011 in The Institute of Chartered Accountant of India Vs. Shaunak H Satya and Ors.
  - (f) Shail Sahni Vs. V. S. Mathew & others (Delhi High Court, 2016).
  - (g) Shishir Chand Vs. Central Information Commission (Delhi High Court, 2023).

13. Appellant is advised that in future he should file RTI application keeping in view the spirit of the RTI Act and various judgements of Hon'ble Supreme Court & Hon'ble High Court. The case is closed.

14. The matter is disposed of.

  - vi) If the answer of query no. 1 is positive, please send the list of names and address of all the candidates who applied and competed in the above-referred exam.
- B) SPIO, Directorate of Industrial Training sent a reply to the appellant vide no. 11R-2/Estb(Recruit)/5512 dated 24.01.2023.
- C) Grounds for 2nd appeal is non-receipt of any decision from 1st appellate authority.
- D) Relief sought for by the appellant is to provide proper information in respect of question no. 4, 5 & 6.

# 4. Appeal no. 104433 of 2025

A) Shri Ayan Choudhury, vide his application dated- 31.01.2023 requested for the following information from the SPIO, Technical Education, Training & Skill Development Department:-

- i) In accordance to rule 4(1)(d) of the Right to Information Act, 2005 please elaborately state the reason for transferring me (Ayan Chaudhury) on Administrative Ground from ITI Durgapur to ITI Tung vide order bearing memo no. 1/333205/2022 (4e-1/gen/13), dated 20/10/2022.
- B) SPIO, Directorate of Industrial Training sent a reply to the appellant vide no. 11R-2/Estd. (Recruit)-Nil dated 20.02.2023.
- C) Grounds for 2<sup>nd</sup> appeal is incomplete information & non-receipt of any decision from 1<sup>st</sup> appellate authority.
- D) Relief sought for by the appellant is to provide proper information.

# 5. Appeal no. 104434 of 2025

- A) Shri Ayan Choudhury, vide his application dated- 31.01.2023 requested for the following information from the SPIO, Technical Education, Training & Skill Development Department:
  - i) Please send an attested/certified photocopy of the Transfer policy framed by the technical education, training and skill development department vide no. 392 tet (trg)/2e-231/2010, dated 09/09 2011 to my under-mentioned address.
  - ii) Please state whether any staff-member under the control of this directorate, who has been transferred and subsequently released by the concerned DDO., but has failed to join his new place of posting under the new DDO. due to grave family problems, is entitled to receive monthly salary or not?
  - iii) If the answer of point no. 2 is positive then please mention who will draw and disburse the monthly salary and sanction the leave in respect of the above-referred staff-member during the period of his inability to join the new posting?
  - iv) Please state whether Sri Arun Duary [erstwhile instructor (machinist) of ITI Durgapur], presently instructor (machinist) of ITI., Midnapur, had taken departmental permission [in accordance to clause 5(2) of West Bengal Services (duties, rights and obligations of government employees) rules 1980] before selling 3.3183 decimal land (RS. plot no. 324 & RS khatian no. 543) on 29/07/2022 and subsequently before buying 19 decimal land (LR. plot no. 41 & LR. khatian no. 119) on 25/08/2022 or not? And
  - v) If the answer of question no. 4 is positive then please send an attested/certified photocopy of Sri Duary's "prayer for permission" letter and also an

- attested/certified photocopy of the "permission given" letter from your end to my under-mentioned address.
- B) SPIO, Directorate of Industrial Training sent a reply to the appellant vide no. 11R-2/Estb(Recruit)-Nil dated 20.02.2023.
- C) Grounds for 2<sup>nd</sup> appeal is incomplete information.
- D) Relief sought for by the appellant is to provide proper information in respect of question no. 1, 2, 4 & 5.

# 6. Appeal no. 104340 of 2025

- A) Shri Ayan Choudhury, vide his application dated- 11.01.2023 requested for the following information from the SPIO, Industrial Training Institute Durgapur:
  - i) Please furnish and send the attested photocopies of the bills of all materials purchased in the Institute during the period from 01/03/2021 to 30/09/2022, under model ITI scheme and IMC scheme, to my under-mentioned address.
- B) SPIO Industrial Training Institute Durgapur sent a reply to the appellant vide no. ITI/DGR/RTI/802 dated 08.02.2023.
- C) Jt. Director ITI, Durgapur sent a reply to the appellant vide no. RO/DGR/82/132(2) dated 20.02.2023.
- D) Grounds for 2<sup>nd</sup> appeal is incomplete information.
- E) Relief sought for by the appellant is to provide proper information.
- 7. An ATR received from SPIO, Directorate of Industrial Training & Technical Education vide memo no. 55-TETSD/2025 dated 24.04.2025 stating that earlier reply sent to the appellant vide para 2(B), 3(B), 4(B), 5(B) and 6(B) & (C).

#### Decision & Deliberations:

- 8. The appellant along with his father Shri Ajoy Chaudhury is present in person.
- 9. The SPIO and the First Appellate Authority both are present in person.
- 10. The appellant stated that he is an employee of Technical Education, Training & Skill Development. He discussed about RTI application dated 23.12.2022 Appeal No. 104339 vide para 3 above. He stated that the reply to the query no. iv), v), vi) is not proper. SPIO submitted that these are personal information and it has been denied under S. 8 (1) (j) RTI Act. The Commission observed that query no. 4 is about general qualification of the

candidates for recruitment test which was conducted in 2008 (as per the appellant). After laps of 15 years the appellant has filed RTI application and asking the general qualification of that recruitment test. Reply to this query will not serve any public interest. This is wastage of time of Public Authority and therefore, need not be replied. Query no. 5 is a personal information exempted under S. 8 (1) (j). Query no. 6 is vague, general, wide and need not be replied. This Case is closed.

- 11. Appeal no. 104433 dated 31.01.2023 vide para 4 above In query no. 1, the appellant has been asking for the reason for his transfer. SPIO submitted that it has been done on administrative ground and for this a writ petition vide WPA no. 187/2023 dated 04.01.2024 was filed in the Hon'ble Calcutta High Court also. The appellant reportedly did not get any relief. More so, the reason is not part of RTI Act and it is not information under S. 2 (f) (j), RTI Act. The Case is closed.
- 12. Appeal No. 104331 of 2025 vide para 2 above, Appeal no. 104434 of 2025 vide para 5 above and Appeal no. 104340 of 2025 vide para 6 above. After going through the queries of the RTI applications, the Commission observed that all these queries are general, wide, vague, omnibus & voluminous. The reply to these queries will not serve any public interest and even any bonafide personal interest. This is mere a harassment of Public Authority and at the same time a complete misutilisation of RTI Act. Therefore, this need not be replied. This has reference to the following provision of RTI Act and case law.
  - (a) The preamble of the RTI Act, 2005 says that democracy requires informed citizenry and transparency of information which are vital to contain corruption and to hold Govt. accountable. This aim of the Act has to be harmonized with other public interest including efficient operation of Govt., optimum use of limited fiscal resources etc.
  - (b) Section 6 (1), RTI Act.
  - (c) Section 7 (9) of the RTI Act.
  - (d) Hon'ble Supreme Court judgement of 2011 in case of Aditya Bandyapadhya vs. CBSE.
  - (e) Hon'ble Supreme Court judgement dated 02-09-2011 in The Institute of Chartered Accountant of India Vs. Shaunak H Satya and Ors.
  - (f) Shail Sahni Vs. V. S. Mathew & others (Delhi High Court, 2016).
  - (g) Shishir Chand Vs. Central Information Commission (Delhi High Court, 2023).

- 13. Appellant is advised that in future he should file RTI application keeping in view the spirit of the RTI Act and various judgements of Hon'ble Supreme Court & Hon'ble High Court. The case is closed.
- 14. The matter is disposed of.
