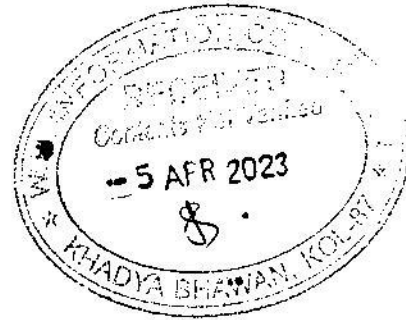

As per the reply (Memo no 319/SDO (G) dated 01/02/2023) against my RTI application dated 05/01/2023 the SPIO inform me that in my application point no 1,2,3,4,5,6,7 are queries which is related to the eligibility for getting cast certificate, but my application is not about that. My queries as follows

1. Were Ms Piu Das and Partha Das submitted two different affidavits (first class Magistrate) for two different casts certificate (OBC & SC)?
2. Were Ms Piu Das and Partha Das submitted two different cast certificate of Panchayat, which were issued by same panchayat for getting two different cast certificate (OBC & SC)?
3. Were Sanjib Das mentions the name and SC certificate of Uttam Das as family member or as a blood relation in his cast certificate application?
4. Were Sanjib Das, Piu Das and Partha Das submitted their voter list and ID for their address prove and Identity proves (for the year 2011, 2012, 2013)?
5. What kind of address proves they submitted at the time of hearing?
6. Whose references are accepted as a referee in cast certificate application?
7. Anybody from another village/ part no, another Gram Panchayat, can refer a person for cast certificate?

The SPIO intentionally hide the true fact in that reply. In that reply officer mention an order (order no 1203 -BCW/MR-88/2014: dt 27.07.2015) of the year 2015, but in my application I mention the certificates which were issued in the year 2012 and 2013 (only one in 2016), officer also mention an URL, which was developed or updated in the year 2017, so I did not get my particular information from that reply and I doubt the officers trying to divert the query, and hide or destroy some important documents (where I mentioned the certificates numbers).

In point no 10, I want to know about the legal provision of fake cast certificate and legal steps by authority.

As per RTI reply format (rule) SPIO not mentioned the first appellate authority in said reply.

For above reasons, I had submitted the first appeal to the first appellate authority (unknown) on 08/02/2023. But till date I don't get any reply from first appellate authority, so I submitting my second appeal to the STATE CHIEF INFORMATION COMMISSIONER.

Sir,

I am writing this letter in connection with Sri Sanjib Das (SC certificate no WB1101SC201200972), S/O Late Surendra nath Das, Miss Piu Das (SC Certificate No WB1101SC201300945 and OBC certificate No WB1101OBC 201111619), D/O Sanjib Das and Sri Partha Das (OBC certificate no WB1101OBC201111620), S/O Sanjib Das. Hereby, I want to bring some documents and information in to your notice

1. In the year 2011 Parthe Das and Piu Das applied for OBC certificate and respective department accepted the application and provided them the certificate. That's mean they submitted all the relevant documents including affidavit (first class Magistrate), panchayet certificate, address prove and others along with the applications. That is necessary to be submitted before the caste certificate authority at the time of prayer for issuing caste certificate. Copy of OBC certificate of Piu Das and Partha Das are enclosed.
2. Ms. Piu Das in the year 2012 applied for Scheduled Caste (for brevity referred to as SC) certificate from the office of the SDO Barasat alleging in the said form that Sri Uttam Das is her paternal uncle who belongs to the SC category having certificate no.5895 dated 24.06.1996. It is pertinent to mention here that the father of the said Ms. Piu Das obtained SC certificate in the year 2012 by purporting the same false information. Anyway in the year 2012 the application of Ms. Piu Das got rejected. But the said Ms. Piu

obtaining their OBC certificate and SC certificate of Piu Das and Partha Das. Mr. Sanjib Das, father of Ms. Piu Das and Partha Das exhibited his address as Nakpul that comes under the said Bergum - I Gram Panchayat while obtaining his SC certificate. Ms Piu Das also exhibited her address as Nakpul that comes under the said Bergum - I Gram Panchayat while obtaining her SC certificate. I further assert that the said Ms. Piu Das, her father Mr. Sanjib Das and Partha Das until 2015 resided at Maslandpur, under Maslandpur - I Gram Panchayat. As the said Maslandpur - I Gram Panchayat was aware of the said persons' caste statuses, the said persons entered into conspiracy with the authorized personnel of Bergum - I No. Gram Panchayat for getting the false attestation paper of address and caste status, that is necessary to be submitted before the caste certificate authority at the time of prayer for issuing caste certificate. There was no address proof of the said Ms. Piu Das and Sanjib Das at Village Nakpul when they were granted with the SC Certificate (except residential certificate from Panchayat, the Panchayat member or pradhan who certify one person in deferent sub cast category). The said persons started living in Village Nakpul only from 2015 and after. I would like to states that the father of the Ms Piu Das is a highly political influential person in the local area. He, taking advantage of his political power, has been committing anarchies in the local area since a long time and now he has also habitually helped his daughter and son to commit the illegal things to get enrolled in the government Services by committing all the fabrications she thought was necessary.

I would like to refer to the voter list of year 1971 that shows the presence of the name of the father of the said Mr. Sanjib Das (Surendranath Das) in Maslandpur; and voter list for the year 2015 showing the presence of the name of the father of the said Ms. Piu Das and Partha Das in Maslandpur - I Gram Panchayat.

6. They mention the name of Archana Paul as first reference, (who is also maternal aunty of Partha Das and Piu Das). I further assert that the said Mrs. Archana Paul (my wife) until 2022 resided (according to voter ID) at village Betpul, Maslandpur, under Maslandpur - I Gram Panchayat. And these circumstances her reference must not be granted as a referee. The referee must be from same village and same pamchayat. For your kind

- information I would like to state that they use her reference for SC certificate without her permission as they asking the reference for OBC certificate several time, and she provided them copy of voter ID (duly signed), but they use it for SC certificate as well. After know this incident Archana Paul put her objection before the authority. Voter ID and Voter list of Archana Paul for the year 2011, 2012 enclosed.
7. I like to states that after being certain about the illegalities committed by such Ms. Piu Das and Partha Das, and violate the Oath Act 1969 by taken false Oath in front of Honourable Magistrate (first class) and committed crime (u/s IPC 193). I submitted representation before different responsible and respected authorities of the State of West Bengal stating *inter alia* that Ms. Piu Das and Partha Das by suppressing the material facts for intention of forgery as regards her OBC Certifiacte has obtained appointment in the department in the category of SC. A citizen must not have two cast certificates- one OBC another SC. Ms. Piu Das and Partha Das by using fake and fabricated SC certifiacte has obtained an employment in the government Service. Due to such heinous falsehood a *bona fide* candidate who actually belongs to the SC category must have been deprived of employment. Hence I am being a lawful citizen prayed before such respected authorities that upon proper and official verification such usurper must be removed from the noble position and seat which they have tainted.
 8. Both the OBC certificate and SC certificate of the said Piu Das and Partha Das was in force together, both at once, at the time the said Piu Das and Partha Das got their enrolment in the Government service and they at the time of enrolment submitted that they are categorized under the SC category RISHI caste when it is fact that the said respondent had suppressed her status as OBC-B category. In that case again they have done forgery to get government job and committed crime u/s IPC 420. They also committed crime U/S IPC 468 (forgery to cheat).
 9. As me and my family are close relative of Sanjib Das and his family that's why we know very well about their cast and family background. **I further like to state that one of their relative with blood relation Mr. Prabir Das, nephew of Sanjib Das and cousin of Piu Das and Partha Das, got promoted in OBC category from head Warder to Chief Head Warder in**

West Bengal correctional service under Government of West Bengal Order dated 05/08/2022 by Rajesh Kumar Yadav, IPS (IG of Correctional Services, West Bengal) copy enclosed. The blood relation between them can prove by scientific investigation (DNA Test) if they deny the relation.

10. Ms Piu Das and her family already unauthorizedly occupying the property of Archana Paul as she is a Judicial Officer in the district court. She uses her influence and position for illegal occupancy.

Hereby I am requesting your office for providing following information or documents under RTI act 2005.

1. Were Ms Piu Das and Partha Das submitted two different affidavits (first class Magistrate) for two different cast certificate?
2. Were Ms Piu Das and Partha Das submitted two different cast certificate of Panchayat, which were issued by same panchayat for getting two different cast certificate?
3. Were Sanjib Das mentions the name and SC certificate of Uttam Das as family member or as a blood relation in his cast certificate application?
4. Were Sanjib Das, Piu Das and Partha Das submitted their voter list and ID for their address prove and Identity proves (for the year 2011, 2012, 2013)?
5. What kind of address proves they submitted at the time of hearing?
6. Whose references are accepted as a referee in cast certificate application?
7. Anybody from another village/ part no, another Gram Panchyat, can refer a person for cast certificate?
8. Reason to issues two different cast certificates in favour of same persons within a year without proper verification (when one cast certificate in force).
9. As per the RTI reply from your side, you inform me that OBC cast certificate of Piu Dsa and Partha Das has been send for cancelation after local verification. Please inform me in which area (locality) and in which gram panchayat your officials have done their investigation. As the certificate issued in 2011, and that time the family belongs to Maslandaur 1 Gram Panchayat.
10. I filed several applications under the provisions of the Right to Information Act before your department to obtain relatable information about the said Ms. Piu Das and Mr Partha Das that has enabled them to come before this

truth. In that case does respective department take any legal action against them?

The requisite service charges Rs 10/- in the form of IPO is being attached. IPO number 23F 194705

If you kindly grant my request and provide the information within statutorily stipulated time period, then I shall be highly obliged.
