2. On 24.05.2023, I received a response (*Annexure-2*) from one Mr. Rajib Sengupta, Assistant Secretary to the Government of West Bengal at the UDMAD whereby he refused to disclose the information based on the following flimsy and obfuscatory reasons:
 - 2.1. No specific question has been asked in the above-referred application.
 - 2.2. As per office record, no such report is available.
 - 2.3. This office is unable to provide such information
3. From the above, it is evident that the concerned State Public Information Officer ("*SPIO*") at the UDMAD is withholding the information and/or documents sought vide the above-referred application under my presumption of corruption and deliberate inaction in order to hide something criminal and sinister. Such acts on the part of the SPIO are tantamount to an offence as per the provisions of the RTI Act.
4. Therefore, I am compelled to file the instant First Appeal as per the provisions of Section 19(1) of the RTI Act on account of my grievances and dissatisfaction due to the presumed corruption and deliberate inaction on the part of the concerned SPIO.




