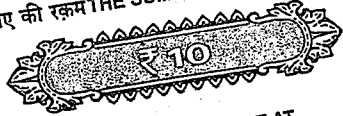

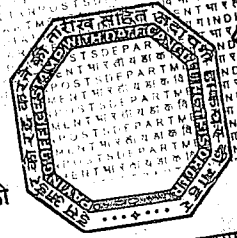

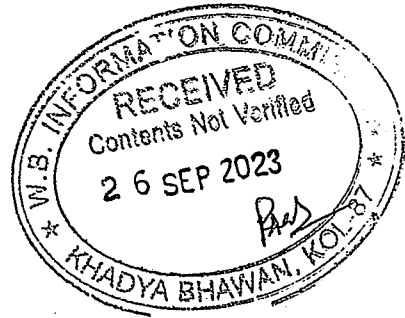

Subject: THIRD Appeal under RTI Act 2005 for delay in furnishing copy of letter dated 8th January 2023 as requested for vide my Application dated 15th Feb. 2023 under RTI Act 2005 and multiple defaults in dealing with the case, at various levels of the office of the Supdt. of Police, Sundarban Police District and PS Mathurapur.

Sir,

May I beg to submit this THIRD APPEAL with a request for appropriate action as required under the provision of RTI Act 2005 and also furnishing complete information as requested for in my RTI Application dated 15th February 2023 (photocopy enclosed) followed by Appeal dated 22nd Aug 2023 (photocopy enclosed)?

2. I am enclosing an Indian Postal Order for Rs 10/ [535278 dated 3 / 4 / 2023.

3. That my junior brother Asit Baran Mandal ex-employee of Calcutta High Court made allegation against me vide his letter dated 8th Jan. 2023 addressed to PS Mathurapur under Sundarban Police District that his elder brother Jyotirmoy Mandal (myself) has closed the ingress and egress towards 1st floor by grill fencing causing hindrance to 1st floor residents [GDE 422 dated 8th Jan 2023 at 11.15 hour]. Authority – Addl SP (HQ) Sundarban Police District's Memo No. 193 dated 24th April 2023 in reply to my RTI Application dated 15th Feb 2023.

3.1. That Asit Baran Mandal's son Siddhartha Mandal, also an employee of Calcutta High Court made similar allegation on mobile on 7th January 2023 at 8.05 hour to PS Mathurapur [GDE 363]/ This was not followed by any written allegation. Authority – Addl SP (HQ) Sundarban Police District's Memo No. 193 dated 24th April 2023 in reply to my RTI Application dated 15th Feb 2023.

3.1.1. That whereas grill fencing was done at about 14 hour on 7th Jan. 2023, allegation was made at 8.05 hour on 7th Jan. 2023 by the said Siddhartha Mandal, misinformed by some close associates of theirs and also intoxicated with his High Court job, made allegation on telephone to PS Mathurapur about grill fencing by me (ref – para 3.1).

3.2. That allegation made by father and son (both are college drop-out and jealous of my rise in life, was false and frivolous and made with an intent to harass me a former civil servant (retired Director General from the office of the Comptroller and Auditor General of India).

3.3.1. Factual position is that my brother and his family members and domestic helps had been walking through veranda of my village house not only disturbing our privacy, but also jeopardizing our security, as some party workers had been using my veranda as thoroughfare to the stair- case of 1st floor.

3.3.2. In view of the above (3.3.1), I provided a separate grill door at about 14 hour on 7th Jan. 2023 for exclusive use by the residents of 1st floor. This facility was taken possession of by the informant Asit Baarn Mandal at about 18 hour of 7th Jan. 2023 after getting my Whatsapp posting. YET the said Asit Baran Mandal made written allegation against me at 11.15 hour on 8th Jan. 2023, in support of his son's false allegation (3.1.1).

4.1. That as my brother and his son became over-active and as they have been successfully pressurizing / influencing the Police Authorities at various levels misusing their High Court link so as to harass me further, I had to invoke the provision of RTI Act 2005 and made an application on 15th Feb 2023 addressed to the CIO of DG – West Bengal requesting to furnish a few information **including** furnishing **photocopy of letter dated 8th Jan 2023** written by Asit Baran Mandal to the OC Mathurapur, making allegation against me. This application was transferred to the SP – Sundarban Police District by the Inspector General (O) of the office of the DG, West Bengal vide memo No 78 dated 28th Feb 2023 (Photocopy enclose) with the following observation:

“The matter may please be taken as important and RTI urgent”.

4.2. Along with other things, I requested the Police authority to furnish a photocopy of written allegation dated 8th Jan. 2023 [Sl. No. 3 of my RTI Application.

- **INCOMPLETE REPLY DATED 24TH APRIL 2023 –(Photocopy enclosed) NOT FURNISHING THE COPY OF WRITTEN ALLEGATION.**

5. That whereas extract of the allegation was furnished by the Addl SP (HQ), Sundarban Police District vide his Memo No. 193 dated 24th April 2023 (Photocopy enclosed), copy of the written allegation by the informant was not furnished, rather **SUPPRESSED.@**

@ Because the allegation was false and frivolous and made with an intent to harass a senior citizen. And Police authority was pressurized by the High Court employee Siddhartha Mandal. This explains the fact of suppression. By that time two sub Inspectors submitted Enquiry Reports [GDE 390 and GDE 434 (photocopy enclosed)] supporting the allegation, that lacks integrity as the police officials obliged the High Court babu under pressure.

- **ADDL SP (HQ)'S REPLY DATED 12TH JUNE 2023 AGAIN SUPPRESSING THE LETTER DATED 8TH APRIL 2023.**

6. That Addl SP (HQ)'s office furnished the photocopies of Enquiry Reports of two Sub-Inspectors (/S Prolay Dhar and Anup Majumdar) that lacks integrity. **But the photocopy written allegation dated 8th Jan. 2023 was again SUPPRESSED.**

Delay in furnishing photocopy of 8th Jan. 2023 letter as on 12th June 2023 works out to [Feb 10 days + March 31 days – April 30 days + May 31 days + June 12 days) = 122 days. This attracts the provision of RTI Act 2005.

- **ADDL SP (HQ)'S REPLY DATED 30TH JUNE 2023. This time an **undated** letter was furnished DETACHING six-page enclosures. [Photocopy enclosed]**

7.1. That Addl SP (HQ) vide his Memo No. 348 dated 30th June 2023 furnished a copy of the UNDATED letter (not the letter dated 8th Jan. 2023 I requested for vide my RTI Application dated 15th Feb. 2023). It appears that allegation made vide undated letter differs from extract of allegation furnished by Addl SP (HQ) vide his Memo dated 24th April 2023 (photocopy enclosed). This fact suggests that letter dated 8th Jan. 2023 has been replaced by the undated letter furnished vide memo No. 348 dated 30th June 2023. This may be due to pressure from High Court Babu. This is a serious matter and needs investigation.

7. 2. MOST DSITURBING? That while furnishing the photocopy of undated letter of allegation, OC Mathurapur **detached** six-page enclosures, and Assl SP (HQ) did not verify this, and furnished the copy of the undated letter without enclosures. As enclosures are integral part of a letter of allegation, its detachment makes the information incomplete.

At this stage delay in furnishing complete information works out to 140 days [18th Feb 2023 to 30th June 2023.

7. 3. The matter was again taken up by me. Addl SP (HQ) after obtaining the copies of six-page enclosures, furnished the same vide his Memo No. 81 dated 10th Aug 2023. THE CAT CAME OUT OF THE BAG !!!!!

■ MOST MOST DSITURBING:

7. 4. All the six-page enclosures are impugned documents as disclosed below:

- a) Both OC Mathurapur PS and Circle Inspector Mandir Bazar certified a BLANK page (page five of the enclosure). I am unable to know what has been cooked up in this certified blank page. This may kindly be considered for taking note of this disturbing matter by the Ld State Information Commissioner. It is also surprising that this very blank page enclosure certified by Police officers and put up to the Addl SP. This escaped the notice of the Addl SP (HQ). So the document is impugned. **This explains the reasons for detachment.**
- b) Page 1 to 3 is a registered agreement in which I have been made a party and in which my signature has been forged benefiting my brother as the enjoyer of my village property by foul means. My brother has been hiding this impugned document. This explains why this enclosure was detached by the Police authorities at various level, may be under pressure from the High Court Babu. **This explains the reasons for detachment.**
- c) Page 4 has been projected as a letter written by me to the informant giving permission to install; water motor in my veranda and also install an over-head tank on the roof top of my house. I have not written any such letter to Asit Baran Mandal, nor did I sign any such document. This is an impugned document. **This explains the reasons for detachment.**
- d) Page six is 50% readable. However this document is also a forged one, and I am not a signatory to any such document. This is an impugned document. **This explains the reasons for detachment.**

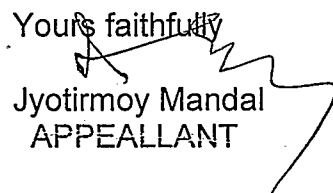
The Learned State Information Commissioner may like to note that I have not been able to get the following documents even after **inordinate delay of more than seven months** (15th Feb 2023 to 20th Sep 2023). This is an established case of violation of provision of RTI Act 2005. This may receive the attention of the Ld State Information Commissioner for appropriate action under various provisions of the RTI Act 2005.

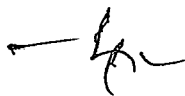

IMPORTANT STATEMENT OF FACT.

RTI Application dated 15th Feb. 2023 stands transferred to Supdt. of Police, Sundarban Police District from the o/o the SP, South 24 Parganas and also from the o/o the DG / West Bengal.

Important Pt. No. 3 of page 2 of RTI Application dated 15th Feb. 2023 – pertains to Informant Asit Baran Mandal's to copy of letter dated 8th Jan. 2023 making false allegation against me has been concealed from me for month after month; because the allegation was false and frivolous; and two Sub Inspectors of Police, Mathurapur PS cooked up their report on false allegation, and made FR against me under pressure from the High Court Babu. This explains the concealment of the said letter dated 8th Jan. 2023.

■ Facts suggest that there was a deal between OC Mathurapur PS and informant Asit Baran Mandal and 8th Jan. 2023 letter was replaced by important undated letter by the informant making allegation different from what was made in 8th Jan. letter.

■ Undated letter had six-page enclosures cooked up by the informant and certified by the OC Mathurapur PS to cover up encroachment of my village properties. Page 5 of the enclosure was blank by 100%. Yet Circle Inspector and OC certified it. This blank page may be hiding some mischief. This is why OC Mathurapur detached these six page enclosure and sent the undated letter to Addl SP (HQ), Sundarban Police District.

*** Letter dated 8th Jan 2023 was concealed from me, because allegation was false and on the basis of false allegation FR was finalized by the OC Mathurapur.

*** And six-page enclosures were concealed from me for months, because all the documents were fake and forged. I did not sign any of these documents.

[As a former civil servant I gained rich knowledge on the functioning of the Police administration, the first Pillar of the State. This knowledge is more valuable than the value of my property. I learnt Police can surrender to a small babu of a High Court.].

Sir,

I am a senior citizen aged 86 years and a former Civil Servant of 1968 Batch ~~retired as~~ Director General from the office of the Comptroller and Auditor General of India, I have been residing in New Delhi.

Every year, once or twice I visit my village house (a RETREAT for me) in Dakshin Mandal Para, under Uttar Laxminarayanpur Gram Panchayat, PS Mathurapur, in the district of South 24 Parganas in West Bengal for maintenance and up-keep of my house.

This year there was a special occasion – Centenary Celebration Function of Mathurapur High School (1923-2023). As an ex-student, I was present in the function as Chief Guest on 1st January 2023. After attending the function, I retired to my village house in the evening and stayed there for a week (1st January to 7th January 2023.)

Some unknown / suspicious persons were moving around my house. I immediately engaged a contractor to fix security fencing around my varandah. This minor civil work was completed on 7th January 2023 by 2 PM.

To my utter surprise, a Police Officer from Mathurapur Police Station suddenly visited my house around 4 PM on 7th January 2023 and asked me to stop all kind of civil work, **and that too without any Court's order**. When asked, the Police officer said, **"Sir, we are under pressure from the top, and we are helpless. You please stop all kind of civil work"**.

Repeated Police Presence On 8th January 2023 another Police Officer, along with my nephew SIDDHARTHA MANDAL, (son of my brother ASIT BARAN MANDAL) who is an employee of Kolkata High Court (Asst Registrar) and **who developed unduly close proximity with the Police at various levels by misusing his official position over the years**, visited my village house around 12 noon. The Police Officer demanded the key of my house from the caretaker of my house (SUDIPTA

While preferring this FIRST APPEAL may I submit that I requested for a **certified photocopy of written allegation** made against me by my brother Asit Baran Mandal vide his letter dated 8th Jan. 2023 to PS Mathurapur (GDE 422 dated 8th Jan. 2023), vide Sl. No (3) of my **RTI Application dated 15th Feb. 2023 [EXHIBIT -1]** addressed to the Chief Information Officer of the office of the Director General of Police, West Bengal?

That on receipt of my RTI Application, the Inspector General of Police and State Police Information Officer forwarded my above mentioned RTI Application to the Supdt. of Police, Sundarban Police District for urgent action instructing as under: **[EXHIBIT -2]**

"The matter may please be taken as important and RTI urgent"
vide Memo No 76 (1) (1) ADM /RTI – 40 / 23 dated 28th Feb 2023.

The office of the Addl Supdt. of Police (HQ), Sundarban Police District furnished extract of allegation **(and NOT the copy of written allegation)** vide his Memo No 193 / RD / ADDL SUPDT. OF POLICE (HQ) /SPD / RTI dated 24th April 2023. So the information furnished was incomplete.

I made another RTI Application vide my letter dated 8th May 2023. In response to this, Office of the Addl. Supdt. of Police (HQ), Sundarban Police District furnished attested copy of a undated written allegation vide Addl Supdt of Police (HQ), Sundarban Police District's vide his Memo No 348 / RD / ADDL SUPDT OF POLICE / SPD / RTI dated 30th June 2023 **[EXHIBIT - 3]**. This time also the information furnished was incomplete due to following defaults.

Default – 1 The written allegation was undated.

Default – 2 Enclosures attached to the undated written allegation were detached in the office of the Dist Police Hq, and not furnished to me.

Default – 3 Enclosures are integral part of written allegation, in absence of which the information furnished was incomplete.

Default - 4 Content of the undated written allegation was different from what was included in GDE 363 and GDE 422 dated 7th and 8th Jan. 2023. Be pleased to read with Attachment – 1 below. **This is a serious matter as it amounts to manipulation.**

In any case, this time also the information furnished vide memo dated 30th June 2023 was not only incomplete but also manipulated at a lower level.

The matter was again taken up vide another RTI Application dated 28th July 2023. On this the detached enclosures (6 pages) were furnished vide your office Memo No 81 / Admn / RTI / SPD dated 10th August 2023. This time also the information furnished was incomplete due to following defaults:

Default – 1 Page 1 of the 6 page enclosures, is not legible by 20%.

Default – 2 Page 3 of the 6 page enclosures is not legible by 40 %.

Default – 3 Page 5 of the 6 page enclosures is BLANK (100%) [EXHIBIT -5], and yet Certified by the OC of Mathurapur PS, and attested by the Circle Inspector. In any case this is no information. One cannot rule out some foul play.

Default – 4 Page 6 of 6 page enclosures is not legible by more than 50%. [EXHIBIT – 6]

Default – 5 Page 6 [EXHIBIT – 6] has not been certified by the OC Mathurapur PS whereas he has certified remaining five pages. This is mysterious.

In any case the information furnished vide memo dated 10th August 2023 is no information due to the above mentioned defaults.

At this stage may I clarify that I did not enter into it any agreement on any matter with the informant Asit Baran Mandal in my life time. Nor did I permit him to occupy my terrace, nor for construction of rooms on the terrace of my house. There was no registered agreement for construction of rooms on my terrace. Yet he constructed rooms in my absence. So all the documents submitted along with undated written allegation to PS Mathurapur are fabricated and suffer from integrity by 100% as I did not make and sign any agreement / letter as produced by the informant. In any case, this would be handled by me in the Court of Law. This may find place in the record of your office. Be pleased to note that somebody has forged my signature to benefit the informant.

I am preferring this APPEAL UNDER RTI ACT 2005 for your kind consideration and arranging to furnish a certified copy of written allegation made by the informant on 8th Jan. 2023 at 11.15 hour [EXHIBIT -3] - GDE 422 that discloses that 'elder brother of the informant has closed the ingress and egress towards 1st floor causing hindrance'. This very information [certified copy of written allegation] has been **concealed from me for more than 187 days** [15th Feb. 2023 to date] despite my repeated request. The undated letter discloses allegations [EXHIBIT – 4] that are different from what has been furnished to me [EXHIBIT - 3] on 24th April 2023. This is a case of **willful manipulation** with a motive to harass me, a senior citizen aged 86 years plus (actual).

That Addl SP (HQ) of Sundarban Police District **detached the three enclosures** from the letter of allegation, and furnished the impugned letter **without the enclosures** vide his Memo No. 348 / RD / ADDL SP (HQ) / SPD / RTI dated 30th June 2023 in reply to my RTI Application dated 15th Feb. 2023. As enclosures are integral part of any letter of allegation, its detachment from the said letter makes the **information incomplete**. So as on 30th June 2023 I could not be fortunate to get complete information in 135 days (15th Feb. 2023 to 30th June 2023).. This may please be noted.

On this, I requested the Addl SP (HQ) of Sundarban Police District to please furnish certified copies of three enclosures to the impugned undated letter of allegation, vide my letter dated 24th July 2023. And Addl SP (HQ), Sundarban Police District furnished the three impugned enclosures vide his Memo No 81/ Admn / RTI / SPD dated 10th Aug. 2023. - iv) Page - 6: More than 80% of the document attested by the Circle Inspector, Mandir Bazar is not legible. HENCE INCOMPLETE. :

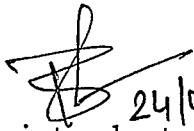

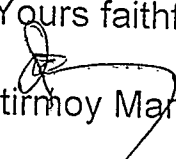

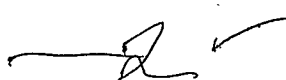
