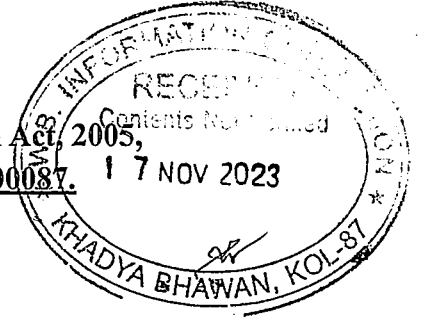

- V. For that, the appellant has complied with all the formalities including depositing requisite Application Fee with the application and as such, non-supply of informations and documents is bad, illegal, malafide and against the provisions of the Right to Information Act, 2005.
- VI. For that, natural justice has been denied to the appellant for not supplying the informations and documents by the First Appellate Authority as per the provision of the Right to Information Act, 2005.

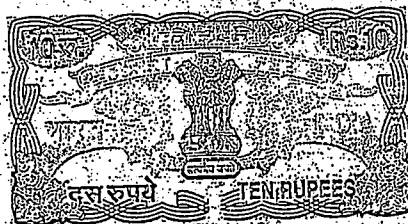
