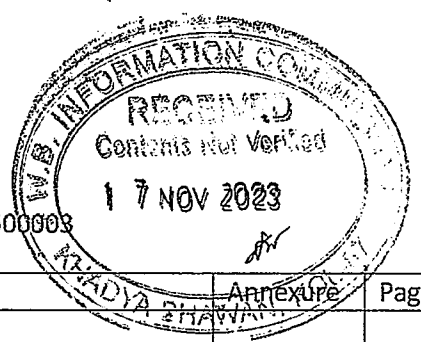

11. Brief facts of the case:

I have made an application under RTI Act, 2005 before SPIO of the Kumargram Development Block Office on 17/05/2023 but not received any reply/information. After that I have filed First Appeal to FAA(First Appellate Authority), Kumargram Block Development Office on 03/07/2023. The reply from FAA is unsatisfactory and misleading. He advice appellant to get information from outsource web portal which is against the Section 7(9) of RTI Act 2005 as section refer- the document should be provided in the form which is sought by applicant. Even Appellant asked through email to FAA whether all information including locatin(Longitude & Latitude) details are available and make ensure about the all information from the suggested web portal for general public/citizen. But FAA not given any clarification and answer at all. One of question (Q. no. 3) FAA sent printout where stamp, sign and location (Longitude & Latitude) are not there as the certified copy should be signed and stamped. Other information also incomplete which was provided by FAA. In total reply is not satisfactory & misleading particularly about the location (Longitude & Latitude) details.

12. Grounds for 2nd appeal and the relief sought(Specify):

That I did not get any response from SPIO & unsatisfactory response from FAA for my said application under RTI Act, 2005 . Point wise query and answer given by FAA which shows the reason of non satisfaction is under for clear understanding :

Q.2 Suggested to collect information from outsource portal. As the query was about the verified & approved list of beneficiary with Latitude & Longitude and construction stage as on date under SBM(G)-II. Is the section 7(9) not applicable if FAA suggest for information from outsource. Section- 7(9)---"An information shall ordinarily be provided in the form in which it is sought unless it would disproportionately divert the resources of the public authority or would be detrimental to the safety or preservation of the record in question ." FAA not ensures appellant regarding all details (including Lat. Long) is available in portal for general citizen as appellant asked by email to him.

Q.3 Mentioned in reply- copy is ready for supply on production of receipt Challan but the Longitude & Latitude is missing in document provided, as the Geotagging of IHHL is mandatory as per the SBM(G) guidelines (attached the copy of chapter from SBM(G) guidelines as a Annexure-XV . FAA should collect the information of Latitude & Longitude if it was done (Geotagg) by outsource and supply to applicant.

Q. 4 Payment status of construction agency as on date against each beneficiaries (all the beneficiaries) under

SBM(G)-II but FAA send the a sheet of details (without sign & stamp) which was the related details of Question no. 7 only , as the supplied details are not all beneficiaries details asked by appellant. And refer enclosure 02 (column-6) for the question no. 4 about the payment status of all agency against each beneficiary which is not proper & suitable answer reference. Applicant asked for all beneficiaries in SBM(G)-II not the only Question no. 7's details . Question no. 7's details is additional particular sought apart from Q. 4.

- Q.5 Mentioned in reply- Field Verification done by Gram Panchayat (G.P.). which was denied by Gram Panchayat & forwarded one RTI application to SPIO, Kumargram Block Development Office , on the base of they are not liable/responsible at all about the Identification, Field Verification & Geotag of IHHL assets. Find attached the copy of Original RTI application to SPIO, Turturi Khanda Gram Panchayat and their forwarded letter for ready reference.
- Q.7 Mixed beneficiary details (SBMG-I &II) asked by appellant. FAA sent the particular details without the location (Longitude & Latitude) of IHHL assets with comments-Not available. It is mandatory to do geotagg of the assets(find attached the SBM Operational guidelines chapter part of Geotagging for your ready reference as Annexure-XV) and MR 13(A) ,SBM(G) report which shows clearly about the Geotagging of assets(Annexure-XIV). What is the reason of commenting as NOT AVAILABLE. Is it stolen ? Is it destroyed ? Is hiding the facts or misleading ? Is not doing Geotagg , ignoring the Guidelines ? . It could be one of the reasons only which supports the comment- NOT AVAILABLE.

MONITORING & EVALUATION

DDWS, at the Central level, shall lead the Monitoring and Evaluation function in coordination with States and Districts. Under SBM(G) Phase II, effective monitoring of outcomes will be undertaken to ensure ODF Plus villages. The monitoring of outputs will also be done for administrative purposes such as the monitoring of expenditure and assets created. The monitoring framework should be able to identify the following:

1. Whether adequate IEC activities have been carried out for behaviour change
2. Whether the ODF status of villages has been achieved and is being sustained
3. Whether adequate solid waste management has been ensured
4. Whether adequate liquid waste management has been ensured
5. Whether the village is visually clean

The Monitoring and Evaluation activities shall be oriented towards monitoring attainment of programme results, effectively and efficiently. Monitoring will also include undertaking independent assessments, periodic reviews, field visits and thematic consultations to ascertain programme progress and effectiveness.

17.1 Output Outcome Monitoring Framework

SBM(G) Phase II will monitor progress on outputs and outcomes using an Output-Outcome Monitoring Framework. Outputs refer to the direct and measurable product of the program activities, often expressed in physical terms or unit. Outcomes are the collective results or qualitative improvements brought about in the delivery of these services. The suggested output outcome monitoring framework for SBM(G) is as under:-

17.2 Integrated Management Information System

SBM(G) Phase II will have a comprehensive online Integrated Management Information System (IMIS) that will provide regular and customized information to programme managers for decision support. SBM(G) Phase II shall generate integrated management information using data entered directly by State Governments as well as information to be received, from time to time, from the Department of Panchayati Raj and the Department of Rural Development. In the IMIS, all SBM(G) activities viz. construction of Individual and Community / Household Toilets, SLWM infrastructure, IEC, Capacity Building and administration related activities, including financial progress, will be exclusively captured in IMIS of SBM(G). The other Non-SBM(G) funded activities will be extracted from the funding programme's MIS and presented in IMIS for analysis.

The IMIS will have modules to capture plans at GP, Block and District level and provide information on status of planning and its implementation. All States/UTs are to submit their physical and financial progress reports of the implementation of the Programme, in real time through the online IMIS using user-ids and passwords provided to various implementing agencies of the States/UTs. It is recommended that all IMIS entries may be made at the block level by designated data entry operators, while only necessary approvals may be undertaken at the district levels.

All activity-wise physical and financial progress is to be updated in the SBM(G) IMIS in real time. All approvals for any data entry in the MIS to be made by the district must be completed within 5 days of entry at the block level, and all approvals for any data entry in the MIS to be made by the State must be completed within 10 days of entry at the district level.

17.3 Baseline Survey

The baseline for the programme on ODF Plus parameters must be determined to ensure the effective planning and implementation of the programme. States and UTs will undertake a baseline assessment in FY 2020-21 to determine initial coverage on key components under SBM(G) for all villages by August 31st, 2020, with the assistance from District/Block Coordinators/ Swachhagrahis. Under the baseline, all community and individual SLWM assets constructed as of 31st May 2020 from various Central/State/ Other schemes/Self-funded would be reported through the mobile app or any other appropriate mechanisms. Details for undertaking the baseline exercise shall be shared by DDWS.

17.4 Geotagging of assets

All assets constructed under the programme (including community SLWM assets and CSCs) are to be geotagged mandatorily with the help of the DDWS Mobile App. Geotagging will be done by a district authorized personnel (District or Block or cluster coordinators / Registered Swachhagrahis etc.) registered on the IMIS. In case of connectivity issues in the field, the authorized person may complete the geo-tagging offline when in the field on the DDWS mobile app and then sync the data to the IMIS on regaining connectivity.

No further approval of geotagging will be required once the authorized personnel has completed the geotagging. However, Districts are mandated to **perform 5% random checks** on geotagging each quarter to ensure the quality assurance of geotagging. In case of discrepancies observed during random checks, the details of random check reports be shared with sub-district authorities for necessary action.

Section 7

7. Disposal of request.—(1) Subject to the proviso to sub-section (2) of section 5 or the proviso to sub-section (3) of section 6, the Central Public Information Officer or State Public Information Officer, as the case may be, on receipt of a request under section 6 shall, as expeditiously as possible, and in any case within thirty days of the receipt of the request, either provide the information on payment of such fee as may be prescribed or reject the request for any of the reasons specified in sections 8 and 9:

Provided that where the information sought for concerns the life or liberty of a person, the same shall be provided within forty-eight hours of the receipt of the request.

(2) If the Central Public Information Officer or State Public Information Officer, as the case may be, fails to give decision on the request for information within the period specified under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall be deemed to have refused the request.

(3) Where a decision is taken to provide the information on payment of any further fee representing the cost of providing the information, the Central Public Information Officer or State Public Information Officer, as the case may be, shall send an intimation to the person making the request, giving—

(a) the details of further fees representing the cost of providing the information as determined by him, together with the calculations made to arrive at the amount in accordance with fee prescribed under sub-section (1), requesting him to deposit that fees, and the period intervening between the despatch of the said intimation and payment of fees shall be excluded for the purpose of calculating the period of thirty days referred to in that sub-section;

(b) information concerning his or her right with respect to review the decision as to the amount of fees charged or the form of access provided, including the particulars of the appellate authority, time limit, process and any other forms.

(4) Where access to the record or a part thereof is required to be provided under this Act and the person to whom access is to be provided is sensorily disabled, the Central Public Information Officer or State Public Information Officer, as the case may be, shall provide assistance to enable access to the information, including providing such assistance as may be appropriate for the inspection.

(5) Where access to information is to be provided in the printed or in any electronic format, the applicant shall, subject to the provisions of sub-section (6), pay such fee as may be prescribed: Provided that the fee prescribed under sub-section (1) of section 6 and sub-sections (1) and (5) of section 7 shall be reasonable and no such fee shall be charged from the persons who are of below poverty line as may be determined by the appropriate Government.

(6) Notwithstanding anything contained in sub-section (5), the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limits specified in sub-section (1).

(7) Before taking any decision under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall take into consideration the representation made by a third party under section 11.

(8) Where a request has been rejected under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall communicate to the person making the request,—

(i) the reasons for such rejection;

(ii) the period within which an appeal against such rejection may be preferred; and

(iii) the particulars of the appellate authority.

(9) An information shall ordinarily be provided in the form in which it is sought unless it would disproportionately divert the resources of the public authority or would be detrimental to the safety or preservation of the record in question.

I wish to inform you that I came to know the facts (Fake IHHL Id creation , approved and geotagged in habitation other than actual habitation of beneficiary to make confusion without the knowledge of beneficiary) through other source. And I was in search of the list and found that I am not the only sufferer / whose name used to get the benefit by others (Concern Official/Agency). There are so many beneficiaries there who don't know about their name is using to get the benefit by someone/agency with wrong details such as-

Wrong habitation mentioned and entered in data (how someone will look his/her name in other habitation i.e. Phaskhawa T.G.. if he/she belongs to Turturi Khanda even after getting the physical list from surveyor/IHHL Maker of his actual habitation)

How someone expect re-creation of new Id in his/her name by the Official/Agency without the knowledge of beneficiary inspite of knowing that his/her earlier application was rejected due to reason- TOILET EXIST / FAMILY NOT DIVIDED which was entered in portal by agency.

How someone expect from the Official/Agency about the rejection of IHHL application which was applied online earlier to get the amount in his/her Bank Account can be re-created of new ID (to favour agency), agency based new ID even after the rejection of application from the same applicant within a short period of time.

In context with other IHHL Id-1900480122- Personnel from agency (Unknown) taken beneficiary contribution Rs.1000/- and provided some part of material. After few days he taken back all the materials and ensure beneficiary that he will construct the IHHL after 1 week. After 1 week he told he has some problem and intimate you later. Even after the more than 20 months he never come back again and convey us the actual situation. She is also not the only sufferer as many beneficiaries are looking for the agency for the reason---

I have heard many beneficiaries given their contribution Rs.1000/- and never get call back or visit by the personnel/agency regarding the situation/making IHHL.

Some beneficiaries get construction material in part/full but not constructed by agency.

Some beneficiaries get materials and some construction (not complete) done by Agency but due to incomplete condition of IHHL, beneficiary not used the IHHL and go outside even after the more than 6 months.

Needy person is ignored and provide more than 1 IHHL to some family even the IHHL in record is more than family members. In same F.Y. or in consecutive year all family members getting IHHL benefit (listed not sure about benefitted) in some cases.
