Sub: Request for taking necessary action against the Treasury Officer, Hooghly Treasury 1, Chinsurah, Hooghly, West Bengal due to non-reply of information sought through RTI- regarding Sir,

With due respect I would like to draw your kind attention that my father Late Saradindu De died on 26th January 2023 in the morning. Accordingly I informed it to the Treasury Officer, Hooghly Treasury-1, West Bengal-712101 on 30th January 2023 to stop his pension. The Treasury Officer released pension to the bank account of deceased for the month of January 2023 but again the whole money was reverted to the treasury from the bank account. As only child and nominee of his pension, I claimed the due amount (upto 25 or 26 January 2023 which is applicable i.e. alive period) from the treasury office, Hooghly. However, the treasury office denied to release due pension stating that there is no nominee in the service book of deceased person. It is also to submit that the School where the deceased person was a teacher, submitted the nominee form along with pension book (copy enclosed).

I appealed to the Assistant Director & SPIO, Pension, PF &GI, Govt. of West Bengal under RTI Act 2005 (letter enclosed) on 9th May 2023, which he <u>forwarded</u> to the DM and SPIO, Hooghly with a copy to Addl. Treasury Officer (Pen), Hooghly Treasury 1 for providing suitable answer (letter enclosed) on 23.5.2023. However, no information was received within stipulated date. Again I appealed to the Appellate Officer and Joint Director of Treasuries & Accounts, Govt. of West Bengal on 24.July 2023 and he forwarded the application to Treasury Officer, Hooghly Treasury 1 for reply (copy enclosed) on 17.8.2023. But till today, no reply has been received. It is assumed that the Tresury Officer, Hooghly Treasury-1, West Bengal-712101 has ignored my queries under RTI.

So, I beg your kind self that necessary action may be taken as per RTI act 2005.

Sub: Release of due pension to Late Saradindu De from Treasury 1 (Pension), Chinsurah, Hooghly during his living period w.e.f. from 1st January 2023 to his death on 26th January 2023-regarding

Ref No. Your memo No. 31/ Treasury 1 dated 12.4.2023 by Treasury 1 (Pension), Chinsurah, Hooghly in response to our legal notice issued by Shri Gautam Saha, Advocate, Patna High Court on 31.3.2023

Sir,

With respect to above mentioned subject and reference, following points are submitted for consideration:

- i. That the nominee and only heir of deceased Saradindu De is the daughter (only child) of Saradindu De i.e. Sima De, Moynadanga, Chinsurah R.S., Hooghly, West Bengal 712102, which has been mentioned in the service book of deceased person submitted by the school to the treasury for release of pension (copy enclosed).
- ii. That the deceased Saradindu De has also nominated Sima De, his daughter in the pension account with Punjab National Bank, Chinsurah branch, Hooghly. The deceased person has opened joint account with his daughter Sima De in the same branch to support the nominee. (Copy enclosed)
- iii. That Panchayat Pradhan of his permanent residence, Kodalia 1, Chinsurah, Hooghly has also certified the name of nominee of the deceased person Saradindu De (copy enclosed).
- iv. That the amount of pension arrear is less than Rs 30000/-, which Treasury Officer can disburse on his own as per the Pension Rule 4.192 (3) of West Bengal Pension Act 2005.
- v. That Sima De has got married to Amitava Dey, Chotonilpur, Pirtala West, Sreepally, Burdwan, Purbi Barddhaman, West Bengal 713103 (copy enclosed).

On the basis of above mentioned facts, I may be informed about the following quarries;

a. Whether Treasury Officer can disburse due pension amounting less than Rs 30000/-on his own as per treasury rule 4.192 (3) where nominee has been mentioned in the

- service book submitted by the school authority, where the deceased person was a teacher, to the treasury for release of pension?
- b. Whether the rule for releasing pension of a deceased person during his live period is same as rules for releasing family pension/arrears/other benefits of a deceased person? (in this case the deceased person Saradindu De was alive upto 26th January morning, the pension is claimed by his heir/ nominee upto that period only).
- c. In this case Saradindu De has died on 26th January 2023 and the pension upto that period has not been released by Treasury1, Chinsurah, Hooghly stating that the nominee has to be authenticated by the Collector.
 - i. If pensioner dies on the last day of a month, pension is released to the account of deceased person and nominee of pension bank account can withdraw it. Whether, it is as per rule? If yes, why pension of deceased person cannot be released upto the date of death, if the pensioner dies in any day of a month?


