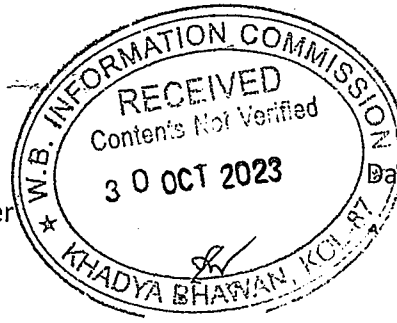

Sub: Application for water connection.

With Due respect I-wish to draw your kind attention to the following points:-

- Sir, I am a senior citizen of around 70 residing at: C C B Chhoto Jhilpar, PO & Vill : Bally Durgapur, Dist: Howrah, WB , PIN: 711205 under Durgapur-Abhoynagar Gram Panchayat-1.
- At the initial stage of allotment of connections I, together with a friend of mine, approached the Prodhan of the said Panchayat. But he directed us that connection would be allowed only after clearance of Panchayat tax. But as my said tax was disputed due to heavy increase (from Rs.60/- to Rs.1440/- i.e. 24 times p.a.) I could not apply for water connection.
- Recently on March 9, 2023 a surveyor or so came to my locality along with a local Panchayat member and found only my residence without any water connection under your project. He asked me the reason. I cited it. Then he assured that clearance of Panchayat tax is not any condition for getting a connection. He demanded my Electric Bill, Aadhar Card and Mobile No. all of which I provided. He noted the necessary data in a register and again assured me that I would get the connection shortly. But nothing happened. I am still where I was. I consider the entire story as unethical and embarrassing specially where it is concerned with the provision of drinking water for all.

I very earnestly request you to please look into the matter.
