



Kindly refer to the above.

In my requisition for information dated 12/09/2022, wherein I asked for some information. The letter was received by S.P.I.O. & Spl. L.A.O. on 12/09/2022. Reply of that letter was received by me on 12/08/2023.

It is, therefore, very clear that stipulated period of 30 (thirty) days is over and S.P.I.O. & Spl. L.A.O. made the reply after a long gap of eleven months, which is violative of my fundamental right and contravenes the law.

In response to my R.T.I. letter dated 12/09/2022, a reply was sent by S.P.I.O. & Spl. L.A.O. on 12/08/2023 in which all the information sought for was not provided clearly. I replied against the reply of S.P.I.O. & Spl. L.A.O. requesting him to inform me name, designation and address of First Appellate Authority vide India Post Consignment Number - EW204880858IN dated 17/08/2023. S.P.I.O. & Spl. L.A.O. received the letter on 18/08/2023. But, till date no communication has been made.

Since it is S.P.I.O. & Spl. L.A.O.'s responsibility to inform me of the appellate authority as per section 7(8)(iii) and he has not done so, it is his responsibility to forward it to the First Appellate Authority.

I, therefore, prefer first appeal and hope that S.P.I.O. & Spl. L.A.O. would kindly forward this application to proper jurisdiction of the first appellate authority and oblige thereby.

Grounds of Appeal : Unsatisfactory reply.
