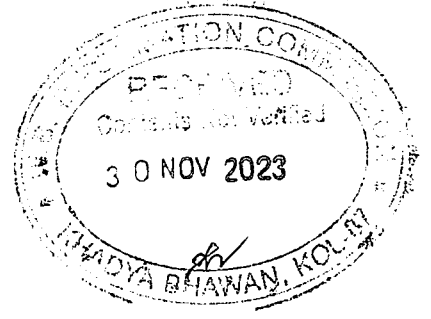

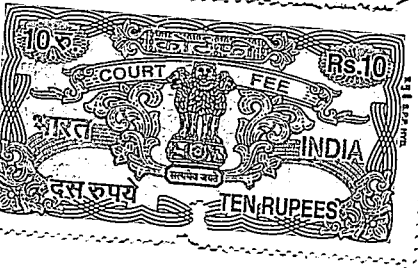
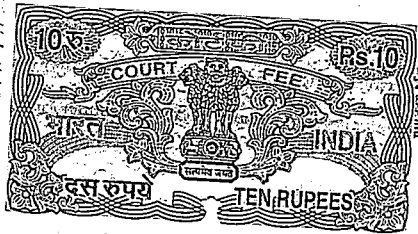

The appellant is ready and willing to pay the necessary costs for supplying information and is affixing Court fee of Rs.50/- for filing

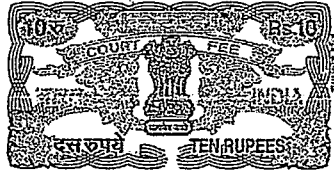
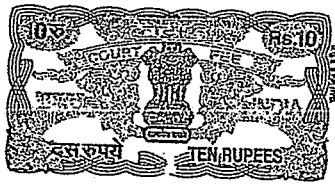
