Please be inform that I made an RTI application before the State public Information Officer, Sub Divisional Officer, Barasat Sub Division on dated: 08.08.2023 praying for some information of Priya Das, wife of Palash Das, daughter of Jadu Gopal Das which are as follows. regarding issuance of Schedule Caste certificate. The RTI application was received at Sub Divisional Office on dated : 10.08.2023

But the learned SPIO rejected the same on dated 17.08.2023, as per section 8(j) of the RTI act 2005 as mentioned by Sub Divisional Officer.

After that one 1<sup>st</sup> appeal of my RTI application was submitted to the 1<sup>st</sup> appellate authority on 06.09.2023, to the SPIO, District Magistrate which is received from his end on dated 08.09.2023. But till date I have not received any reply of my RTI query.

As per RTI rules now due to non receiving of RTI 1<sup>st</sup> appeal application from 1<sup>st</sup> appellate authority i.e District Magistrate within and more than stipulated time undersigned submitting 2<sup>nd</sup> appeal to the State Information Commission.

Being dissatisfied with and aggrieved of such decision I am highlighting some points which are as under, and submitting my 2<sup>nd</sup> RTI appeal to the State Information Commission, Govt of West Bengal.

1. I am the husband of the said Priya Das, therefore I am every right to know the records of my wife. marriage certificate is annexed herewith for your ready reference.
2. Said Priya Das has a dual citizenship both Bangladesh and India. Her father namely Jadugopal Das is the servant of Bangladesh govt. I crave leave to produce all such documents at the time of hearing of these appeal.
3. The Aadhaar card and the voter card have been cancelled by the govt of India. Copies of cancelled Aadhar and voter card are annexed herewith for your ready reference.
4. The ration card of the said Priya Das has also been cancelled. Copy of the ration card are annexed here for your ready reference.

5. All the identity including Aadhaar card , voter card , PAN , passport have been seized by the Gholia police station, under Barrackpore police commissionerate..

6. At the time of issuing Schedule caste certificate by the , learned SDO Barasat North 24 parganas , my said wife as a minor be then time reside with her parents under the sub division of Barrackpore,north 24 parganas.The learned SPIO has has erred in law but passed such order which is rather whimsicaly.I crave leave to produce all such documents at the time of hearing.

7. The learned SPIO has miserably failed to appreciate the safety, security, national integrity of our country as she is a Bangladeshi resident and her father is a servant of Bangladesh Govt.Therefore the order of such rejection must be setaside forthwith.

8. Regarding her date of birth is suspicious and doubtful the SPIO not enquire/verify the matter , has passed the order of such rejection rather whimsicalyTherefore order of rejection must be setaside.I crave leave to produce document of her date of birth at the time of hearing of this appeal.

In the afore said circumstances the SPIO Basarat SDO, has misutilize the section 8 (j) of the RTI 2005 national safety ,security and integrity is far higher value than a personal one.Therefore the order of rejection 16.08.2023 by the SPIO , Barasat North 24 parganas must be setaside forthwith if you have any query for further investigation you may call upon me when necessary by giving written communication.

Also 1<sup>st</sup> appellate authority District Magistrate , North 24 Parganas didnot reply my RTI query as per RTI rules.



D. Please inform me Give the name and address of those person who endorsed that SC certificate in favour of Priya Das respectively with and as per supplied document attached thereto?

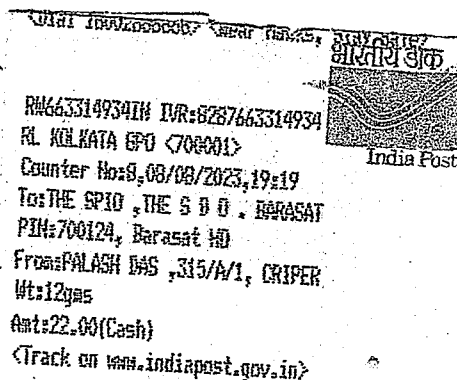





2. If not cancelled till date,
  - a. Please inform me on or at the time of application and issuing of SC certificate of Priya Das, where is/was her residential address has been given with as per submitted proof of document?
  - b. Please inform me on or at the time of application and issuing of said SC certificate of Priya Das, which birth proof is attached thereto, e.g birth certificate from hospital/ birth proof of any authority/ birth certificate from the school etc, with and as per her submitted proof of document?
  - c. Whether the father namely Jadu Gopal Das and / or mother namely Malina Das and/or elder brother namely Apu Das, of the said Priya Das has/have any SC certificate attached thereto as a proof of caste along with her SC application or not?
  - d. Please inform me give me the name and address of those person who endorsed that SC certificate in favour of Priya Das respectively and as per supplied document attached thereto?

But the learned SPIO rejected the same as per section 8(j) of the RTI act 2005 on dated 17.08.2023.SDO , Barasat , did not mentioned the name of 1<sup>st</sup> appeal authority.

Being dissatisfied with and aggrieved of Isuch decision I am highlighting some points which are as under

1. I am the husband of the said Priya Das , therefore I am every right to know the records of my wife.marriage certificate is annexed herewith for your ready reference.

2. Said Priya Das has a dual citizenship both Bangladesh and India. Her father namely Jadugopal Das is the servant of Bangladesh govt. I crave leave to produce all such documents at the time of hearing of these appeal.

3. The Aadhaar card and the voter card have been cancelled by the govt of India. Copies of cancelled Aadhar and voter card are annexed herewith for your ready reference.

4. The ration card of the said Priya Das has also been cancelled. Copy of the ration card are annexed here for your ready reference.

5. All the identity including Aadhaar card, voter card, PAN, passport have been seized by the Ghola police station, under Barrackpore police Commissionerate.,

6. At the time of issuing Schedule caste certificate by the, learned SDO Barasat North 24 parganas, my said wife as a minor be then time reside with her parents under the sub division of Barrackpore, north 24 parganas. The learned SPIO has erred in law but passed such order which is rather whimsicaly. I crave leave to produce all such documents at the time of hearing.

7. The learned SPIO has miserably failed to appreciate the safety, security, national integrity of our country as she is a Bangladeshi resident and her father is a servant of Bangladesh Govt. Therefore the order of such rejection must be set aside forthwith.

8. Regarding her date of birth is suspicious and doubtful the SPIO not enquire/verify the matter, has passed the order of such rejection rather whimsicaly. Therefore order of rejection must be set aside. I crave leave to produce document of her date of birth at the time of hearing of this appeal.

In the afore said circumstances the SPIO Barasat SDO, has misutilize the section 8 (j) of the RTI 2005 national safety, security and integrity is far higher value than a personal one. Therefore the order of rejection 16.08.2023 by the SPIO, Barasat North 24 parganas must be set aside forthwith if you have any query for further investigation you may call upon me when necessary by giving written communication. Therefore your honour may graciously be pleased to pass such order and /or give me such information as per my said RTI application dated: 08.08.2023 and/ or set aside the order of rejection dated- 16.08.2023 passed hurriedly by the SPIO, Barasat (Sadar) SDO, north 24 Parganas, and/or as your honour may think it proper.


