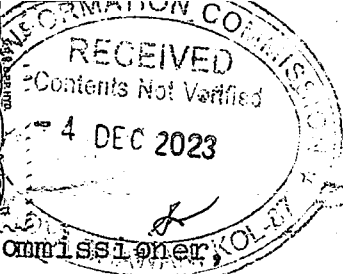
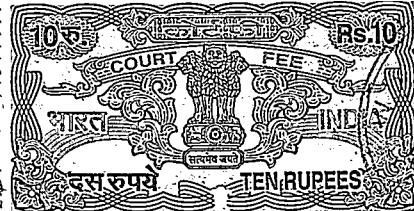

The State Assistant Information Officer as Administrator, Board of Administration Kalimpong Municipality P.O, P.S, Sub Division and District Kalimpong-734301, West Bengal has failed to response to my Application requesting for information under the Right to Information Act, 2005. That application was filed before the aforesaid State Information Officer on dated 31/07/2023, and on the strength of aforesaid R.T.I application 2005, I had filed a petition before the state Information Officer as District Magistrate Kalimpong, P.O, P.S, Sub Division and District Kalimpong- 734301 on Dated 31/08/2023.

Vide Memo Number 90/1(1)/RTI dated 07/09/2023 was sent by ld S.P.I.O ~~of~~ Office of the District Magistrate, P.O P.S, Sub Division and District Kalimpong - 734301 to the Chairman Kalimpong Municipality, P.O, P.S, S.D, District Kalimpong- 734301.

The requisite time for supply of Information (30days of application was filed before the State Information Officer and 35 days if it was filed before the State Assistant Information Commissioner) has already expired. That Public Information Officer has neither supply the Information nor denied the same, hence this Appeal.
