

Sir/Madam,

I am writing this appeal to you under the provisions of the Right to Information (RTI) Act, 2005, under section 19(1), in reference to my initial RTI application dated 13/06/2023 addressed to the Chief Medical Officer of Health (CMOH), Purba Medinipur, as the Public Information Officer. I am appealing against the response from CMOH, Purba Medinipur, Memo no- CMOH/pbmd/RTI/4403 dated 26.07.23 to my RTI application dated 13.06.23. I had applied for the post of sl. no. 9 (RMNCH+A) as a counsellor under the notification Memo No. CMOH/pbmd/6775 dated 24.11.22 published through district online portal under the head of District Health and Family Welfare Samiti, Purba Medinipur. It appeared in the final panel that I have been placed at the 4th position. However, I am not clear about the distribution of my marks as it is not reflected there.

Therefore, I had requested the competent authority for the same through my RTI application dated 13.06.2023. I had also asked to provide me with a copy of my written test. But such authority has denied my request without stating any valid grounds for doing so. The response they have sent is not pertinent at all and very ambiguous. I would like to bring to your kind attention that timely and transparent dissemination of information is essential under the RTI Act. I believe that I have a right to know how my performance was evaluated and how the marks were awarded. I also believe that providing me with a copy of my written test is not exempted under any provision of the RTI Act.

In my initial RTI application dated 13/06/2023, I sought information related to my application for the post of Counsellor SI. No. 9; (RMNCH+A), as advertised in the notification memo No. CMOH/pbmd/6775 dated 24/11/2022. The information sought included:

- 1. Particulars regarding the marks obtained by me in three categories, namely academic qualifications, post qualification and post-qualification experience, and written examination.
- 2. A copy of the written test for the aforementioned examination.

However, on 28/7/2023, I received a response to my RTI application memo no. CMOH/PBMD/RTI/4403 dated 26/07/2023 that I find to be misleading and not in accordance with the details requested in my original query. The response provided by the concerned authority has


failed to address my primary concerns, thus leading me to believe that the information has been intentionally withheld or misrepresented.

Specifically, the response provided to query no. 1 has been deemed misleading and lacking in transparency, as it does not accurately reflect the information I had requested. Similarly, while query no. 2 has not been outright denied, the response does not provide any explanation for the refusal to supply the requested answer sheet, as mandated by the provisions of the RTI Act.

I kindly request that you review the response provided by the Public Information Officer in light of the discrepancies and inconsistencies mentioned above. I seek your intervention in ensuring that the principles of transparency, accountability, and adherence to the RTI Act are upheld.

Therefore, I humbly appeal to your esteemed office to:

- 1. Reevaluate the response provided by the Public Information Officer to my initial RTI
- 2. Please make sure to provide me with accurate and complete information in response to query number 1. This should cover all three categories I requested, along with the marks division for all the empaneled candidates and an explanation of how the grand total was calculated. Please provide these details in a transparent manner, as it appears that there might be an intentional attempt to hide something by the Public Information Officer (PIO).
- 3. Also ensure to get me the written test paper of me and along with the first 4 empaneled
- 4. Provide clear and substantiated reasons, in accordance with the RTI Act, for the decision not to provide the answer sheet for the written test as requested in query no. 2.
- 5. Ensuring the provision of accurate and complete information in response to query no. 1. This must encompass the marks awarded across all three categories, accompanied by a clear breakdown of marks for each of the empaneled candidates. Furthermore, I request a detailed explanation of the methodology employed for calculating the grand total of marks.
- 6. Facilitating the procurement of not only my written test paper but also the written test
- 7. Review and Reevaluation: Kindly review the responses provided by the Public Information Officer in both instances. Ensure that the responses are in line with the principles of transparency and accuracy as mandated by the RTI Act. Address any misleading information and discrepancies in the responses.
- 8. Comprehensive Information: Ensure that accurate and complete information is provided in response to query no. 1 of the initial RTI application. This information should encompass the marks division for all three categories requested (academic qualifications, post-qualification experience, and written examination). Additionally, please provide details of how the grand total was calculated for all empaneled candidates.



- 9. Provision of Written Test Papers: Please provide me with a copy of my written test paper along with the written test papers of the first four empaneled candidates. This information is crucial for transparency and accountability in the recruitment process.
- 10. Clear and Substantiated Reasons: Require the PIO to provide clear and substantiated reasons, in accordance with the RTI Act, for the decision not to provide the answer sheet for the written test as requested in query no. 2 of the initial RTI application.

I trust in the transparency and fairness of the RTI Act and the appellate process. I am confident that your esteemed office will take necessary actions to address my concerns and uphold the principles of the RTI Act.



I am writing this appeal to you under the provisions of the Right to Information (RTI) Act, 2005, under section 19(1), in reference to my initial RTI application dated 13/06/2023 addressed to the Chief Medical Officer of Health (CMOH), Purba Medinipur, as the Public Information Officer. I am appealing against the response from CMOH, Purba Medinipur, Memo no- CMOH/pbmd/RTI/4403 dated 26.07.23 to my RTI application dated 13.06.23. I had applied for the post of sl. no. 9 (RMNCH+A) as a counsellor under the notification Memo No. CMOH/pbmd/6775 dated 24.11.22 published through district online portal under the head of District Health and Family Welfare Samiti, Purba Medinipur. It appeared in the final panel that I have been placed at the 4th position. However, I am not clear about the distribution of my marks as it is not reflected there.

Therefore, I had requested the competent authority for the same through my RTI application dated 13.06.2023. I had also asked to provide me with a copy of my written test. But such authority has denied my request without stating any valid grounds for doing so. The response they have sent is not pertinent at all and very ambiguous. I would like to bring to your kind attention that timely and transparent dissemination of information is essential under the RTI Act. I believe that I have a right to know how my performance was evaluated and how the marks were awarded. I also believe that providing me with a copy of my written test is not exempted under any provision of the RTI Act.

In my initial RTI application dated 13/06/2023, I sought information related to my application for the post of Counsellor SI. No. 9; (RMNCH+A), as advertised in the notification memo No. CMOH/pbmd/6775 dated 24/11/2022. The information sought included:

- 1. Particulars regarding the marks obtained by me in three categories, namely academic qualifications, post qualification and post-qualification experience, and written examination.
- 2. A copy of the written test for the aforementioned examination

However, on 28/7/2023, I received a response to my RTI application memo no. CMOH/PBMD/RTI/4403 dated 26/07/2023 that I find to be misleading and not in accordance with the details requested in my original query. The response provided by the concerned authority has failed to address my primary concerns, thus leading me to believe that the information has been intentionally withheld or misrepresented.

Specifically, the response provided to query no. 1 has been deemed misleading and lacking in transparency, as it does not accurately reflect the information I had requested. Similarly, while query no. 2 has not been outright denied, the response does not provide any explanation for the refusal to supply the requested answer sheet, as mandated by the provisions of the RTI Act.

I kindly request that you review the response provided by the Public Information Officer in light of the discrepancies and inconsistencies mentioned above. I seek your intervention in ensuring that the principles of transparency, accountability, and adherence to the RTI Act are upheld.

Therefore, I humbly appeal to your esteemed office to:


- 1. Reevaluate the response provided by the Public Information Officer to my initial RTI application.
- 2. Please make sure to provide me with accurate and complete information in response to query number 1. This should cover all three categories I requested, along with the marks division for all the empaneled candidates and an explanation of how the grand total was calculated. Please provide these details in a transparent manner, as it appears that there might be an intentional attempt to hide something by the Public Information Officer (PIO).
- 3. Also ensure to get me the written test paper of me and along with the first 4 empanelled candidates' written test papers.
- 4. Provide clear and substantiated reasons, in accordance with the RTI Act, for the decision not to provide the answer sheet for the written test as requested in query no. 2.
- 5. Ensuring the provision of accurate and complete information in response to query no. 1. This must encompass the marks awarded across all three categories, accompanied by a clear breakdown of marks for each of the empanelled candidates. Furthermore, I request a detailed explanation of the methodology employed for calculating the grand total of marks.
- 6. Facilitating the procurement of not only my written test paper but also the written test papers of the top four empanelled candidates.

- 7. Review and Reevaluation: Kindly review the responses provided by the Public Information Officer in both instances. Ensure that the responses are in line with the principles of transparency and accuracy as mandated by the RTI Act. Address any misleading information and discrepancies in the responses.
- 8. Comprehensive Information: Ensure that accurate and complete information is provided in response to query no. 1 of the initial RTI application. This information should encompass the marks division for all three categories requested (academic qualifications, post-qualification experience, and written examination). Additionally, please provide details of how the grand total was calculated for all empaneled candidates.
- 9. Provision of Written Test Papers: Please provide me with a copy of my written test paper along with the written test papers of the first four empaneled candidates. This information is crucial for transparency and accountability in the recruitment process.
- 10. Clear and Substantiated Reasons: Require the PIO to provide clear and substantiated reasons, in accordance with the RTI Act, for the decision not to provide the answer sheet for the written test as requested in query no. 2 of the initial RTI application.

I trust in the transparency and fairness of the RTI Act and the appellate process. I am confident that your esteemed office will take necessary actions to address my concerns and uphold the principles of the RTI Act.

Thank you for your attention to this matter.




