



Sir,

With reference to my RTI application dated 02/05/2023 requesting information regarding the inquiry report conducted by SDO kurseong Shri. Abhishek Chaurasia on the issue of dual citizenship of Shri Anit Thapa between 2019-2020 I have not received any reply from this office.

I also received a copy of the letter from the SDO Kurseong dated 26/05/2023 stating that the inquiry report mentioned above has been forwarded to the office of DM Darjeeling.

As the inquiry was conducted under the instructions of the Ministry of Home Affairs for public interest I see no reason why a public document like this is being concealed unless the reason is something else.

The law mandates that the reply needs to be furnished within 30 days but more than 3 months has elapsed and I have not heard anything from the PIO who for some reason has withheld this public document which needs to be in the public domain. In response to the inaction of PIO I am forced to move the 1st appellate authority as provided in RTI Act and further I also intend to move the Central Information Commission if the 1st appellate officer does not furnish the information sought within 30 days of the receipt of this appeal.
