Respected madam,

We, the undersigned teachers of Jagriti Hindi Vidyamandir, High School, Liluah, Howrah are writing to bring to your attention several pressing concerns regarding the current administrative situation and conditions at our school that require immediate attention and resolution.

Lack of Financial Transparency:

We have made repeated attempts to acquire information concerning the utilization of SSA and other government funds from our Teacher-in-Charge named Mrs. Anshu Kumari Pandey through RTI. Regrettably, the responses we received from her (TIC) were evasive and failed to provide the necessary clarity. Requests made under the RTI Act 2005 regarding records and accounts related to these funds have not been adequately addressed. Despite numerous appeals, no utilisation certificate has been furnished, leading to a severe lack of transparency in our school's financial records.

Deteriorating Classroom Conditions:

The physical state of our classrooms is alarming. The absence of benches, doors, and broken window panes has made it arduous for students to focus on their studies, especially during adverse weather conditions. The lack of maintenance and repairs over several years has worsened the situation, impacting the students' learning environment significantly.

Security and Staff Attendance Issues:

The absence of Mr. Dhiren Das, a Group D staff member, before the Durga Puja Vacation in 2023 has resulted in security issues. Attempts to seek information regarding Mr. Das's attendance through RTI inquiries have been met with inadequate responses from our Teacher-in-Charge, Mrs. Anshu Kumari Pandey. The lack of Mr. Das's presence has allowed disturbances by local individuals, posing a threat to the security and orderly functioning of the school.

Administrative Shortcomings:

Under the current leadership of our Teacher-in-Charge, there's been a distinct absence of regular staff and guardian meetings, fostering an atmosphere where decisions seem to be made on her whims rather than through collective input and dialogue.

Isolation and Discriminatory Behavior:

During crucial examination periods, a notable number of teachers have distanced themselves from their duties and collective staffroom activities, creating a sense of isolation and division among staff members. This behavior has inadvertently fostered a discriminatory attitude among students, hindering the creation of a collaborative and supportive educational environment.

The aforementioned issues have not only affected academic performance but have also instilled feelings of alienation and distress among students. It is imperative to address these concerns promptly to restore an environment based on equality, respect, and inclusivity within our educational community.

We humbly request an urgent meeting or discussion with the relevant authorities to further elaborate on these concerns and collaboratively devise sustainable solutions that uphold the values of fairness and respect within our school.

Information sought:

1. In accordance with the Right to Information Act, we request you to kindly provide the actual strength of students for the years 2022 and 2023 at our school.
2. Pursuant to the Right to Information Act, we request you to kindly provide the attendance records of Mr. Dhiren Das, a Group-D staff member who joined on 25.04.2001, from the year 2014 to the present date.
3. Under the provisions of the Right to Information Act, please provide the leave details of Ms. Punam Shaw, an Assistant Teacher of Physical Education who joined on 20.12.2019, for the period of February 2022 to March 2022.

We are making this request to obtain information that is essential for understanding the governance structure of our school and ensuring transparency in its administration. We are paying the fees for this application by way of Indian Postal Order as being no. 11F 931609 of Rs. 10/- and we are undertaking to you to pay excess fees if required for your office purpose. Kindly provide the information in the format which is convenient and permissible under the Act, such as hard copies or digital copies.

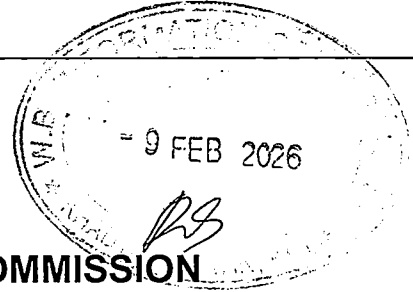

(b) If the SPIO attending the hearing before the Commission does not happen to be the concerned SPIO, it shall still be his/her responsibility to ensure that the SPIO(s) concerned must attend **with complete file concerning the RTI request**, the hearing along with him.

4. All the parties may submit their written submission, if any, to the Commission at least 7 days before the date of hearing. A copy of the same shall be served upon opposite party. 5. SPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.

6. The authorised representative or the officer of the public authority and the appellant/complainant/third party is advised to carry a "proof of identity" **along with the authorization letter.**

7. Take notice that in default of your appearance on the time and date mentioned aforesaid, the case shall be heard and decided in your absence **and that there will be no adjournment and review.**

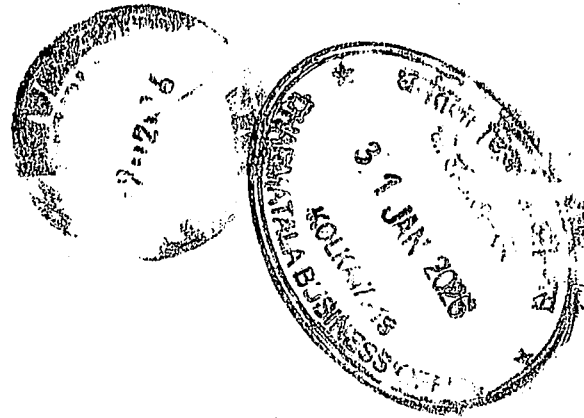
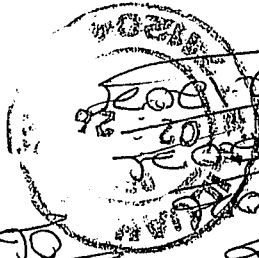
