4. Ground for compliant:-

I applied under RTI Act.2005 to PIO of University of Kalyani on 05.02.2024 (Copy enclosed). But unfortunately I have not got the answer yet. Then I made First Appeal on 15.03.2024 (Copy enclosed)but unfortunately no information was given to me by First appellate authority till date. So despite being a citizen of democratic India, my fair rights have been neglected, which in our case is a complete violation of the RTI Act 2005.

Therefore the request to Sir in this regard is as per section 18(1) of Right to Information Act. order to make available urgent information to the PIO by initiating an expeditious hearing in this matter.

Also please order the PIO to pay penalty under various provisions of the Act for violation of RTI Act 2005. I hope that you consider this complaint letter as important and take immediate action so that I get correct information at the earliest.

I was waiting for a fair trial from you.

5. Prayers:-

a) Enquiry:-

Sir, exercising power's of civil court vested in you U/S 18, please enquiry in to this complaint.

b) Direction to PIO:-

Sir, please direct PIO comply with requirements of section 7(1) and give proper reply to RTI application.

c) Penalty:-

Sir, please impose penalty as per section 20(1) to the PIO "without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified U/S of RTI Act, 2005".

d) Disciplinary action:-

Sir, please recommend disciplinary action against PIO as per section 20(2), who has "without reasonable cause and persistently" denied my request for information.

e) The SPIO be penalized and strict disciplinary action be taken against him under service conduct rules and discipline and appeal rules 1968 & 1969.




