Whereas, in respect of demand notice submitted by Sudip Rakshit, Nirman Sahayak, Kholapota Gram Panchayat dated 18.07.22, a hearing was scheduled on 25.08.22 in pursuance of the letter vide Memo no 963/DPRDO dated 12/08/2022 at the office chamber of the undersigned

Whereas, the Block Development Officer, Basirhat- II Development Block along with the Assistant Accountant M.D.M were present at the time of hearing.

Whereas, Sri Sudip Rakshit, Nirman Sahayak, Kholapota Gram Panchayat was also present at the time of hearing.

Whereas, attendance sheet of the said hearing is kept for record.

Whereas, Sri Rakshit during hearing expressed his views as mentioned in the Demand Notice dated 18.07.22 which was taken for record. Besides, he also submitted a self explicit hand written letter dated 25/08/2022, wherein he has expressed his willingness to consider his joining to the said post at the Gram Panchayat from 01/09/2022 which was taken for record. In this regard, during his submission he mentioned that earlier he had submitted a prayer for his resignation from the said post dated 24.07.20 and also applied to withdraw the said prayer of resignation through submitting an application directly to District Magistrate on 24.09.20 and the same was docketed at the office of the District Magistrate vide no 2426 dated 25.09.2020 ( copy was kept with record).

Whereas, the Block Development Officer of the Basirhat-II Block Development Block was also heard and raised the matter regarding the unauthorized absence of the incumbent which tantamount to more than two sixty two days covering both the Pandemic Covid tenure inter alia the West Bengal State Legislative Assembly Election, 2021 without having any satisfactory valid grounds and submitted several show causes notices which were issued against him time to time and on being dissatisfied the proposal of a departmental proceeding against him on ground of insubordination, obstinacy was submitted before the authority vide Memo No. 1100 dated 27.07.22 and another proposal to frame charges on ground of unauthorised absence and gross violation of election order was also submitted before the authority vide Memo No 605 dated 23.03.2021 and all such documents were kept as record and it is understood that all such recommendations are pending for disposal against the incumbent concerned.

Whereas, considering the facts vis-a-vis the representations of the B.D.O, Basirhat-II Dev. Block and Sri Sudip Rakshit, N.S., Kholapota Gram Panchayat, being the Additional District Magistrate(Panchayat), North 24 Parganas, and the present service complicity of Sri Rakshit, I am of the opinion that Sri Rakshit be considered to join at his present place of posting on & from 01/09/2022 or the issuance of the order, whichever is earlier. pending disposal of the recommendation of the Departmental Proceedings against him submitted by the BDO, Basirhat II and the Salary and other Service related issues, such as assessment of leave etc. P-will be considered by the Block Development Officer Basirhat II Dev. Block as per existing norms as laid down in the Gram Panchayat Administration Rule, 2004 as amended.

This order is issued upon obtaining approval from the Executive Officer, North 24 Pargans Zilla Parishad.
