I, Amitava Roy, S/O Late Purnendu Roy, residing at 172/C, Ramkrishna Road, P.O. New Barrack pore, Kolkata – 700 131, hereby beg to pray before you to lodge a complaint U/S 18 of R.T.I. Act 2005 being denied information in exercise of my right under R.T.I. Act despite providing for necessary fees and applying in specified format.

Sir, I am an assistant teacher of Dakshineswar High School (H.S.), 7, A.C. Banerjee Road, P.O. Ariadaha, Kolkata 700 057. I had by R.T.I. application dated: 01.02.2024 prayed for following information:

1. A true copy of the resolution by which the SMC of the school was constituted;
2. The names of all the members of the committee and their respective posts;
3. A true copy of the resolution by which the Staff Council Secretary was ratified;
4. A true copy of the resolution by which the Academic Council was ratified;

from School Education Department from Public authority D.I. (S.E.) Barrackpore through S.P.I.O of D.I. (S.E.) Barrackpore under R.T.I. Act 2005, providing court fees as needed by application dated 01.02.2024, sent on 01.02.2024 and received on 02.02.2024, which remaining unanswered despite reminder dated 16.03.2024, sent on 16.03.2024 and received on 18.03.2024.

Sir, I was forced to file first appeal before First Appellate Authority dated: 12.03.2024, sent on 12.03.2024 and received on 14.03.2024 which through e-mail was answered, Sir, therefrom I found that the First Appellate Authority had transferred the appeal to the office of D.I (S.E.) Barrackpore, as the matter of appeal was related to his office as public authority.

Sir, in the meantime on 27.03.2024 I received an e-mail from D.I. (S.E.) Barrackpore stating that he had transferred my application dated: 01.02.2024 to the Teacher – in – Charge U/S 6(3) of R.T.I. Act 2005 wherefrom it appears to my little understanding that D.I. (S.E.) Barrackpore was acting on my first R.T.I. application and not as delegatee in respect of appeal transferred by order of the First Appellate Authority dated 28.03.2024.

Sir, I received on 20.04.2024 memo no: 23/RTI/BKP/2024 dated 18.04.2024 from D.I. (S.E.) Barrackpore regarding the R.T.I. reply received by him from the Teacher – in – Charge wherein the Teacher – in – Charge just intimated two answers, namely,


1. Query no. 1 i.e. by which resolution the SMC of the school was constituted;
2. Query no. 2 i.e. the names of all the members of the SMC and their respective posts;

But the Teacher – in – Charge did not give all the names of all the members of the SMC and also refused copy of the resolution dated 15.09.2023 promising furnishing upon payment of requisite fees. However, by letter dated 05.06.2024 I had furnished to the Teacher – in – Charge which was received on 06.06.2024 but no information was furnished.

Sir, now I complain to you against the undisposed appeal that was transferred by the First Appellate Authority to the D.I. (S.E.), Barrackpore and non – compliance of D.I. (S.E.) Barrackpore transferred application to the Teacher – in – Charge, seeking information under R.T.I. Act 2005 despite payment of fees by me to the Teacher – in – Charge later.

Sir, so kindly direct the First Appellate Authority, D.I. (S.E.) Barrackpore and S.P.I.O. of the school i.e. Teacher – in – Charge of the Dakshineswar High School to furnish me the resolutions regarding SMC constitution of the school, ratification of the secretary of the Staff council, ratification of the Academic council and list of all the names of the members of the SMC and their respective posts as I have already paid fees.




