Sir / Ma'am,

This is the appeal against the decision of State Public Information Officer (SPIO), Office of the Registrar of Firms, Societies and Non-Trading Corporations, West Bengal, DJ-10, 2nd Floor, WBIIDC Head Office Building, Sector II, Bidhannagar, Kolkata-700091, who rejected my/our RTI application dated 12/12/2024, Memo No. 673-RFS. Stating reason under Section-6(1) of the RTI Act, 2005. "A person who desires to obtain any information under this act shall make a request". So only one person is requested to apply for the information and not more there than one at a time. And asked to apply again. (attached copy)

Because I have come across the CIC judgement where it is clearly stated that more than one person can apply to obtain the information through RTI and such application cannot be rejected (File No.CIC/LS/A/2013/000706 & Decision No. CIC/SG/A/2010/001429/8585).


I humbly request you to review the SPIO's decision and direct them to provide the information requested in my/our RTI application dated 26/12/2024, considering the above points and the spirit of the RTI Act, 2005.

I along with 37 flat owners approached to the Registrar of Societies the written complaint against the present governing-body of our society. Who are going in illegal manner, fraudulent, throwing threatening body languages, misusing the signatures of the flat-owners as per their choices, manipulations of our money, forcefully imposing their unwanted illegal decisions on the flat-owners etc. against the "Memorandum of Association" since last six (6) years.

Group of ladies of our society also filed a written complaint against them. But the Registrar has not taken any proper action irrespective of that the Registrar has not provided us the copy of reply of the opposite party since August, 2024, even after verbal repeated written request.

Hope you will do the needful. I will be highly obliged.



- They have started hiring/renting the society office on a commercial basis. (Attached Annexure2)
- The Governing Body Members behave in a manner that they are the owner of all the flat and common areas and talks in a very dominating way.
- They are encroaching the common place for their personal entertainment.
- They quietly made a deal with the "Bharti Airtel" last year for installation of FATF Box without passing any resolution in the general meeting, without putting this in the knowledge of any flat owners. It was strictly objected by Blocks and contacted the "Bharti Airtel" stating them the facts. To which on the "Bharti Airtel" confirm that the Secretary has got the NOC from all the flat owners for this which was totally incorrect. Later when the Airtel company came to know the real fact they themselves cancelled the deal with the Secretary.
- We would like to highlight their major fraudulent activeity that is in all meeting in their tenure (03 AGM & 01 Special General Meeting) thay take the signatures of all the members before the commencement of the meeting as a attendandance and later the same signatures they converted into the permission granted for of passing their agendas of the meeting.

We have demanded few information from time to time, but they have never provided us till today. That is----- (Attached Annexure1)

1. Why the election is not held every year as none of their Notice of AGM contains this Agenda.
2. Current Status of registration along with registration number.
3. Currently held Bank account details and balance status along with copies of any Investments made till current date.
4. Latest purchase/sale details and any money is taken/received from buyers/sellers in the last 2 years and their deposit slips and their expenditure if any undertaken and with whose approval.
5. The details of the Current Governing Bodies on what basis it has been constituted (because all the committee members are friends, family friend, working colleagues) so it is clear they have captured the office with the favourable people and made them a governing body.
6. Minutes of any meetings held amongst the members who call themselves members of Governing Body for the year 2022-24.
7. The details of additional building construction approval of any construction conducted from year 2022 to 2024 along with approved building plans from the Rajpur Sonarpur

Municipality, site plans and all flat owners' approval and also the approval of the developer that is Peerless. Because this project in their hand and it is till not handed over to us.

8. And most important the bye-laws and the memorandum of association.

This committee came forcefully in the year 2019 without any election and captured the office. In the year 2022 with the demand of the members they did hold an election but was totally manipulated and they came into force again and till today they are, and declared that there will be no election as they will remain as long as they want.

The details we are attaching along with this letter and humbly request you to kindly take action against this committee members by auditing accounts from 2019.. and sending your officials to put a search on their other activities.

Sir, we have dared to come before you with great hope. We want freedom from these dictatorship committee members, because they threaten us if we go against them. We are very simple middle class residence of Peerless Prantik Complex and from 1997 to 2018 we were going very happily with all the committee members who came into force during these periods. But few group of people forcefully captured the office without election and till today we are suffering their dictatorship behavior. Specially Mr. Pallab Bhowmik (treasurer) holds the charge of the office and creates his own law for the members. Every month he spending lakh-n-lakhs rupees has per his choice. We few residences out of 396 flat owners dared to approach with the complaint against them before you. Many did not have guts to approach before they are scared of Mr. Pallab Bhowmik threatening lines that if we flat owners him he will make falls charges and put case against us before the court.

So kindly do the needful as-soon-as-possible and get us relief from this problem. We all will be highly obliged.



So once again request you to take the required action against them as soon as possible. We are there to cooperate if needed and get us relief from this Dadagiri committee.


We have approached you with great hope. We are service middle class people and it is becoming very difficult to stay under this type of environment.





Sir,

I Mr. Manas Das, S/o Late Suchanda Das bought a flat in "Peerless Prantik" Block-A1/1, Flat No.- 304, Sonarpur-700150, from Mr. Chandan Dutta in October, 2024 on Housing Loan and went to took the physical possession on 17/11/2024.

As soon as I reached the Society gate of my flat where I was going to take the physical possession / shift. The security stopped me from entering the gate stating that I have not been allowed to enter until unless I don't pay the NOC amount in the office.

Immediately, I rushed to the office to see the secretary. I saw the office was locked. Somehow requested the security to allow my belongings to enter the gate so that I can unload my household things and later will see the secretary. I entered the gate and was going to unload my things from the lorry, Mr. Pallab Bhowmik, the treasurer of the society, came and started screaming and shouting at me with very bad language and stopped the unloading process. Stating, that I will not be allowed to take possession of my flat until unless I will pay Rs. 30,000 as a NOC of the Society.

I am a very simple man working in a small private firm with a very minimum income and somehow I have managed to buy a 1 room flat on loan.

At that moment I was not having the amount demanded which is Rs. 30,000 and humbly requested them to kindly allow me to take possession of the flat, and later somehow managed to arrange the amount and will pay to the society.

After repeated requests Mr. Pallab Bhowmik was not at all ready to allow me to take possession of the flat. And above that he called a few more people to harrass me and was abusing me and shouting at me.

I was mentally harassed and tortured by him and his friends with bad words and bad body gestures and made the atmosphere so unwanted for me that I was frightened in anticipation then they may also physically harm me, I immediately rushed to the police station and lodged a complaint against Mr. Pallab Bhowmik regarding the situation. The police officials immediately turned up and requested both the parties to settle down mutually.

To which I somehow managed to pay Rs. 5,000 and the rest of the amount I promised to pay later. This I did under pressure because I wanted to take possession of the flat.

Later after discussion with the police official he suggested to me to approached the higher official in the police station for the further action.

Now I would like to mention here that the above I promised to pay the rest of the amount looking upto the situation. Because I wanted to take possession of the flat.

Yesterday I received a certified copy of the "Mamorandum of the Association" of this society . And nowhere it is mentioned that to get the NOC from the society one has to pay the demanded amount.

Hence I withdraw my written promise that I have given in written, that I will pay the rest of the amount in the coming month.

I have to pay extra expenses for helding-up the lorry for 6-7 hours and also for unloading my belongings. I demand this extra payment which I gave to movers & packers from Mr. Pallab Bhowmik.

And also Mr. Pallab Bhowmik should apologise to me in writing for his arrogant and uncultured behaviour alongwith unwanted body language.

Also came to know there are number of complaints against Mr. Pallab Bhowmik. Which is before the registrar.

He is treasurer and he should know how to talk and how to behave with the flat owners. He should know the welcoming gestures for the newcomers.

Please kindly take strict action against Mr. Pallab Bhowmik.


Sir,

So requesting you to please kindly provide us all the information through hand deliver and email also.







Facts:- Heard today dated 26.4.2013. Appellant not present. AIIMS is represented by Dr. Sanjeev Lalwani and Shri Vinod Kumar Sharma, XEN.

2. In the RTI application dated 2.1.2013, the appellant had sought information about the payment of minimum wages to the contractual employees at Jai Prakash Narayan Apex Trauma Centre and the matters related therewith. The CPIO vide letter dated 27.2.2013 had refused to disclose any information to the appellant only on the ground that the RTI application was signed by two individuals, namely, Shri Joginder Singh and Ashok Kumar. The view taken by the CPIO cannot be upheld. It does not matter whether information is sought by one individual or more than one. The response should have been given by the CPIO as per law. Be that as it may, the following information may be supplied to the appellant:-

- (a) The Number of contractual labourers employed at the Trauma Centre, shift-wise, (Names need not be given).
- (b) Whether the contractor is paying minimum wages to the labour as per law; and
- (c) Whether the contractor is contributing towards EPF and ESIC of the contractual labour.

3. It is clarified that if the AIIMS does not have this information, the CPIO may seek this information from the contractor(s) concerned and transmit the same to the appellant.

4. This order may be complied with in 04 weeks time.

Information Sought

The Appellant sought information regarding -

• All the appellants, who are labourers in the Ms. Magadh Engineering Works (EPF Code : JH / 10532), have EPF accounts in which their monthly payments are deposited. The names along with their father's names and their account numbers are enclosed. Furnish the self certified copies of the AR and 6 AR of the mentioned names from 1999 to 2008. • Detailed copy of the orders passed since 2005 till present, under the EPF 1952 scheme provision 7 A against the Mesers Engineering Works.

Reply of the Public Information Officer (PIO) No Reply was given and application was rejected as it was a joint application by Mr. Samir Kumar Haldar and Seven others.

Grounds for the First Appeal:

No Information provided by the PIO. Order of the First Appellate Authority (FAA):

"I have gone through the contents of the matter. In the original application of Shri Haldar, the same is joined by seven other applicants but the address of communication which has been given is of Shri Samir Kumar Haldar. Further, the

copy of Form 3(R) and 6 (AR) has been sought in respect to all applications. Now, these returns content the details of member like details of wages. details of P.F. contribution etc. which is a personal information in respect of those members and is maintained by this office in its fiduciary capacity. Sending this Information for all members on the postal address of one applicant will tantamount to disclosing these personal Information to the individual on whose address the same is sent and thus would be violation of the provisions of Section 8(1) e) and (J) of the RTI Act 2005.

Hence, under the above referred sections of the RTI. Act2005. I do not think proper to disclose the information sought jointly and hence, the request of Sit Haldar is rejected. However, the individuals are free to make an application individually to seek Information under the [RTI Act 2005](#)."

Grounds for the Second Appeal:

Unsatisfactory Information provided by the PIO. Relevant Facts emerging during Hearing:

Both the parties were given an opportunity for hearing. However, neither party appeared. From a perusal of the papers it is seen that the appellant Mr. Samir Kumar Haldar had filed an RTI application which was also signed by seven other people. The RTI Application was filed on 04/02/2010 and the information should have been provided to the appellant before 06/03/2010. Instead a rejection was sent to the appellant on 30/03/2010 stating that since seven other people have sought the information the PIO was refusing to supply the information. The FAA has not taken cognizance of this objection of the PIO that seven other people have signed the RTI application along with the appellant but upheld the refusal to give information by invoking [Section 8\(1\)\(j\)](#) since the appellant had sought details of wages and PF contributions etc. The PIO's rejection was completely wrong since there is nothing in the law or the rules preventing more than one citizen from submitting the RTI application. [Section-3](#) of the RTI Act states, "Subject to the provisions of this Act, all citizens shall have Right to Information". Hence the PIO's rejection has no basis in law. The FAA has not supported the PIO's contention but has justified denial of information claiming exemption under [Section 8\(1\) \(j\)](#) to deny information relating to those who had signed the RTI Application. It is correct that the details of an individual's PF account cannot be given to any one else since it would be an intrusion on the privacy of an individual but since seven other people had signed the RTI Application jointly with Mr. Haldar the information could have been provided. In case the FAA wanted to verify if the other seven people had no objection in giving the information he could have ordered the PIO to seek their concurrence under [Section-11](#) of the RTI Act.

The PIO has without any justification delayed rejecting the disclosure of the information by 24 days.

Decision:

The Appeal is allowed.

The PIO is directed to give the complete information to the appellant before 05 August 2010.

The issue before the Commission is of not supplying the complete, required information by the PIO within 30 days as required by the law.

From the facts before the Commission it is apparent that the PIO is guilty of not furnishing information within the time specified under sub-section (1) of [Section 7](#) by not replying within 30 days, as per the requirement of the [RTI Act](#).

It appears that the PIO's actions attract the penal provisions of [Section 20 \(1\)](#). A showcause notice is being issued to him, and he is directed give his reasons to the Commission to show cause why penalty should not be levied on him.

He will present himself before the Commission at the above address on 16 August 2010 at 2.30am alongwith his written submissions showing cause why penalty should not be imposed on him as mandated under [Section 20 \(1\)](#). He will also submit proof of having given the information to the appellant.

If there are other persons responsible for the delay in providing the information to the Appellant the PIO is directed to inform such persons of the show cause hearing and direct them to appear before the Commission with him.

This decision is announced in open chamber.

Notice of this decision be given free of cost to the parties. Any information in compliance with this Order will be provided free of cost as per [Section 7\(6\)](#) of RTI Act.
