





I, **SHRI BISWANATH CHATTERJEE**, S/O- Late Nipendra Chandra Chatterjee, of village and post office- Madral, Banerjee Para, District: North 24-Parganas, Postal Index Number- 743165, make the present application to you under section 6 of Right to Information Act, 2005, in order to obtain certain pieces of information.

That fact is that my younger brother named Priya Ranjan Chatterjee is no more in the world. He passed away on 12.09.2007 at S.S.K.M. Hospital in Kolkata. Death certificate was duly issued at that effect by the concerned authority of Kolkata Municipal corporation. The said certificate bears a number printed on it i.e. "0123711". For your perusal a true copy of the same is annexed herewith.

It is also a fact that my said brother died because of an accident caused by vehicle having registration number 2882-XT 3N/2022. The accident accrued on 03.09.2007 at Kalyani express way failing under Jagaddal Police Station, District- North 24-Parganas.

It is also a fact that I duly informed the said matter to the said P.S. and a case was consequently started vide Jagaddal P.S. Case No. 311/2007.

It is also a fact that my said brother was unmarried Hindu. Both of my parents also died. Only me and my 5 sisters stand to be the legal heirs of my said deceased brother.

It is also a fact that several times I made due request to several authorities for granting compensation to the eligible legal heirs of my deceased brother.

It is also a fact that on 19.12.2022 I submitted a letter to the District Magistrate, North 24-Parganas, Barasat with the prayer for granting accidental benefits as per law. A photocopy of the said letter is annexed herewith.

It is also a fact that I have been visiting several offices to know the status of the said application and I received the following nominal pieces of information about the status of the said application.
