

Subject: Application under the provisions of Right to Information Act 2005

Sir,

I am Dipayan Mistry informing you that my sister Dipanwita Mistry is a student of your institute whose marksheets of Class XI Annual Examination 2025 is showing fail. My father has already sent an application to you regarding this matter on 05.05.2025 through inland speed post vide consignment number – EW226951848IN which has been delivered to your institute on 07.05.2025. My father already told you about the provisions of the West Bengal Council of Higher Secondary (Examination) Regulations 2024 (herein after named as WBCHSE), still we did not get any response from your end. The marksheets was generated, declared and given to me by you and the marksheets is very doubtful because it doesn't follow regulations 3(8) of the WBCHSE (Examination) Regulation 2024 which was approved by the State Government of West Bengal and published in the Official Gazette on 21.08.2024 and all the provisions are still in force because no new gazette notification available in the council website (See Sub-Section 4 and 5 of Section 21 of the West Bengal Council of Higher Secondary Act 1975). The below mentioned questions are still unanswered.

The Questions are: -

1. Why my sister's marksheets is showing fail?
2. What were the criteria to pass Class XI Annual Examination 2025?
3. Where the criteria are mentioned?
4. What is my sister's fault in this matter?
5. Is there any certified document or regulation which is more powerful than WBCHSE (Examination) Regulations 2024 dated 21.08.2024?

Again, as a guardian of my sister I am sincerely requesting you under the provisions of Right to Information Act 2005 to give me proper explanations about my sister's marksheets and answer the above-mentioned questions as early as possible.

Also, I am requesting you under the provisions of Right to Information Act 2005 to give me certified copies (Xerox) of answer scripts of the subjects Chemistry and Physics.

I hope you will pay attention in this matter and co-operate with me.
