Sir/Madam,

I would like to draw your kind attention to the fact that,

1. I submitted an RTI-Petition to the Hon'ble Public Information Officer (RTI), Office of the Hon'ble ADM&DL&LRO, North 24 Parganas on 14.04.2023 seeking specific information regarding the current status (area as Govt. land and area as Raiyat Land) of the land of RS Plot No. 464 at Mouza-Ghonarban (J.L. No. Sabek-153 and Hal- 06) under P.S. & Block- Minakhan, Dist.- North 24 Parganas. Copy is annexed as P1.
2. The Hon'ble SPIO and Dy. DL&LRO, North Parganas transferred the said RTI-Petition (u/s 6(1) of RTI Act 2005) to the concerned BL&LRO, Minakhan Block and directed him to provide the necessary information directly to the petitioner as per provision of RTI-Act 2005. His Office Memo No. RTI/2151/1/2023-DL&LRO(N), Dated 10.05.2023
3. The SPIO and BL&LRO, Minakhan Block ignored the directives of the aforesaid RTI authority. He did not provide me any information. He directly refused to provide it.
4. On 19.06.2023, I complained to the Hon'ble SPIO and Deputy DL&LRO, North 24 Parganas about the passive role of the ASPIO and BL&LRO, Minakhan Block in implementing his aforesaid directive.
5. The Hon'ble Deputy DL&LRO, North 24 Parganas sent reminder along with the allegation to the SPIO and BL&LRO, Minakhan Block and re-directed him to provide required information directly to the RTI-Applicant. vide Memo No. RTI/3019/1/2023-DL&LRO(N), Dated- 03.07.2023.

6. Once again, the reckless SPIO and the BL&LRO, Minakhan Block did not implement the directive given by the Hon'ble Deputy DL&LRO, North 24 Pgs. I did not get any information from the SPIO and BL&LRO, Minakhan Block in respect of my aforesaid RTI-Application.

7. On 11.08.2023, 15.09.2023 & 03.10.2023, I repeatedly appealed to the Hon'ble District Magistrate, North 24 Pgs. as well as the highest level of the State Administration regarding the matter in detail and requested to take necessary action against the alleged SPIO and BL&LRO, Minakhan Block.

8. The BL&LRO, Minakhan Block changed his previous stands/strategy due to tough attitude taken by the higher authorities against him. He instantly created absolutely new/absurd/manipulated (completely different from his office-records) information and sent it to me as RTI-Reply, vide Memo No. 882/BLLR/Min/2023, dated 10.10.2023. Copy is annexed as P2

8. I made an RTI-Appeal Petition (u/s-19(1) of RTI Act 2005) before the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Parganas District, Barasat on 15.11.2023 against the aforesaid unsatisfactory/impugned RTI-Reply ; **RTI Appeal Case No. 46 of 2023**. Copy of the Appeal-Petition is annexed as P3

9. The matter was taken up for hearing on 12.12.2023 by the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Parganas. Considering all aspects, His Lordship was pleased to direct "**the ASPIO & BL&LRO, Minakhan should invariably reply to the petitioner in respect of his application and also provide the information/ certified copy of the document**". His Lordship was pleased to direct once again "**the ASPIO&BL&LRO, Minakhan is directed to provide the information/document to the appellant within 15 days of receiving of this order**". The Appeal was disposed of in the above terms. Copy of the ORDER-SHEET is attached as P4.

10. The Office of the Hon'ble ADM&DL&LRO, North 24 Parganas District sent the aforesaid RTI Appeal-Order to the concerned ASPIO and BL&LRO, Minakhan Block for its comply, vide Memo No. RTYI/Appeal/969/L&LR(N), dated 15.03.2024.

11. The ASPIO and BL&LRO, Minakhan Block resumed his previous game. He ignored to execute the order of the Hon'ble Appellate Authority. He denied to provide me any information in respect of the aforesaid Appeal-Order..

12. I appealed once again to the Hon'ble ADM&DL&LRO, North 24 Pgs. for his effective intervention regarding the matter. The Office of the Hon'ble ADM&DL&LRO, North 24 Parganas District resent the aforesaid RTI Appeal Order to the concerned ASPIO and BL&LRO, Minakhan Block for immediate comply, vide Memo No. RTI/Appeal/1026/L&LR(N), date 20.03.2024.

13. Changing his strategy slightly, the ASPIO and BL&LRO, Minakhan Block re-attached the same copy of his previous RTI-Reply vide Memo No. 882/1/BLLRO/Min/2023, dated 10.10.2023 and sent it to me with a forwarding letter vide Memo No. 188/1/BLLRO/Min/2024, dated 09.04.2024. He deemed that the information mentioned in his previous RTI-Reply dated 10.10.2023 is appropriate answer to my RTI query.

Though, the Appellate Authority's Order made it mandatory to attach the certified copy of the relevant official records with the subsequent fresh RTI-Reply. Yet, as a ploy to keep the truth

undisclosed, the ASPIO and BL&LRO concerned did not attach any copy of the relevant documents in support of his RTI-Reply.

14. Thus, on 12.04.2024, I submitted a written application to the concerned SPIO and BL&LRO, Minakhan Block along with the copy of the aforesaid RTI Appeal-Order and I apprised him for expeditious execution of the said order. His Office's Receipt No. 1075, dated 12.04.2024.

15. Reiterating his previous stand, the ASPIO and BL&LRO, Minakhan Block sent me a letter vide Memo No. 211/BLLR/Min/2024, Dated - 22.04.2024 by enclosing the copy of LR ROR (Land Record) of the respective Plot 464 of Mouza-Ghonarbon (J.L. No.06) with reference to his previous impugned RTI-Reply (which was quashed by the Hon'ble 1st Appellate Authority). As a ploy to keep the Govt. land area under RS Plot No. 464 undisclosed, the SPIO and BL&LRO attached only the LR ROR copy with the letter instead of both the corresponding RS ROR and LR ROR of the respective Plot.

16. On 26.04.2024, I made complaint to the Hon'ble ADM&DL&LRO, North 24 Parganas against the reluctance and reckless attitude of the BL&LRO, Minakhan regarding non-implementation of the said order passed by the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Pgs. district.

17. On 03.05.2024, further, I brought the matter to the attention of the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Parganas and raised complaint against the ongoing illegal acts of the ASPIO and BL&LRO, Minakhan Block regarding non-compliance the order of the Hon'ble 1st Appellate Authority.

18. The Hon'ble SPIO and Dy. DL&LRO, North 24 Parganas transferred the allegation along with all contents to the ASPIO and BL&LRO, Minakhan Block and re-directed him to comply the order passed by the Hon'ble 1st Appellate Authority. His office Memo No. RTI/1402/1/2024-DL&LRO(N), Dated 13.05.2024.

19. The ASPIO and BL&LRO, Minakhan Block did not comply the order of the Hon'ble 1st Appellate Authority. He did not provide me required information. He denied the applicability of the concerned RTI Act by not complying the order of the Hon'ble Appellate Authority.

20. On 26.05.2024, I lodged complaint against the alleged SPIO and BL&LRO, Minakhan Block. I sought prompt and effective intervention of the Hon'ble ADM&DL&LRO, North 24 Pgs. and all concerned.

21. On behalf of the Hon'ble ADM&DL&LRO, North 24 Parganas, Hon'ble Deputy DL&LRO, North 24 Parganas urgently intervened into the matter and re-directed to the SPIO and BL&LRO, Minakhan Block to expeditiously comply the order of the Hon'ble Appellate Authority. His Office Memo No. RTI/1544/1/L&LR(N), dated 05.06.2024.

22. The BL&LRO, Minakhan Block stuck to his pre-set targets. He ignored the instruction of his superiors. He did not take initiative to fully comply the order passed by the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Pgs.

23. I conveyed the matter to the Hon'ble District Magistrate, North 24 Parganas as well as highest level including departmental Ministers and Secretaries of our State and appealed them to take strict action against the ASPIO and BL&LRO, Minakhan Block for his repeatedly disobeying the orders passed by the Hon'ble Appellate Authority and ADM&DL&LRO, North 24 Parganas.

24. The ASPIO and BL&LRO, Minakhan Block has changed his previous stand slightly. Through email (dated 19.06.2024), he sent me copies of his official documents i.e., RS ROR, LR Mother Scanned and its Computerized Land Record of the concerned RS Plot 464 of Mouza-Ghonarbon containing my desired information along with a forwarding letter vide Memo No. 313/BLLRO/Min/2024, dated- 18.06.2024. Copy is annexed as P5.

25. As a result, factual discrepancies in his previous RTI-Reply came out. i) In his impugned /previous RTI-Reply, the ASPIO and BL&LRO, Minakhan Block mentioned that the total land area of the Rs Plot No. 464 of Mouza- Ghonarbon is 0.96 acres only. But as his latest annexed RS ROR, the area of that Plot is 1.83 acres. ii) In his RTI-Reply, the ASPIO and BL&LRO, Minakhan Block mentioned that there is no Govt. land in the RS Plot No. 464 of Mouza-Ghonarbon. Whereas, according to the difference in area officially mentioned in his annexed RS ROR and LR ROR, there is a clear presence of 0.87 acres of Govt. land in RS Plot No. 464 of Mouza- Ghonarbon. Annexed copy of LR ROR as P6 & Copy of RS ROR as P7.

26. To make the RTI-Reply unusable and unintelligible, the ASPIO and BL&LRO, Minakhan Block has adopted an alternative route. Recently, he has released copies of aforementioned official records. But he did not make any factual changes in his previous/disputed RTI-Reply in accordance with those documents.

27. On 25.06.2024, I made application to the ASPIO and BL&LRO, Minakhan Block for necessary factual correction in his previous/disputed RTI-Reply. But, till date, he has not issued a fresh and revised Reply instead of his previous/impugned/inappropriate RTI-Reply. His Office's Receipt No. 1492, dated-25.06.24. Copy of the Application is annexed as P8.

28. I appeared before the concern BL&LRO, Minakhan Block in several times for expeditious execution of the aforesaid Appeal-Order by issuing fresh 'Reply' mentioning the factual information. But, he flatly refused to uphold the aforesaid Appeal-Order.

I made RTI-Petition as per my constitutional right (14.04.2024). I have been facing many obstacles since beginning. I have been suffering in many ways since then. I'm getting endless harassment till today. Despite many hurdles, I still haven't got the complete information. Still I don't know what else I've to do to get the necessary information properly!!!

I applied for specific information under the Right to Information Act 2005. But, the SPIO and BL&LRO, Minakhan Block has violated the relevant law by not providing the required information. He has exalted his post and power by continuously providing false and fabricated information. He has derogated my fundamental rights by not providing proper information. He has wasted my precious time and thoughts. He has committed the punishable offense of falsifying official information. He has protected the interests of influential encroachers (land-mafias) of Govt. land by concealing the true facts. He has acted against the 'Right to Information Act 2005' as well as the 'Prevention of Corruption Act 2018' by distorting information and hiding the truth. He has conspired to subvert the real objectives of the concerned law by constantly providing fake information.



Sir/Madam,

I made an application to the Hon'ble Public Information Officer, Office of the Hon'ble ADM&DL&LRO, North 24 Parganas, Barasat under RTI Act-2005 for a specific information. After a long tussle, the Hon'ble BL&LRO, Minakhan Block has transmitted me a RTI-Reply. But, there is no consistency between the 'Official Documents' and the 'Official Reply'.

In view of above, I would like to inform that,

1) On 14.04.2023, I applied to the Public Information Officer (RTI), Office of Hon'ble ADM&DL&LRO, North 24 Parganas under the RTI Act-2005 seeking specific information about the current status (area as Govt. land & area as Rioti land) of RS Plot No. 464 in Mouza- Ghonarbon (J.L. No. Sabek-153 & Hal- 06) under P.S. & Block- Minakhan, Dist.- North 24 Parganas. Copy is annexed as P1.

2) The Hon'ble SPIO & Dty. DL&LRO, North 24 Pgs transferred the said RTI application to the local BL&LRO, Minakhan Block and directed him to provide the information directly to the applicant as per provisions of RTI Act-2005 ; His office Memo No. RTI/2151/1/2023-DL&LRO(N), dated 10.05.2023.

But, no action was taken by the BL&LRO, Minakhan accordingly.

3) On 19.06.2023, I informed the Hon'ble SPIO & Dty. DL&LRO, North 24 Pgs about the inaction of the local BL&LRO regarding the matter and begged his urgent and effective intervention ; Copy is annexed as P2.

4) The Hon'ble SPIO & Dty. DL&LRO, North 24 Pgs. transferred the application along with a reminder to the BL&LRO, Minakhan Block and re-directed him to provide me necessary information; His office Memo No. RTI/3019/1/2023-DL&LRO(N), Dated 03.07.2023.

Yet, neither BL&LRO, Minakhan nor his office took any action in that regards.

5) On 11.08.2023, I re-informed the Hon'ble SPIO & Dty DL&LRO, North 24 Pgs regarding non-availability of required information and benefit of the RTI Act. Copy annexed as P3

6) The Hon'ble SPIO & Dty DL&LRO, North 24 Pgs transferred the same to the BL&LRO, Minakhan Block along with a forwarding letter for providing the information as per provisions of RTI Act-2005.

Moreover, the BL&LRO, Minakhan Block did not implement the order of his superior. He or his office did not provide any information, I needed.

7) On 04.09.2023, I appeared before the BL&LRO, Minakhan Block along with all copies of order issued by the concerned RTI authority (i.e. Hon'ble SPIO & Dty DL&LRO, North 24 Pgs) and repeatedly requested him to provide information in view of my RTI application; Copy is annexed as P4.

But, the BL&LRO, Minakhan Block did not respond to my request.

8) On 03.10.2023, I complained against the passive role of the BL&LRO, Minakhan Block regarding my pending RTI Application and appealed to the office of the Hon'ble C.M., Govt. of West Bengal and other officials concerned to take prompt and effective action ; Copy is annexed as P5.

In view thereof, the authorities concerned forwarded the same to the Hon'ble District Magistrate, North 24 Parganas for necessary action in that regards ; Memo No. 2L-44/2022/246-R/LA(504738), Dated-10.10.2023, Office of the Govt. of West Bengal, PWD (Roads Wing), Land Acquisition Br. Khadya Bhaban, Kolata-700087.

9) Finally, Mr. BL&LRO, Minakhan Block sent me a fabricated/manipulated 'RTI Reply' through Regd. Post. ; His Office Memo No. 882/BLLRO/Min/2023, dated 10/10/2023. Copy annexed as P6.

But, the 'RTI-Reply' has no consistency with its 'Official Records'.

Inconsistencies in the 'RTI Reply' :-

a) His office despatched the RTI-Reply through a Registry Post being No. RW654009295IN at Malancha B.O. on 07.10.2023 ; Copy of the Postal Document is annexed as P7. But, strategically, the SPIO & BL&LRO, Minakhan Block wrote a fake date of 1 (one) month back i.e.10.10.2023 on the official letter (RTI-Reply) as its 'issue date'. Pls. see Annexure-P6

b) I made RTI application to the ADM&DL&LRO, North 24 Pgs office on 14.04.2023. The Hon'ble SPIO & Dty DL&LRO, North 24 pgs transferred it to BL&LRO, Minakhan Block office on 10.05.2023. After a long tussle (about 6 months), the BL&LRO, Minakhan posted the RTI Reply on 07.11.2023.

It's a clear violation of the prescribed 'Time-Limit' of the RTI Act-2005.

c) In his RTI-Reply, the SPIO & BL&LRO, Minakhan Block has mentioned that the actual total land area of RS Plot No. 464 in Mouza-Ghonarbon (J.L. No. 06) is 0.96 acre. But, according to the RS Records (RS ROR, Kh. No. 293) of his office, it is 1.83 acre. Copy of the RS Record is annexed as P8.

So, it's completely false and fabricated information.

d) As per the RS Records (Annexure-P-8), Plot No. 464 of Mouza-Ghonarbon had a total area of 1.83 acre and as per LR Records (LR ROR), it is currently 0.96 acre (Annexure-P9). The remaining 0.87 acre is now a government land of Khatian No.1. But, to hide the official information, the SPIO & BL&LRO, Minakhan Block has mentioned in his RTI-Reply that there is no Govt. land in the said plot.

So, it's also a wrong and misleading information.

In fact,

i) BL&LRO, Minakhan Block has prepared this fabricated and manipulated RTI Reply to avoid inconsistency with their earlier false 'Survey-Reports' on related matters submitted to various departments including the PWD (Roads) authorities; His Office Memo No. 112/BLLRO/Min/2022, dated 23.03.2022.

ii) BL&LRO, Minakhan Block has furnished this false information to disrupt and mislead the ongoing investigation regarding the encroachment of the said plot/govt. land.


iii) In his RTI Reply, the SPIO & BL&LRO, Minakhan Block has consciously omitted the actual information regarding the government property of PWD (Roads) to hide and help the influential encroachers/Land Mafias.

I had applied to the ^{Honible} ADM&DL&LRO, North 24 Parganas for an official information under RTI Act-2005. The BL&LRO, Minakhan Block have provided a fabricated information in that regards. This is a direct violation of the relevant laws and an example of a serious violation of my fundamental rights.

Therefore, I'm appealing for providing the actual information as per my RTI Application dated 14.04.2023 (Annexure-P1).

I made an RTI-Petition to the Hon'ble Public Information Officer, Office of the Hon'ble ADM&DL&LRO, North 24 Pgs. Barasat on 14.04.2023 seeking information regarding the Status (area as Govt. land and area as Raiyat land) of the land of RS Plot No. 464 in the Mouza- Ghonarban (J.L. No. Sabek-154 & Hal-06) under Minakhan Block and Police Station.

The Hon'ble Dy. DL&LRO, North 24 Pgs. directed to provide required information directly to the petitioner by transferring (u/s 6(1) of RTI Act 2005) the same to the BL&LRO, Minakhan Block. His Office Memo No. RTI/2151/1/2023-DL&LRO(N), dated 10.05.2023

The BL&LRO, Minakhan Block knowingly provided wrong information to me in the form of 'RTI-Reply'. His Office Memo No. 882/BLLR/Min/2023, dated 10.10.2023.

I filed Appeal-Petition (u/s-19(1) of RTI Act 2005) to the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Pgs. against the 'Unsatisfactory RTI-Reply'. RTI-Appeal Case No.46/2023.

The matter was taken up for hearing on 12.12.2023 by the Hon'ble 1st Appellate Authority and ADM&DL&LRO, North 24 Parganas and His Lordship was pleased to direct "the ASPIO and BL&LRO, Minakhan should invariably reply to the petitioner in respect of his application and also provide the information/certified copy of the document".

But, the BL&LRO, Minakhan was defying the Appeal-Order by various unethical tricks and practices. The Hon'ble Deputy DL&LRO, 24 Pgs. (N) intervened the matter and directed BL&LRO, Minakhan Block to comply the order of the 1st Appellate Authority, vide his Memo No. RTI/1402/1/2024-DL&LRO(N), dated 13.05.2024.

Finally, I have received your letter (via email on June 19, 2024) vide Memo No. 313/BLLRO/Min/2024, dated 18.06.2024 along with copy of RS ROR, LR Mother Scanned Copy and Computerized Land Record regarding the RS Plot No.464, Mouza- Ghonarban, J.L. No. Sabek 153 & Hal 06, P.S. & Block- Minakhan. But, I am shocked to know about inconsistencies between your RTI-Reply and attached documents.

a) As per Rs ROR, the land area of the RS Plot 464 of Ghonarban Mouza is 1.83 acres. Whereas, in your RTI-Reply, you have mentioned "the total area of the land of RS Plot No. 464 in the Mouza- Ghonarban (J.L. No.06) is 0.96 acre".


b) As per RS ROR, the land area of the Plot 464 was 1.83 acres and as per LR ROR, the land area of the Plot 464 is 0.96 acres. According to the both ROR, the difference in area of that Plot is 0.87 acres. There is 0.87 acres of Govt. land in Plot No. 464 of respective Ghonarbon Mouza.
