

7) Reason of any fact in supports of the complaint:-

The SPIO had/ has not supplied the required documents to the applicant infringed the Ruyle-7(1) &(2). However, the required documents will not consists in the light of Rule-8(1) & Rule-11 under RTI Act,2005 as because the Municipal building rules are covered the ambit of Municipal legislation.




