

Sir,

Most respectfully, I beg to make this complaint against "no response" in respect of my application for inspection of the office records of the Block Land & Land Reforms Officer, Kanksa, situated at Vill.: Kanksa, P.O.: Panagarh Bazaar, Dist.: Paschim Bardhaman (West Bengal), PIN-713148.

My brother, Shri Samir Mukhopadhyay, has submitted false and forged documents in the office of the Block Land & Land Reforms Officer, Kanksa, and has got my land unlawfully recorded in his own name.

As such, I submitted an application to the State Public Information Officer (SPIO) of that office of the Block Land & Land Reforms Officer, Kanksa, on 18.12.2023, requesting him to let me have an inspection of the following office records:

1. The original copy of *warishannama* (ওয়ারিশাননামা) submitted by my brother, Shri Samir Mukhopadhyay.
2. The original office note sheets wherein that *warishannama* (ওয়ারিশাননামা) was dealt with and the L.R. RoR was mutated/changed in the name of my brother, Shri Samir Mukhopadhyay.
3. The original copy of each of the other documents (including applications and enclosures thereto) that my brother, Shri Samir Mukhopadhyay, had submitted at your office for mutation/change of the land record in his name.

The application was submitted by me on 18.12.2023. (A copy of the received application is enclosed.) The SPIO should have responded within 30 days offering me the inspection of the office records. Today, more than 30 days have passed, but I have received no response from the SPIO.

I, therefore, request you to kindly register a complaint under section 20 of the RTI Act, 2005, against the SPIO.



Sub.: Application for inspection of your office records under the RTI Act, 2005.

Sirs,

I beg to make this application for inspection of your office records under the RTI Act, 2005 and say as follows:

My father, Abani Mukhopadhyay @ Abani Bhusan Mukhopadhyay (since deceased), was the rayat (रायत) of R.S. Plot No. 827, Mouza – Kuldiha, P.S. Kanksa, Dist. Bardhaman (now Paschim Bardhaman), West Bengal. The plot measures 35 decimals.

My father gave, granted and assured the plot unto me. Quite accordingly, my name came to be recorded as "ଶ୍ରୀ.ଦଃ - ଲିଲିବାନୀ ଘୋଷାଳ ସ୍ତା - ଶ୍ରୀକର୍ଣ୍ଣଦେବ" in the L.R. RoR. With my name being so recorded in the L.R. RoR, my bother, Shri Samir Mukhopadhyay, had no right, title or authority to sell the said plot of land.

But, my brother has sold the entire plot measuring 35 decimals, though it was only I who had the right, power or authority to sell the plot.

To sell the plot, he first submitted a false *warishannama* (ওয়ারিশাননামা) with your office and got the plot recorded in his sole name, though he is not the sole heir of my deceased father. Moreover, my name being recorded as "ବ୍ର.ଦଂ - ଲିଲିରାଣୀ ଘୋଷାଲ ସ୍ବା - ଶ୍ରକ୍ତଦେବ" in the L.R. RoR, my brother had no scope to get the same recorded in his name even.

My brother, after thus wrongfully getting the plot recorded in his name, has sold the plot to several persons, who have, in turn, got the plot recorded in their respective names.

As such, the L.R. RoR in favour of my brother, and also in favour of several persons whom he sold several land portions of the plot, is wrongful, illegal, invalid and without authority of law.

In the above backdrop, I, under the RTI Act, 2005, wish to inspect your following office records:—


1. The original copy of *warishannama* (ওয়ারিশাননামা) submitted by my brother.
