Appellate Order

Perused the RTI application dated NIL of Shri Amit Kumar Prasad received by the SPIO & IGP(O), West Bengal on 27.03.23. The applicant sought information to get some information in c/w Rampurhat PS GDE No.1214 dated 18.04.22.

Requisite fee for filling an RTI application was not attached with said RTI application. RTI application was returned to the applicant in original by the SPIO, WBPD vide this office Memo No.118-ADM/RTI dated 10.04.2023.

Later it is found that the applicant has enclosed a copy of certificate with signature of the Chairperson & Executive Officer of Rampurhat Municipality regarding his BPL category status. The important document was inadvertently overlooked and the Dealings Assistant expressed his regret for the same.

The SPIO took cognizance of the RTI application and transferred it to the SPIO, Birbhum District vide this office Memo No.137-ADM/RTI dated 24.04.23 with an intimation to the applicant vide this office Memo No.137/1-ADM/RTI dated 24.04.23 and as per postal Consignment number tracking he has received the information letter.

The applicant preferred 1st Appeal dated 29.04.2023 which was received on 03.05.2023 by the Appellate Authority, WBPD. He has stated herein that no information has been received from the SPIO, WBPD in connection with his RTI application dated NIL.

I perused all the record. I heard the views of the SPIO, WBPD in person.

After careful application of my mind judiciously, I think that RTI petition is transferred to the SPIO, Birbhum District for taking necessary action from his end. The applicant will receive the information from the SPIO, Birbhum District within stipulated period directly. He can prefer appeal to the Additional Superintendent of Police & Appellate Authority, Birbhum district then if he does not receive the information or is not satisfied by the information received.

Hence, the appeal petition dated 29.04.2023 is disposed off.

The appellant may prefer appeal before the West Bengal Information Commission, "Khadya Bhawan", 11A, Mirza Ghalib Street, Kolkata-700087, if he is not satisfied with this order.


