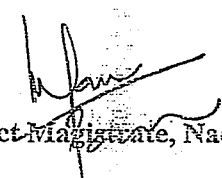

Nature of the case: Proceedings in compliance with the Order dated 12.06.2019 passed by the Hon'ble High Court in MAT-1551 of 2018 with CAN 1501 of 2019 [Pulak Kumar Dey-Vs- the Union of India & Ors.]

Dictated, corrected and signed by me  District Magistrate, Nadia	He states that following the provision of Section 3G (2) of the NH Act, a complete indemnity was provided to the Petitioner in respect of using the structure and also for being parted with the business carried out thereon. The compensation amounting to Rs. 30,260/- including a sum of Rs. 20,000/- as shifting allowance was granted in favour of Pulak Kr. Dey by the Competent Authority. Accordingly, a Notice for Payment of such amount was issued to him. But, it could not be served upon him. In the light of the above arguments and counter-arguments, the following observations are evolved:- a) that, the structure in question had long been in use of the family of Pulak Kr. Dey, since his father, Jamini Ranjan Dey entered into the lease agreement in the year 1976. b) that, the Competent Authority already granted compensation to the Petitioner for using the structure under acquisition. Moreover, under the extant Act of Acquisition, there is no provision of granting value of the structure to the Tenant, who has been enjoying the land which belongs to others. Therefore, the Competent Authority is directed to issue Notice for Payment of the amount of Rs. 30,260/- to the Petitioner afresh. In the view of the above, the claim of the Petitioner for the value of the structure on the strength of the lease agreement only is not legally tenable. The claim of compensation for setting up the structure is unconscionable in the eyes of Law. Hence, the Case is disposed of and thus the Order of the Hon'ble Division Bench of the Calcutta High Court is complied with. Let a photocopy of the Order be delivered to the interested Parties.
