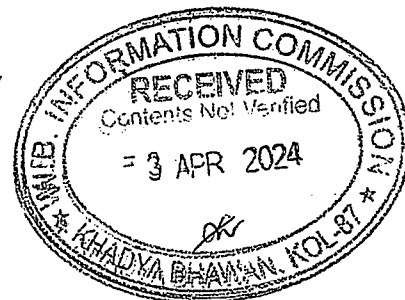

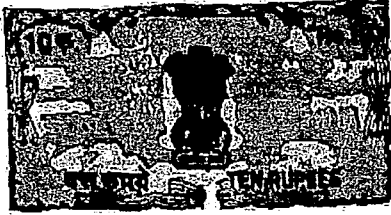

Pursuant to the instructions received from my client, Mr. Damodar Prasad Mondal, son of Late Sudhanshu Mohan Mondal, of Karangapara, Durgapur, P.S. Coke-Oven, Dist. Paschim Bardhaman West Bengal, PIN-713201, I do hereby make this RTI Application and request you to furnish the following pieces of information:-

My client is a recorded co-owner of R.S. Plot No. 5285 of Mouza Gopinathpur, P.S. Coke-Oven, Dist. Paschim Bardhaman, West Bengal. The R.S. Plot was initially recorded in the names of my client as well as his two brothers, Shri Bishnu Narayan Mondal and Shri Debi Prasad Mondal. Later, Shri Debi Prasad Mondal died intestate, while being unmarried and issueless. So, the R.S. Plot came to be held, owned and possessed by my client and his brother, Shri Bishnu Narayan Mondal, in equal proportion.



The aforesaid R.S. Plot has been converted, during L.R. operations, into three plots, being L.R. Plots Nos. 3421, 3422 & 3431. The three L.R. Plots are now recorded as having the total areas as follows:

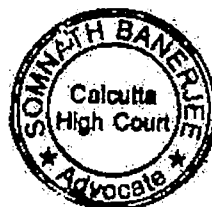

On 11.01.2023, my client came to know that the three L.R. Plots, as aforesaid, have been recorded in entirety in the name of Shri Bishnu Narayan Mondal under L.R. Khatain No. 9380, thereby depriving my client of his half share in the said L.R. Plots.

My client has further come to know that the aforesaid L.R. Khatain in the name of Shri Bishnu Narayan Mondal was opened on 10.12.2021 by the office of the Block Land & Land Reforms Officer, Durgapur.

In the above backdrop, I request you to furnish me the following pieces of information:

- (1) Was any proceeding initiated in your office to record the name of Shri Bishnu Narayan Mondal in L.R. RoR in respect of L.R. Plots Nos. 3421, 3422 & 3431 of Mouza Gopinathpur?
- (2) Under what section of the West Bengal Land Reforms Act, 1955, was the proceeding initiated? Who was the applicant? Give the details of the proceeding, like, type of proceeding, number of proceeding and year of proceeding.
- (3) When was the proceeding started? When did the proceeding conclude?
- (4) What were the documents submitted by the applicant in support of his claim in the proceeding, whether submitted with the application for initiating the proceeding, or submitted in the course of the proceeding, or submitted at the time of conclusion of the proceeding? Please mention all those documents. Please also furnish a copy of each of those documents.
- (5) Was any hearing notice issued by your office in the case? If yes, please furnish a copy of each of such hearing notices.



- (6) Was any inspection of the L.R. Plots made by your office? If yes, please furnish a copy of each of the inspection reports.
- (7) What were the orders passed in the proceeding, from time to time? Please furnish a copy of each of the orders passed and a copy of the entire note sheet of the proceeding.
- (8) Was the case referred by your office to the Higher Authorities? If yes, to which Authorities? Under what memo numbers/letters numbers/U.O. reference numbers and when? Please give the memo numbers/letter numbers/U.O. reference numbers and the respective dates.
- (9) What was the response received by your office from the Higher Authorities? Please furnish a copy of all the responses in the case received from the Higher Authorities.
- (10) Please furnish a copy of the final order issued in the proceeding.
- (11) Please furnish a copy of each of the other documents received or issued in connection with the proceeding, whether received or issued for initiating the proceeding, received or issued in the course of the proceeding or received or issued at the time of conclusion of the proceeding.

Your action in recording the entirety of the aforesaid three L.R. Plots in the sole name of Shri Bishnu Narayan Mondal has put my client in imminent danger of being deprived of his right, title and interest in those Plots.

Please furnish the information sought for, as above, at the earliest, but within the statutory time-limit of 30 days from the date of receipt of this application at your end.

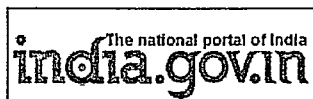

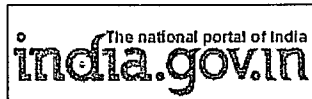
