I do like to draw your kind attention about the facts that by my application dated 27/01/20 addressed to the SPIO, School Education Department, Establish Branch, Bkash Bhaban, Salt Lake, Kolkata-700091, I requested for few information relating to one certificate issued by the Head Master of Mandar High School P.O. Ramnagar, P.S. Ramnagar, Dist. Purba Medinipur, from which it was revealed that in the year 2017-18, 2 nos. of Class Rooms of School Building of said Mandar High School was constructed by the Contractor, Niyati Building House Construction, Proprietor – Goutam Jana, vide PAN BJXPJ3230J. It is also revealed that for construction of said 2 nos. of Class Rooms in the School Building of said School a total amount of Rs.14,79,435/- was paid to the said Contractor after TDS of Rs.34,010/- S.T. Rs.34,010/- and Cess Rs.17,005/-. But unfortunately I have not yet received any information about the same i.e. I have been refused access to the information. The copy of said application is enclosed herewith for your ready reference.

In the circumstances, you are, therefore, requested to initiate an inquiry in respect of the above matter as per law of the land and oblige.

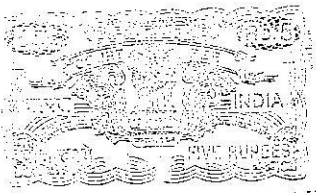
