I do like to draw your kind attention about the facts that by my application dated 18.02.2020 addressed to the Additional District Inspector of School (Secondary Education), Contai near Rakhal Chandra Vidyapith, Dist. Purba Medinipur, I requested for few information relating to one certificate issued by the Head Master of Mandar High School P.O. Ramnagar, P.S. Ramnagar, Dist. Purba Medinipur, from which it was revealed that in the year 2017-18, 2 nos. of Class Rooms of School Building of said Mandar High School was constructed by the Contractor, Niyati Building House Construction, Proprietor – Goutam Jana, vide PAN BJXPJ3230J. It is also revealed that for construction of said 2 nos. of Class Rooms in the School Building of said School a total amount of Rs.14,79,435/- was paid to the said Contractor after TDS of Rs.34,010/- S.T. Rs.34,010/- and Cess Rs.17,005/-. But unfortunately I have not yet received any information about the same i.e. I have been refused access to the information. The copy of said application is enclosed herewith for your ready reference.

In the circumstances, you are, therefore, requested to initiate an inquiry in respect of the above matter as per law of the land and oblige.

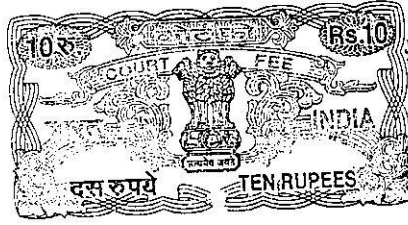

Respected Sir,

Please note, I am a Contractor and generally carryout the construction works of Roads, School Buildings, Culverts and Rural Concrete Roads all over Contai Sub-Division.

From one certificate issued by the Headmaster of Mandar High School, P.O. Mandar, P.S. Ramnagar, Dist. Purba Medinipur, I have come to know that in the year 2017-18, 2 nos. of Classrooms of School Building of said Mandar High School was constructed by the Contractor, Niyati Building House Construction, Proprietor: Goutam Jana, Village-Jagadishpur, P.O. Purba Madhabpur, P.S. Ramnagar, Dist. Purba Medinipur, PIN-721453.

It is pertinent to note that for construction of said 2 nos. of classrooms to School Building of said Mandar High School a total amount paid for Rs.14,79,435/- by two account payee cheques (one cheque for Rs.8,29,322.72 dated 28.10.2017 and another cheque dated 15.03.2018 for Rs.6,50,102.28). In addition to this amount the total amount of TDS was Rs.34,010/- and total amount of ST Rs.34,010/- and the total amount of Cess was Rs.17,005/-.

But practically no such classrooms to School Building of said Mandar High School have been constructed by anybody in the year 2017-18.

In the circumstances, under the RTI Act, 2005 I am interested to know the following.

1. Whether any Tender Notice was issued for construction of said fictitious 2 nos. of classrooms to School Building of said Mandar High School!
2. If at all any Tender Notice was issued where and on which date the said Notice was published!
3. If at all the said Tender Notice was published, who were the participants in the said Tender (Please provide the details of the participants)!
4. From which fund the said money was paid, whether funded by Government of West Bengal or whether out of own fund of the School the amount was paid!
5. Whether the said TDS was deposited before the Income Tax Authority, if deposited please provide the details of said deposit!
6. Whether the ST to the tune of Rs.34,010/- was duly deposited to the concerned department, if so, please provide the details of said deposit!
7. Whether the Cess to the tune of Rs.17,005/- recovered by the School authority was duly deposited to the concerned department or not, if so, please provide the details of said deposit!
8. The School Authority kept deposit an amount of Rs.1,36,040/-, deducting the same towards security deduction in which account the said amount of Rs.1,36,040/- has been kept by the School Authority, please provide the details!

I am enclosing the requisite fees of Rs.10/- in ^{Court fee} Indian Postal Order as per RTI Act, 2005.
