



# Facts on Record & Findings:

Both the appellant and the SPIO of the case are present for the hearing in virtual mode.

2. The appellant filed an RTI application on 28.6.2022 seeking three points of information relating to LA case No. 63/1957 - 1958 pertaining to Mouza Gabilpur in Rampurhat PS of Birbhum District. A reply was sent to the appellant on 1.8.2022 asking the appellant to mention actual plots of land for obtaining information and also that "no information about the land will be informed to any 3rd party". Dissatisfied, the appellant filed 1st appeal before the 1st Appellate Authority on 14.9.2022 and 2nd appeal before the Commission on 14.11.2022.

3. On the request of the complainant, the complaint case is being converted into

2<sup>nd</sup> appeal case in order to furnish requisite information to the appellant. On being

asked, the SPIO mentioned that the record of the LA case under reference is available.

A perusal of the RTI application indicates that the 2<sup>nd</sup> query is regarding details of

compensation paid to individuals, nothing of which is of the appellant himself and

therefore the same being 3<sup>rd</sup> party information, nothing is required to be furnished to

the appellant. However, the 1st query which seeks to know as to how much land from

RS records was acquired for apparent construction of a road and the 3rd query

regarding seeking a copy of LA map are not covered under any exemption from being

furnished being public records and the same need to be furnished to the appellant. A

time of 4 (four) weeks is given to the SPIO to furnish requisite information against

query Nos. 1 & 3 to the appellant under intimation to the Commission immediately

thereafter.

In view of the above, there is nothing further to proceed with the 2<sup>nd</sup> appeal case 4.

under consideration and the same is liable to be disposed accordingly.

**Decision:** 

In view of the facts and findings as mentioned hereinabove, the matter is

accordingly disposed of and closed.
