I had written a RTI Act, 2005 application to Diamond Harbour Sub Divisional officer in 16/07/22 for providing me the information of booth no. 153 Gram Madhabpur in under of Krishnapur Gram Panchayat under of 135 Mandir Bazar Bidhan Sabha information from 2000 to 2022 that what work is going on and which work is pending and future work plans and in this all work how much money is alerted by government and how much money is spent. All over I am asking for information of village development. But the sub-divisional officer forwarded my application to The State Public Information / Joint BDO of Mandir Bazar development block in 25/07/22 and told him to provide me the informations directly but the SPIO / Joint BDO of Mandir Bazar development block forwarded my application to SPIO & executive Assistant - In-charge of Krishnapur Gram Panchayat on 29/07/22 for providing me the informations. Then SPIO & executive assistant - In-charge of Krishnapur Gram Panchayat sent me a letter on 02/08/2022 and calls me for a meeting in Krishnapur Panchayat on 08/08/22 at 12:00 noon. As he

told me to be present there. I went with my 2 person and saw that there SPIO of Krishnapur Guam Panchayat and few persons were present there. They told me to sit there and they didn't allow my 2 persons to get in and they just push them out and closes the door and they told me to sign in blank paper but I didn't sign then they give me so many threats and also misbehave with me and told me to deposit 5,00,00/- (five lakh rupees) on 10/08/22 at 10:00 am and also said this is first deposit the rest rupees then find out by yourself the information from here." But this is not possible for me to deposit this amount so I came home from there any how. And on that same day I went to Diamond Harbour sub-divisional officer at 2:30 pm to 3:00 pm and told him about what happens with me and all matter. And sub-divisional officer told me to visit once to SPIO/ Joint BDO of Mandir Bazar development block. As he told me to visit there I went to visit him and the SPIO of Mandir Bazar development block told me to again visit SPIO & executive assistant - In-charge of Krishnapur Guam Panchayat and I also went there once again but he did the same behaviour and didn't give me the informations and threats from some rule breaker type persons but any how I came out from there. Respected Sir/Madam this is my humble request that please ^{take} some legal steps and me and my family are not at all safe. I am sure that anytime anything can happen to us. Sir/Madam please provide us police protection that can me and my family feels safe and please provide me the data or informations of village development that I am demanding. I hope you will listen our request and take legal steps.

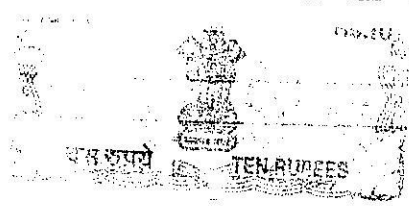

Facts on Records:

1. Shri Ranjit Halder, vide his application dated- 16.07.2022 requested for the following information from SDO, Diamond Harbour, South 24 Parganas in c/w booth no. 153 Gram Madhabpur in under of Krishanpur Gram Panchayat under 135 Mandir Bazar Bidhan Sabha from 2000 - 2022:

- i) What work is going on and which work is pending and future work plans and in this all work how much money is allotted by Government and how much money is spent and contactor name etc.
- a) Pradhan Mantri Awas Yojana
b) Job Card (100 days work who did participate in this and how much money they get)
c) Paltry Farm
d) Plantation

- e) Building Pond
 - f) Agriculture Loan (KCC)
 - g) Road (Modhaiur St. Toto to East PWD Kulpi Road)
 - h) Water way (Drain)
 - i) Senior Officer Pension
 - j) Widow Woman Pension
 - k) Deep Tube Wells
 - l) Water Supply Pipeline
 - m) Concrete Road Repairing
 - n) Pond Filling etc. village upgrade information.
2. SPIO, DM & DC, Diamond Harbour, South 24 Pgs. transferred to the SPIO, Mandirbazar Dev. Block, South 24 Pgs. vide memo no. 859/Con/SDO/DH/22 dated 25.07.2022 to provide information directly to the appellant.
 3. SPIO, Mandirbazar Dev. Block, South 24 Pgs. forwarded the RTI application to the SPIO, Krishnapur Gram Panchayat, South 24 Parganas vide memo no. 1754/RTI/MBZ dated 29.07.2022
 4. SPIO, Krishnapur Gram Panchayat sent a letter to the appellant in this matter vide memo no. KGP/169/22-23 dated 02.08.2022 with a request to physically present on Krishnapur Gram Panchayat office on 08.08.2022.
 5. Grounds for complaint / 2nd appeal is non-receipt of information, SPIO asked to deposit Rs. 5 Lakh to get the information and misbehaved repeatedly.
 6. Relief sought for by the appellant is to provide information.

Deliberations and Decision:

7. The appellant is present along with Sh. Ranojoy Chatterjee, Advocate. He stated that the appellant was called for an inspection in the office of G.P. vide para 4 above. Then he was asked to specify his requirement. He produced a copy of form in support of his statement. He stated that the Pradhan never said that he would not provide the reply. So, this is one more reason that he should have replied to it.


8. The Commission pointed out to the appellant that he has asked for huge amount of information which is general, vague, wide, omnibus & voluminous. The reply to these queries will not serve any public interest and even any bonafide personal interest. This is mere harassment of Public Authority and at the same time a complete misutilisation of RTI Act. Therefore, this could not have been replied also. This has reference to the following provision of RTI Act and case law.

- (a) The preamble of the RTI Act, 2005 says that democracy requires informed citizenry and transparency of information which are vital to contain corruption and to hold Govt. accountable. This aim of the Act has to be harmonized with other public interest including efficient operation of Govt., optimum use of limited fiscal resources etc.
- (b) Section 6 (1), RTI Act.
- (c) Hon'ble Supreme Court judgement of 2011 in case of Aditya Bandyapadhyya vs. CBSE.
- (d) Hon'ble Supreme Court judgement dated 02-09-2011 in The Institute of Chartered Accountant of India - Vs. - Shaunak H Satya and Ors.
- (e) Shail Sahni Vs. V. S. Mathew & others (Delhi High Court, 2016).
- (f) Shishir Chand Vs. Central Information Commission (Delhi High Court, 2023).

9. The appellant was asked to give any specific request for reply. He mentioned that he could be given information about building ponds. But the Commission found it vague & not specific.

10. Appellant is advised that in future he should file RTI application keeping in view the spirit of the RTI Act and various judgements of Hon'ble Supreme Court & Hon'ble High Court. The case is closed.

11. The matter is disposed of.
