3 Cause of Complaint :- A I did not get my information of my RTI application dt 16/7/24 (encl-1) with time limit, hence Complaint

4 Fact of Complaint :- In few important information I wrote to CP10 of O/o Commissioner of Police, Kolkata under Postal Regd. But I did not get the information within time limit permissible as per act which is a violation of Act. Hence I lodge this Complaint W/S 18(1) of RTI Act.

5. Relief sought :- (i) CP10 be directed to provide me the information  
(ii) Impose penalty for delay action W/S 18(1) b kc of Act @ Rs 250/- per day delay W/S 20(1) of Act  
(iii) I may be given the opportunity of being heard in person via video call before taking any decision

6 Grounds of Appeal :- (i) As a citizen of free Country I am legally entitled to have the information which denied by CP10, O/o COP K hence the appeal  
(ii) The information I sought is not included in the Exemption List W/S 8 of Act.

The above complaint is made W/S 18 of Act. Since there was no reply from CP10, 1st Appellate authority is not approached as per act W/S 18(1) b kc of Act


