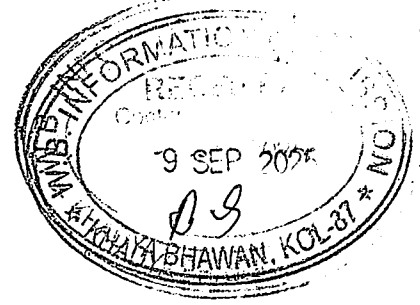
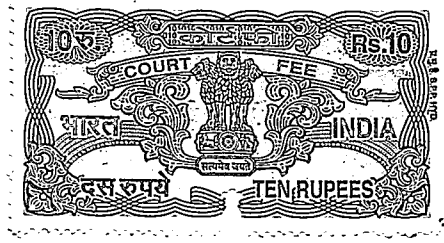

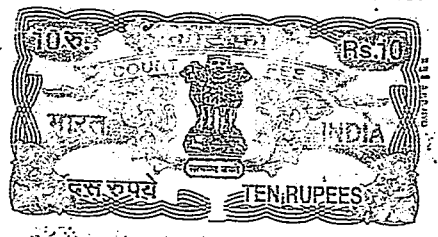

Respected Sir

I have received your letter with report submitted by Inspector in Charge Mr.Mrinal Sinha Kandi P.S Murshidabad memo no -522 dated 17.06.2025 and note content with regret.

This is perhaps for the first time that I have been alleged by the ASI Mr Krishnapada Ghosh who was mobile duty on 21.03.2025. It is seen from the report that he found Tapan Kr Paul and Srimanta mondal were making a hot altercation and quarrel with local people over the issue of land dispute matter and ASI Krishna Pada Ghosh tried to stop but they did not pay any heed, finding no other alternative way, he arrested U/S170BNSS and brought to P.S with a view to prosecute U/S 126BNSS. But Practically I made him to construction work over PWD land in front of my existing room on 21.03.2025 and that time said ASI took me and others to the P.S kandi and stopped construction work.

So my thanks know no proportion to Sri KrishnaPada Ghosh ASI who was on mobile duty on 21.03.2025 for his keenness of observation and inordinate activeness to stop my construction and overlooked the running construction of Samar Pal s/o Lt .Ganapati Pal and consummate wit for preparation of arrested and accused ground to a 64 years retired Govt.employee and law abided person and creating present catastrophe which increased problem just after his action against me .

It is worth mentioning that Samar Pal s/o Lt.Ganapati Pal and his wife Momota Pal have extended room over Pwd land covered some part of my passage to ingress and egress forcibly . When incident occurred I requested them not to cover my passage to ingress and egress knowing my inconvenience, they refused to co-operate and leave my passage. They were also verbally very abusive during the discussion.

on 22.06.2025 Samar Pal rest part of my passage to ingress and egress he did outlet drain of his extension room the same way and communicated to you the serious matter on 23.06.2025 but no effective result has been received from you

I am one justice its follower and aspirant of relief the present situation under constitutional rules .So You are once again requested to kindly investigate into the matter impartially and judiciously as deem fit and proper in conformity with my above prayer to restore my passage covered by Samar Pal and his wife Momota Pal and stop all type of conspiracy allow me to covered my front of existing room by fencing as early as possible to avoid future complicity.

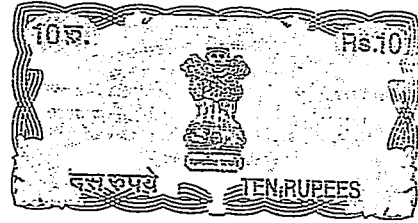

With due respect, I beg to report that in compliance to your kind order, I enquired the matter personally. During enquiry, I consulted with the available PS Records and Registers, it came to learnt that on 21.03.2025, during mobile duty, ASI Krishna Pada Ghosh of Kandi PS along with force had been to Ghanashyampur Road under Kandi PS and found that the alleged persons namely (i) Tapan Kr. Paul S/O Bibhutibhusan Paul of Vill- Ghanashyampur, PS- Kandi, Dist- Murshidabad and (ii) Srimanta Mondal S/O Prabhat Mondal of Banti, PS- Kandi, Dist- Murshidabad were making a hot altercation and quarrel with the local people over the issue of land dispute matter. Then, ASI Krishna Pada Ghosh tried to stop them, but they did not pay any heed. Finding no other alternative way, he arrested them U/S 170 BNSS and brought to PS with a view to prosecute them U/S 126 BNSS.

After some time, on demand of local people, both of them were released from PS on Bail Bond and PR Bond with condition to appear before Ld. Court as and when directed and ASI Krishna Pada Ghosh submitted NCR before Ld. Court vide NCR NO. 457/25 dt. 21.03.2025 U/S 170/126 BNSS against both the alleged persons.

where police inaction case is to be filed before the Hon'ble High Court Calcutta case no WPA/27783/2024 which is under judicial consideration there inordinate activeness of police it was very much shocked during confinement as I know nothing regarding my fault of such type of action till now

An application has been sent to I.C Kandi under RTI Act 2005 to ensure regarding my fault and reason of confinement on 22.03.2025 but yet to receive reply.

Sir, Samar Pal S/O Lt. Ganapati Pal and his wife Mamata Pal are worshipping in accordance with tantara, mantara and an amulet trafficker. They are very dangerous and greedy persons they may any cause any harm to me even loss of my life
