

1. Shri Amal Chandra Ghosh, the appellant stated that he submitted a complaint to the WBIC on 05.01.2013 regarding non-furnishing of information as per his RTI application dated 17.07.2012. Thereafter, WBIC sent a letter to the SPIO, Public Health Engineering DTE, Balurghat vide memo no. 2887-WBIC/RTI/526/16 dated 03.07.2018 to dispose of the RTI application. On the basis of the letter of WBIC, the appellant visited to the Balurghat office on several occasion for required information but all his effort was in vain. He stated that as per list of ongoing w/s scheme, PHE Det. under Dakshin Dinajpur district provided by the Executive Engineer, Malda he submitted the application for engagement of Pump-operator. But Executive Engineer, Malda informed him that "there is no information regarding engagement of Pump-operator under Malda Mechanical Division (memo no. 1397/MMLD Dated 18.09.12) ". Besides, as per letter of Executive Engineer, Balurghat Diviion, PHED vide memo no. 929/BD Dated

13.05.2013 appears "there is no information regarding engagement of pump operator under Balurghat division, Civil, PHED".

It is to be mentioned that he submitted RTI applications dated 17.10.2016 & 06.11.2017 regarding non-engagement as pump operator. On 22.10.2018 & 18.01.2019 the appellant submitted two appeals to the WBIC in this regard.

- 2. Shri Amal Chandra Ghosh, vide his application dated- 17.07.2012 requested for the following information from District Magistrate, Dakshin Dinajpur:
 - i) Provide information whether my selection as pump operator under PHE passed in the Board meeting?
 - ii) Provide information whether my work at Bhangar Hat PHE has been passed?
- 3. WBIC sent a letter to the SPIO, Public Health Engineering DTE, Balurghat vide memo no. 2887-WBIC/RTI/526/16 dated 03.07.2018 to dispose of the RTI application dated 17.07.20212.
- 4. Grounds for complaint is non-receipt of information.

Deliberations and Decision:

- 5. The appellant and his daughter Ms. Soma Ghosh is present virtually.
- 6. The SPIO is present virtually.
- 7. It is seen that since it is a 2012 case i.e. 13 years old case, the SPIO was not aware.
- 8. However, the appellant submitted that he got the reply of the information and he was satisfied with the reply. The case is closed.
- 9. The matter is disposed of.
