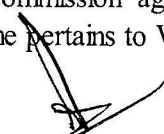

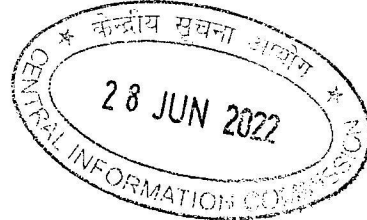

The attendants, Nurses and doctors misbehaved with him . they afterwards refused to replace plates inserted inside his leg and other regions. Afterwards the doctors even tried to take his life as he acted as

whistle blower regarding mismanagement and abysmal negligence as well as misbehaviour of the officials including doctors and nurses. The Medical College Superintendent cum principal, Malda Medical College and Hospital, Malda give a concocted order after getting officials communique from Dy Director of Medical Education & SPIO. Govt of West Bengal, Kolkata-91. The SPIO duck questions and appellate authority also acted as stooge of Hospital staffs without considering age and position of the applicant/appellant. The inference drawn by the MSVP Malda Medical College & Hospital, Malda is fabricated and figment of imagination as well as highly biased.

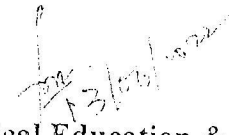

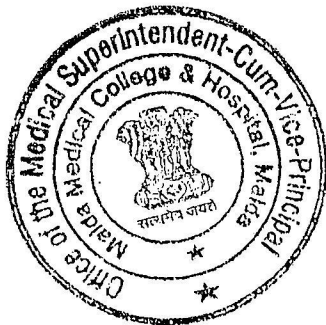
