

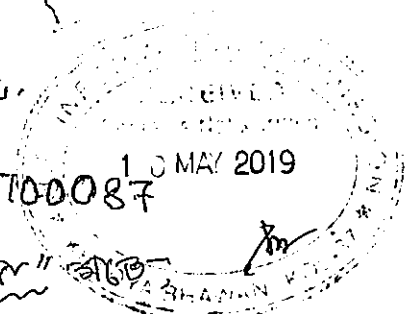

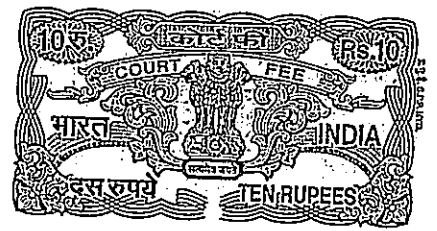

In compliance to the solemn order of the Hon'ble Commission and after careful perusal of the available office records of officel do hereby submit before this Hon'ble Commission of para wise written submission on Appeal being No. 100555 of 2024.

- 1) This is to humbly submit in respect of the Appeal that the allegation made by the appellant is against the purported inaction with respect to an RTI Application dated 22.01.2019.

I have joined as the Block Land & Land Reforms Officer, Barabazar on February, 2023, which is much later to the date of filing of the RTI Application.

Thus, I was in complete dark about the application filed and any action/ inaction by the then S.A.P.I.O. of B.L.&L.R.O., Barabazar.

- 2) This is to submit that from the Office records and the attachments of this instant Appeal it is evident thatwith due respect to the RTI Act, 2005 one reply was given to the RTI Application dated 22.01.2019 from the part of the S.A.P.I.O of BL&LRO, Barabazar vide this office Memo No. 693/BL&LRO/BZR/PRL/2019 dated 25.02.2019 the applicant within stipulated time as guided by RTI Act, 2005 and RTI Rules, 2006. The reply was given to the Applicant requesting him to inspect the document at his convenient time after giving prior intimation to the Office as provision U/S 7(4) of RTI Act, 2005. Full opportunity was accorded to the Appellant/Applicant to see the record himself but he did not show any interest to get his required information.
- 3) On perusal of the RTI Application it is found that the applicant wanted to get the documents from this Office which he claimed to submit to this Office by himself on different dates as mentioned in his RTI application. In his RTI Application the applicant sought for these list of documents but did not mentioned any case number, plot schedule related to which he wants the said documents.
- 4) Having due respect to the provision of RTI Act and Rules this is to submit that the undersigned is not in a position to track the records from the huge bulk of the office records without any case number or Memo No. As the information sought for is not maintained in such format from which these documents can be located. The applicant's query to some extent is not specific.The specific reference is needed from the part of the applicant which can help to locate the information otherwise the searching may disproportionately divert the resources of the Office and prevent the office from



discharging its normal public duties. Hence, this is to humbly submit that the reply provided to the appellant is just and as per the provisions of RTI Act, 2005.

- 5) This is to submit that the averment made by the Applicant for not supplying the information or reply is not true. But on the basis of my submissions in the foregoing paragraphs, I humbly beg to submit that the then S.A.P.I.O of B.L.&L.R.O., Barabazar provided a reply appreciating the true spirit of the RTI Act, 2005 and RTI Rules, 2006 which appears to be justified.
- 6) This is to further submit that the averments made by the Applicant are not tenable in the eye of law as guided by RTI Act and RTI Rules. Therefore, it is humbly prayed that this Hon'ble Commission may be gracious enough not to take any cognizance of the statements/averments made by the applicants and to pass necessary order / orders, direction/ directions dismissing the instant Appeal.

Facts on Record & Findings :

The SPIO of the case is present for the hearing in virtual mode while the complainant remained absent.

2. The complainant filed an RTI application on 21.1.2019 seeking land related documents of four persons without giving any details of area and / or other details nor clarifying as to what information was exactly required by him. The SPIO vide his letter Dated 25.2.2019 asked the complainant to inspect the requisite documents after giving prior intimation to the office of the BL & LRO, Barabazar. Dissatisfied, the complainant filed a complaint before the Commission on 21.4.2019.

3. From a perusal of the RTI application, it is not clear as to what specific information was sought by the complainant nor it could be found out whether the

documents were sought with reference to some ongoing proceedings before the BL & LRO office etc. The SPIO correctly asked to the complainant to visit his office and inspect records as it was not understood as to what specifically was required by the complainant. This therefore appears to be a case where no specific information was sought and the RTI application does not clarify as to what were the information / documents sought. In the absence of any specific information sought and also the fact that the complainant did not avail himself of the opportunity given by the SPIO to visit his office and search for documents / information with reference to his RTI application, I find that there was nothing more on part of the SPIO that he should have done in the present case.


