**Facts on records:**

The complainant filed two RTI applications for obtaining some information. Due to non-receipt of information, the complainant filed an application before the Commission. In turn, the Commission vide letter dated 2.9.2019 directed the public authority to transfer the said RTI application to the appropriate authority to dispose the matter within 30 days under intimation to the Commission.

In compliance of the order, the Circle Project Coordinator vide letter dated 21.10.2019 provided information to the complainant. The complainant by the instant complainant not only expresses his dissatisfaction but also alleged that the information so provided or incorrect / misleading in nature. The Commission decides to resolve the complaint by conduct of hearing and accordingly 03.02.2021 has been fixed.

**Decision:**

The matter has been called for hearing as per schedule.

Perused instant complaint together with all relevant documents, enclosed therewith.

The SPIO during the hearing submits that the complainant has been provided information firstly on 21.10.2019 and further on 28.01.2020 except the information pertaining to query No. 3 as the same does not constitute information. Since the copy of the reply dated 28.01.2020 has not been submitted before the Commission, the SPIO is directed to submit the same within 2 weeks from the receipt of this order before this Commission for proper appreciation. Since, it transpires from SPIO's submission that he had requested the SSM office for providing the information, lying with them but didn't transfer it in terms of the Section 6(3) of the RTI Act. SPIO is hereby advised to act prudently while disposing RTI matters.

The complainant submits that he is not satisfied with the information he has received. The complainant is hereby directed to submit in writing, his specific dissatisfaction over the received information with two weeks from the date of receipt of this order for proper appreciation of the matter.

Next hearing will be held online. The date and time will be intimated in due course. The SPIO is directed to attend the next hearing.

**Facts on records:**

The complainant filed two RTI applications for obtaining some information. Due to non-receipt of information, the complainant filed an application before the Commission. In turn, the Commission vide letter dated 2.9.2019 directed the public authority to transfer the said RTI application to the appropriate authority to dispose the matter within 30 days under intimation to the Commission.

In compliance of the order, the Circle Project Coordinator vide letter dated 21.10.2019 provided information to the complainant. The complainant by the instant complainant not only expresses his dissatisfaction but also alleged that the information so provided or incorrect / misleading in nature. The Commission decides to resolve the complaint by conduct of hearing and accordingly 03.02.2021 has been fixed.

**Decision:**

The matter has been called for hearing as per schedule.

Perused instant complaint together with all relevant documents, enclosed therewith.

The SPIO during the hearing submits that the complainant has been provided information firstly on 21.10.2019 and further on 28.01.2020 except the information pertaining to query No. 3 as the same does not constitute information. Since the copy of the reply dated 28.01.2020 has not been submitted before the Commission, the SPIO is directed to submit the same within 2 weeks from the receipt of this order before this Commission for proper appreciation. Since, it transpires from SPIO's submission that he had requested the SSM office for providing the information, lying with them but didn't transfer it in terms of the Section 6(3) of the RTI Act. SPIO is hereby advised to act prudently while disposing RTI matters.

The complainant submits that he is not satisfied with the information he has received. The complainant is hereby directed to submit in writing, his specific dissatisfaction over the received information with two weeks from the date of receipt of this order for proper appreciation of the matter.

Next hearing will be held online. The date and time will be intimated in due course. The SPIO is directed to attend the next hearing.
