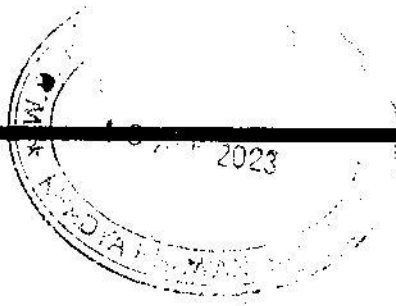

Prabir Sandan have attacked me inside the  
office premises at 2:06 P.M. this resulted in  
injury to the right corner of the right eye.  
The goons had attacked with bare hands and wooden  
sticks. The main cause of this attack was that  
there was wrong delivery of cheque book of

Nitya Naskar w/o Laxmikanta Naskar to  
another recipient which outraged Laxmikanta  
Naskar. Due to this he had brought along  
with Prabir Sandan and other goons.

The outcome of the attack resulted  
in breaking of window pane and another  
wooden frame of the post office  
causing damage in the govt. property of  
the post office.




