Sub: Prayer for some information under RTI Act - 2005

Respected Sir,

I, Sri. Pramatha Halder want to state that my son, Raksh was admitted at Memari V.M. Institution (Unit-1) on 17/01/2023 in class X (Ten). But his name was registered in class IX in his previous school i.e. Koley Para Kanthal Gachi High School (H1-122). He studied at Memari V.M. Institution (Unit-1) upto class - VIII and he was peaceful. But, at his previous school (i.e. Koley Para Kanthal Gachi High School) he was very much hyperactive and lost his concentration in study to some extent. Even he was being attracted towards addicted persons. Under this condition my family was helpless and after taking advice from a doctor, he was admitted at his present school (i.e. Memari V.M. Institution Unit-1). Now he is peacefully reading there. For regularizing this admission, when I went to your office to submit Form NO: WBBSE/03 with other documents, It was refused to accept again & again. Then I sent four letters to respected MIE, Principal Secretary of School Education Deptt & the President and the Secretary of West Bengal Board of Secondary Education. After this, when I went to Niladita Bhawan to pursue the matter, on 16/02/2023, Subhara informed me that he had talked to the authority of Park Street office and the office of Park Street would accept the documents that lay in add & online certificate mentioning promoted to class X in 2023.

But, a letter from you, declining the application for admission in class X has been sent to the school and a copy to me.

Under that condition, I want some information (PTO)

under RTI Act-2005 and kindly oblige me by providing the information as quick as possible considering the urgency.

① What is written in rule of West Bengal Board of Secondary Education in allowing and declining the application for admission in class X?
(Kindly provide the ^{an completed} authenticated copy of the above rule)

② On which date the rule was issued?

③ At the time of rule formation, Was a student with 2 'D' in subjects with overall 25% marks, promoted to class X? Or 2022 was the special year for such relaxation after corona lockdown?

④ As per online result, my son has passed and as per online certificate, he has been promoted to class X in 2023.

⑤ Is there ~~no~~ value of online result and online certificate, downloaded from Bangla Shiksha Portal?

⑥ As per online result and certificate, my son would be a student in of class X and in Kolkpara Kamthal Gachi High School and there would be no problem to appear in Madhyamik Examination. But, I was bound to change his school on the advice of doctor to save son's life from dangerous companion. My son had never got a single 'D' in any subject upto class VIII.

Now my question is → Will Madhyamik Board ^{not} show any sympathy to save one student's life in relaxation of the normal rule if necessary?

⑦ What is written in rule of WBBSE about the problem if a ^{Passed} student (getting more than 2 'D' in subjects of class IX), changes his school in class X?
(Kindly provide relevant authenticated portion of the above rule)

⑧ I was informed from Park Street office, ~~an~~ Form NO: WBBSE/03 with other documents including "Pass" "result" and "certificate" mentioning promoted to class X and my letter to the respected Board President (pro)

and Secretary, was sent for the consideration of Board President.

☐ My question is → Was it possible to draw the kind of the President's attention/towards my helpless condition? Did he make any written comments in this respect?
(Provide me an authenticated copy of the comments)

⑧ How can I meet the Board President and when?
(Kindly mention time and place)

⑨ What is the next course of action of my son ^{as a student} and I myself as a father in respect of school education?

⑩ In this situation, who can reconsider and provide permission?

⑪ In this condition, if my ^{son} becomes much depressed and loses interest in education ~~life~~ and life, what will be remedy?

⑫ Kindly provide me information about the Appellate Authority (name & office address) and about Information Commission (designation and office address)

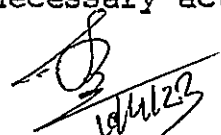
