U/s of RTI Act, 2005".

(c) DISCIPLINARY ACTION:

Sir, please recommend disciplinary action against S.P.I.O. & F.A.A. as per section 20(2), who has "without reasonable cause and "persistently" denied my request for information.

(d) The S.P.I.O & F.A.A.be penalized and strict disciplinary action be taken against him under service conduct rules and discipline and appeal rules 1968 and 1969

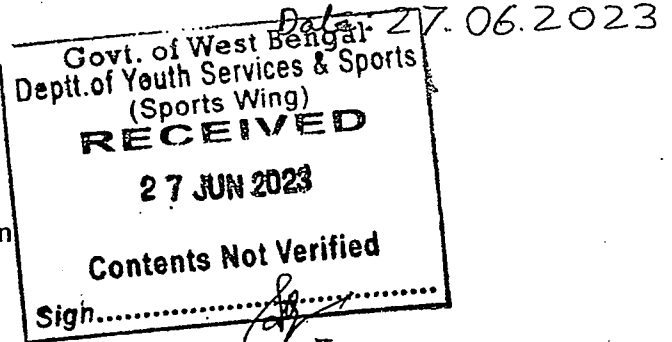

Reply of the State Public Information Officer:

No reply has been given after lapse of 45 days for submitting the information before the State Public Information Officer.

Ground of Appeal:

Sir, Under the provision of the R.T.I. Act, 2005, there is a provision to provide information to the Applicant within 30 days but even after lapse of 45 days, non provision of information shows that neither the Public Information Officer, nor the R.T.I. passed by the Parliament of India Act, 2005, does not care about the rules and Regulations protection of human rights.

*This is clearly accepted by the appellant that the Public Information Officer has refused to give information under section 7(2).

*The Public Information Officer is habitually guilty and using his post misusing, not working properly, not giving information on time, intentionally delayed and also violation of the R.T.I. Act, 2005.

*It seems clear from these things that the Public Information Officer is flouting the R.T.I. Act, ignoring the R.T.I. Act, which is a serious matter and neglect of government duties.

* Issuing a written warning to the Public Information Officer under the existing rules and regulations, directing him to comply with the time limit specified in the R.T.I. Act, 2005 passed by the Parliament of India as well as the R.T.I. Act.

*And other relief, as the Appellate Authority may feel necessary in making the Public Information Officer to comply with the direction of law and inform the concerned S.P.I.O that the appellant will move a Second Appeal before the S.C.I.C under section 18(1) and will demand imposition of under section 20(2) service book record and penalty under section 20(1) of the R.T.I. Act 2005, at the rate of Rs.250.00 for every day of delay (subject to a maximum of Rs.25,000 from the date the information was due till the date the information is actually given to me.

Under the circumstances, kindly supply me the desired information available within the time limit under the provision of R.T.I. Act 2005. I will bear the necessary cost of required as per the protocol of the office in concern.

The said "Khidderpore School of Physical Culture" has been illegally operating from an illegally occupied K.M.C Premises No.21/1, Ekbalpore Lane, Kolkata-700023. (Annexture A & B)

The said Sk. Merajuddin Ahmed alias Cheena has been defrauding and collecting money from different organizations and persons in the name of the said fake club.

The said Sk. Merajuddin Ahmed alias Cheena had practiced fraud and had withdrawn **PUBLIC MONEY** for a sum of Rs.2,00,000/- in F.Y-2014/15 and Rs.1,00,000/- in F.Y-2015-16 total Rs.3,00,000/- from your department in the name of the said fake club. (Annexture C and D)

The said sum of Rs.3,00,000/- is a **PUBLIC MONEY** and you are the custodian of the said money and said money cannot be squandered. I by my letter to you have repeatedly informed you with all relevant documents and evidence about the said fraud being practiced upon your department and cheating of the **PUBLIC MONEY** for the said sum of Rs.3,00,000/-. After getting all informations about the said fraud you are duty bound to recover the



said money and inform the police and lodge a F.I.R but strangely enough you are sitting tight over the matter and has not taken a single step to recover the **PUBLIC MONEY** and start a F.I.R against the said culprit.

I therefore request your kindness to take immediate and urgent step to recover the said **PUBLIC MONEY** and start F.I.R against the said person.

I have earlier lodged a written complain stating the aforesaid fact but there was a mistake in the said complain in para 2 instead of 21/1, Ekbalpore Lane, it has stated as 21/1, Nawab Ali Lane. Hence I am filling a fresh complain.

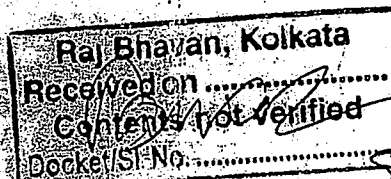

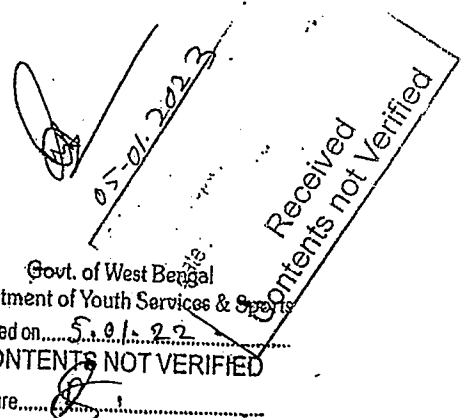

Facts on Records :

1. Sajed Ekbal, the appellant submitted a complaint dated 05.01.2023 addressed to the Senior Special Secretary & Ex. Officio Director, Youth Service & Sports, WB. In the complaint he stated that one Sk. Merajuddin Ahmed alias Cheena son of Late Sk. Amiruddin presenting himself as the secretary of a club namely of "Khidderpore School of Physical Culture". The said club is a fake club registered from a fake non-existent address at 2/1, Nawab Ali Lane, Kolkata – 700 023. The said club has been illegally operating from an illegally occupied K.M.C Premises No.21/1, Ekbalpore Lane, Kolkata – 700 023. The said Sk. Merajuddin Ahmed has been defrauding and collecting money from different organizations and persons in the name of the said fake club. He had drawn PUBLIC MONEY amounting to Rs. 2,00,000/- in F.Y-2014/15 and Rs. 1,00,000/- in F.Y-2015 - 16 from Sports Department. The Department should take prompt action to recover the said money and inform the police to lodge a F.I.R.

2. Sajed Ekbal, vide his application dated- 03.05.2023 requested for the following information / documents from the SPIO, Youth Services & Sports Department, Kolkata in c/w his complaint dated 05.01.2023. :

- a) The complaint letter I had given on 05/01/2023 in your department more than 3 months I didn't get any reply in your office, let me know any legal action happened or not, if not then please furnish the reasons of my said complaint letter.
- b) The complaint letter I had given on 05/01/2023 in your department, let me know the present progressive report of my said complaint letter.

3. Grounds for complaint is non-receipt of information and relief sought for by the appellant are i) to provide information ii) to impose penalty as per sec. 20(1), RTI Act 2005 against SPIO & 1st appellate authority for not providing the information iii) to recommend disciplinary action against SPIO & 1st appellate authority as per sec. 20(2), RTI Act 2005.

Deliberations and Decision :

4. The Appellant is absent despite option to appear virtually. He has neither sent any intimation nor he has sent any representative. His telephone number was tried but he is not available. The SPIO is present in person.
5. The SPIO submitted that the previous SPIO replied to the appellant vide letter no. 295-SP/1M-19/2023 dated 22.02.2023. The Commission noted that the reply is not satisfactory. The appellant is asking about the status of his complaint. The SPIO, is directed to relook into the matter and reply the RTI application.
6. Next date of hearing is fixed on 11.12.2025 (Thursday) at 11.30 hrs.
