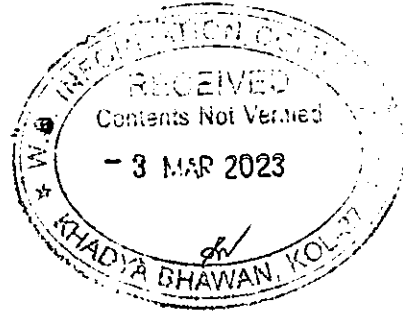

of the Appellate authority is annexed herewith).

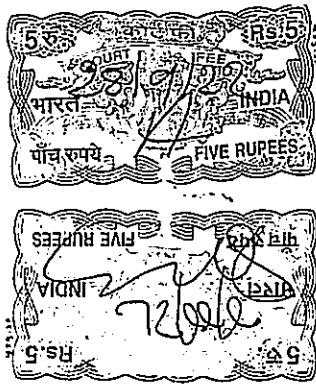

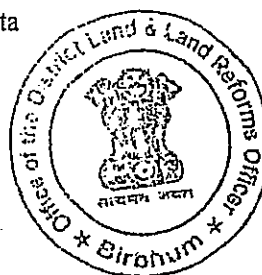


