#### GROUNDS

- I. As because the SPIO has not adhered to the provisions envisaged Sub-section (8) of Section 7 of the RTI Act '05, procedure laid down where a request has be rejected. The SPIO is supposed to communicate the applicant stating reason for such rejection, the period within which an appeal may be referred and the particulars of the appellate authority.
- party information as laid down under Section 11 the RTI Act '05 has NOT been complied before rejection of RTI application, the provision is not to reject but to follow drills envisaged a five days written notice to third party of the request would be served on third party inviting submission. It appears that the RTI application rejected illegally and arbitrarily.
- III. As because the respondent misconstrued the contents of the application which sought permission to inspect relevant records whereas the respondent has nothing stated in his office Memo dated 28.03.23 rather advised contrary to request totally inconsistent to request.
- IV. **AS because** the request of the applicant / appellant has been wrongfully, illegally and arbitrarily rejected with malice intend to conceal the truth.

After perusing all the relevant documents as annexed therewith, the 1st Appellate Authority has found sufficient grounds to enquire into the matter and has decided to hear the instant matter on 26/05/2023 around 3:30 p.m in the chamber of the Appellate Authority in presence of all concerned vide Memo No.189/Gnl dated 22/05/2023.

On the date of hearing on 26/05/2023, the Appellant was present in person along with her Ld. Advocate Md. Qaiyam Ansari and the SPIO was also present along with Ld. Advocate and the dealing staff of the concerned department of this Municipality.

#### Decision

The matter has been called for hearing as per schedule.

Heard the submission of both the parties and after perusal of the record, it appears that the present SPIO could not provide the reply as per the RTI Act, 2005 as he is newly appointed in this post and he has no knowledge about such RTI Application, subject matter of which was happened much earlier before his joining in this official capacity. In fact, the subject matter of concerned mutation procedure and records were dealt with the earlier board of this Municipality, even before taking charge of this 1st Appellate Authority as the Chairman of this Municipality from the month of Attested by me Suparna chatterju appeallant January, 2014 onwards.

Upon due consideration, the 1st Appellate Authority heard the matter in length and found that upon hearing on this Appellant's application dated-30-07-2021 for insertion of her name in concerned holding no.939 under Ward No.21 of this municipality, she was earlier requested to approach the concerned Civil Court for establishing her claim regarding the suit property and to bring the said decision of the said Court of law before this Municipal Authority for recording her name vide-Item No.2 of CIC meeting dated-18-08-2021. Presently, as per the records available in the computer database of this Municipality, it is the information relating to other person, therefore it is barred to provide such information under sections 8 (1) (g) and 8 (1) (j) read with sections 9 and 11 of the Right to Information Act, 2005 as amended from time to time. But, it would be appropriate to direct the SPIO of Kamarhati Municipality to try to find out the documents related to the concerned mutation by the dealing staffs, if available. All other information provided by the SPIO vide Memo No-1727/Gnl dated-28-03-2023 are correct and according to laws and relevant facts.

#### Facts on Records:

- Smt. Suparna Chatterjee, daughter of Samarendra Chatterjee, the appellant submitted two RTI applications dated- 22.08.2022 & 02.03.2023 to the SPIO, Kamarhati Municipality. Being dissatisfied she submitted 1<sup>st</sup> appeal to the concerned department and 2<sup>nd</sup> appeal /complaint to the WBIC.
- 2. A) Smt. Suparna Chatterjee, vide her application dated- 22.08.2022 requested for the following information from SPIO, Kamarhati Municipality.:
  - i) When the last trade license was issued in the name of Samarendra Chatterjee? Please supply the photocopy of the trade license.

- ii) When the first license was issued in the name of Kanika Chatterjee after the death of Samarendra Chatterjee?
- iii) Which documents were submitted by Kanika Chatterjee on the basis of which the name of Samarendra Chatterjee was deleted from the roll of the license and the first license of Kanika Chatterjee was issued? Please supply me the photocopy of the said documents in manual submission of documents if software does not reflect.
- B) Grounds for 2<sup>nd</sup> appeal is non-receipt of information.
- 3. A) Smt. Suparna Chatterjee, vide her application dated- 02.03.2023 requested for the following information from SPIO, Kamarhati Municipality.:
  - i) Name / names of the person (s) in whose name the license has been issued by the concerned authority in respect of cycle garage in the name style of "Chatterjee Cycle Mart" situated at 4, Station Road Belgharia in municipal ward No 21 of your municipality.
  - ii) Name of the documents / papers submitted by the person who is presently enjoying license for the said premises/ shop.
  - iii) Name and designation of the officer in charge of the department.
  - iv) Name and designation of the person / officer who preside over the BOA on 30.12,2021 and person (s) who presided over the BOC on 28.04,2022.
  - v) Advise me procedure and fees for obtaining certified copy of board proceedings with minutes/agenda listed for resolution.
  - B) SPIO, Kamarhati Municipality sent a reply to the appellant vide memo no. 1727/Gnl dated 28.03.2023.

#### Deliberations and Decision:

- The SPIO is present virtually.
- 5. The appellant is present in person. She stated that she did not get the reply vide para 3 (B) above. She was given the copy of the reply available with the Commission under acknowledgement. The appellant reiterated her demand for copy of the documents submitted by her mother to the Municipality for issuing Trade License. It was pointed out to her that this is a personal information and is exempted under S. 8(1) (j) and (e) RTI

Act. After that she added that she filed two RTI applications and she has been replied one of the RTI application vide para 3 (B) above.

- 6. The Commission observed that after going through the queries in RTI application and reply it is seen that it is a dispute between the mother and the daughter about inheritance after the death of the father of the latter. It is also seen that various queries in two RTI applications are similar and the reply given by the SPIO vide para 3 (B) above and the discussions vide para 5 above provide adequate reply to all her queries in both the RTI applications. After this the appellant stated that the RTI application was filed by her lawyer who is absent today. She requested for another date. But the Commission did not find any reason to fix another hearing as all the relevant points were discussed. She added that she is not maintaining any relation with her mother for last 7/8 years. She reiterated her request for another date and she got emotional. She was reminded that this is a proceeding of quasi-judicial body and she should maintain decorum during the proceedings of the Commission. The Commission observed that she has been adequately replied. The case is closed.
- 7. The matter is disposed of.
