- iii) For that the Information as sought for by the Appellant does not fall under exempted category U/S.8 of the said Act.

Special Land Acquisition Officer, The Department of Land Acquisition, District Magistrate & Collector's Office of Malda for several months just for issuance of a copy of an order sheet pertaining to an L.A CASE NO. 12/ NH -34/08-09.

I am a senior citizen with various ailments and co-morbidities. Due to my health condition, I have restricted mobility. I have been trying to obtain this order sheet since August 2022 as you can find in the long list of letters mentioned in the reference. I have followed all due procedures and abided by whatever was asked to do. However, I have not received the order. I sent an authorized person to collect the order sheet and he was adamantly denied. The authorized person was even passively threatened that even though we have been submitting several applications it would not be sufficient to obtain the order sheet.

Please note that I already raised an alarm to the District Magistrate of Malda through a letter dated 8th August 2022 and requested his strict vigilance to prevent potential corruption in the disbursement of monetary compensation of more than 1 crore linked to the case for which I have been asking for an order sheet. I have observed a hostile attitude since the day I raised the alarm.

As I am left with no other options, I request your kind intervention in the issuance of the order sheet.

I, therefore, request you kindly to grant my request and oblige thereby.

I respectfully request the Commission to **take note that the late service of notice and information has since been provided to me by the Public Authority.**

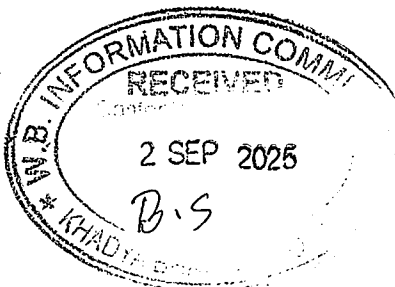
