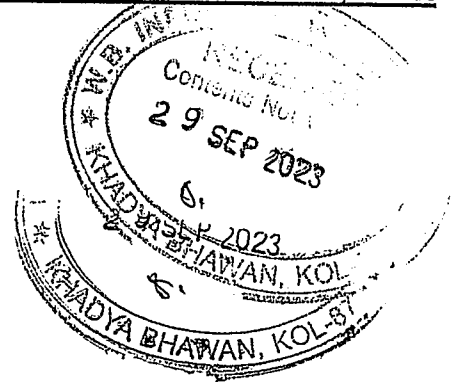

11. Brief facts:

The above query has been received by the SPIO by hand on 4.8.2023 and by Memo No. CMC/RTI/2023/105 dated 28.8.2023, answered that *"As per Section 8(1)(g) of RTI Act, 2005, no information can be provided"*.

12. Name of the Office or Department

13. The Grounds of Complaint:

- For that the SPIO in its reply dated 28.8.2023, has been given incomplete, misleading or false information, which is prima facie make out a case under Section 18(1)(e) of the RTI Act, 2005 against the SPIO.
- For that the SPIO is wilfully misconstrued the meaning, purport and object of Section 8(1)(g) of the RTI Act, 2005 which says that *"information, the disclosure of which would endanger the life or physical safety of any person or identify the*

*source of information or assistance given in confidence for law enforcement or security purposes;*” – which is not at all applicable in the present case and the SPIO has falsely invoked such provision only to safeguard the said Smt. Kalpana Banerjee out of some illegal motive and interest.

- (iii) For that the SPIO has failed and neglected to give proper and prompt reply to the RTI application filed by the Appellant and by citing a provision of RTI Act which is not at all applicable in the present case and thereby safeguarding the complainant in inspection done by CMC vide Notice No. BD-2/23-24/34 dated 01/08/2023.
- (iv) For that if according to the SPIO, the information as sought for by the Appellant will be the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes as said in Section 8(1)(g) of the RTI Act, then on the basis of which no inspection notice can be issued by the CMC authority to the Appellant.
- (v) For that the information as sought for by the undersigned is not related to any national or state security related matters and for which the same is not come under the provisions of Section 8 and 9 of the RTI Act.
- (vi) For that information as sought for by the undersigned is totally arising out of a private dispute and on the basis of it the CMC authority is conducting an inspection by giving notice to the undersigned also.
- (vii) For that without knowing the allegations leveled, the undersigned cannot participate in the inspection or any other proceedings to be conducted by the CMC authority.
- (viii) For that the said reply by the SPIO, knowingly given incorrect, incomplete or misleading information or obstructing in furnishing the proper information in the manner to safeguard some other person illegally.
- (ix) For that the conduct of SPIO in the present case, requires to implement Section 20 of the RTI Act, 2005 against him.

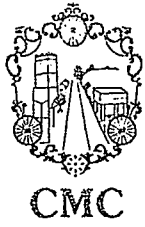



- (i) For that the SPIO is totally misconstrued the meaning, purport and object of Section 8(1)(g) of the RTI Act, 2005 which says that "*information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes;*" – such provision of law is not at all applicable in the present case.
- (ii) For that the SPIO has failed and neglected to give proper and prompt reply to the RTI application filed by the Appellant and by citing a provision of RTI Act which is not at all applicable in the present case and thereby safeguarding the complainant in inspection done by CMC vide Notice No. BD-2/23-24/34 dated 01/08/2023.
- (iii) For that the act of SPIO violates the statutory right of the Appellant which is guaranteed under the RTI Act, 2005 by not providing the information as sought for.
- (iv) For that if according the SPIO, the information as sought for by the Appellant will be the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes as said in Section 8(1)(g) of the RTI Act, then on the basis of which no inspection notice can be issued by the CMC authority to the Appellant.

- (v) For that such unmindful reply of SPIO violates the principles of natural justice for the Appellant since, the CMC authority is acting upon that complaint against the Appellant but without disclosing the allegations against her.
- (vi) For that the informations as sought for by the Appellant do not come under the scope and purview of Section 8 and 9 of the RTI Act, 2005, hence the reply on part of the SPIO is totally illegal and arbitrary.
- (vii) For that the reply of RTI request by the SPIO violates principles of natural justice for the Appellant and thereby giving illegal, unlawful and unethical protection to the Complainant, upon which the CMC authority has issued the inspection Notice against the Appellant vide No. BD-2/23-24/34 dated 01/08/2023.

5. SPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission.
