Sub: A serious complaint under Section 18 of the RTI Act against the Executive Engineer-I, Alipore Division, PWD, having his office at 32, Belvedere Road, Alipore Police Line, Kolkata- 700027 for not responding to the application under Section 6(1) of the Right to Information Act, 2005 dated 20.06.2023 and serious complaint against the Joint Secretary (Personal) PWD, 1st Appellate Authority under the Right to Information Act, 2005 for not responding an appeal preferred before him under Section 19(1) of the Right to Information Act, 2005.

Respected Sir,

I Sri. Amit Halder, Son of Late Ashoke Halder, Advocate, High Court, Calcutta having my office at 680/1, Gem Apartment, Gr. Floor, Dist- South 24 Parganas, Kolkata- 700063, do hereby state to inform your kind authority that pursuant to a mass representation dated 05.06.2023 lodged before the Executive Engineer- I, Alipore Division, PWD, an application under Section 6(1) of the Right to Information Act has been preferred dated 20.06.2023 before the Executive Engineer-I, Alipore Division, PWD seeking for information in regard to the current status in regard to the said representation dated 05.06.2023, and also the day to day progress as to the action/steps taken by the concerned authority after receiving the said letter of representation dated 05.06.2023 and information in regard to the name, particulars and designation of the officer who has been responsible to deal with the said representation dated 05.06.2023 and also to provide the necessary information in relation to the findings and opinion after disposing the said mass representation dated 05.06.2023.

But it is regrettably submitted that no response has been received to the said request for information or access to information within the specified time limit under the Right to Information Act, nor the said information has been provided by the delinquent/servant.

It is further submitted that being aggrieved and dissatisfied with the said not providing of the required information an appeal under Section 19(1) of the Right to Information Act, 2005 has been also preferred before the Joint Secretary (Personal) PWD, 1st Appellate Authority under the Right to Information Act, 2005 dated 07.08.2023, but no response has been received from the appellate authority till today for information or access to the information within the time limit specified under the Right to Information Act, 2005. That the said appeal even remained undisposed of till today, the statutory time to dispose of the said appeal has been elapsed. Both the authorities have not complied with the statutory provisions as envisaged in Right to Information Act, 2005, and there are reasonable and satisfactory grounds to enquire into the matter, and therefore your authority is requested to initiate an enquiry in this respect thereof.

It is further submitted before your kind authority that during the said enquiry of this instant complaint under the Right to Information Act, 2005 it shall be expedient for the ends of justice to examine each and every required document and record and after deciding this instant complaint on its merit, if your kind authority is of the opinion that the State Public Information Officer and the 1st appellate authority has without a reasonable cause, refused to furnish information within the time specified in sub-section 1 of Section 7 and have malafide denied the request for information obstructing me in any manner in furnishing the information and therefore shall impose a penalty of Rs. 250/- each day till the application is received or information is furnished in the most befitting manner for the interest of justice.

It is further submitted that a recommendation for disciplinary action against the State Public Information Officer may also be initiated for the ends of justice and oblige.

This is for your kind information and necessary action.

Subject : Complaint against one stall erected/installed on the Diamond Harbour Road in front of the premises No. 240, D.H. Road, Kolkata -700063, Police Station - Thakurpukur, K.M.C. Ward No. 124.

Respected Sir,

We the owners of Gem Apartment situated at 240 D.H Road, Kolkata 700063, Police Station - Thakurpukur, K.M.C. Ward No. 124, do hereby draw your kind attention and state to inform you that One Stall has been installed/erected with M.S / Iron structure by virtue of an illegal construction on the Diamond Harbour road in front of the Premises no. 240 D.H Road, Kolkata 700063, Police Station - Thakurpukur, K.M.C. Ward No. 124, on 20th May, 2023.

We have serious objection to the same but the occupier of the said stall could not be traced out and therefore the stall could not be removed, such a stall on the Diamond Harbour Road in front of our said premises by encroaching an area of 50 to 100 sq. ft of Government roadway and public place illegally is obstructing the main gate of our premises, exposing into the danger of accident of being run over by moving buses, cars and other vehicles on the main road.

The provisions enacted in K.M.C. act is here undermentioned.

❖ *Encroachments on streets*

369. PROHIBITION OF PROJECTIONS UPON STREETS, ETC.-

(1) No person shall erect, set up, add to, or place against or in front of, any premises any structure or fixture which will—(a) overhang, jut or project into, or in any way encroach upon, and obstruct in any way the safe or convenient passage of public along, any street, or (b) jut or project into, or encroach upon, any drain or open channel in any street so as to interfere

with in any way the use or proper working of such drain or channel or to impede the inspection or cleansing thereof.

(2) The Municipal Commissioner may, by a written notice, require the owner or the occupier of any premises to remove, or to take such other action as he may direct in relation to, any structure or fixture which has been erected, set up, added to, or placed against or in front of, such premises, in contravention of this section.

(3) If the occupier of such premises removes or alters any structure or fixture in accordance with such notice, he shall be entitled, unless the structure or fixture was erected, set up or placed by himself, to credit to his account with the owner of such premises all reasonable expenses incurred by him in complying with the notice.

❖ **371. PROHIBITION OF STRUCTURES OR FIXTURES WHICH CAUSE OBSTRUCTION IN STREETS :-**

(1) No person shall, except with the permission of the Municipal Commissioner granted in this behalf, erect or set up any wall, fence, rail, post, step, booth or other structure, whether fixed or movable or whether of a permanent or temporary nature, or any fixture in or upon any street or upon or over any open channel, drain, well or tank in any street so as to form an obstruction to, or an encroachment upon, or a projection over, or to occupy any portion of such street, channel, drain, well or tank.

(2) Nothing in this section shall apply to any erection or thing to which clause (c) of sub-section (1) of section 377 applies.

❖ **372. POWER TO REMOVE ANYTHING ERECTED, DEPOSITED OR HAWKED IN CONTRAVENTION OF THIS ACT :-**

The Municipal Commissioner may, without notice, cause to be removed—

(a) any wall, fence, post, step, booth or other structure or fixture which may be erected or set up in or upon any street, footpath or upon or over any open channel, drain, well or tank contrary to the provisions of this Act;

(b) any stall, chair, bench, box, ladder, bale, board or shelf, or any other thing whatsoever placed, deposited, projected, attached or suspended in, upon, from or to any place in -contravention of the provisions of this Act;

(c) any article whatsoever hawked or exposed for sale in any public place or in any public street or footpath in contravention of the provisions of this

Act and any vehicle. package, box, board, shelf or any other thing in or on which article is placed or kept for purpose of sale. display, or otherwise.

As per the penal provisions of the Indian Penal Code as envisaged under Section 283 where it has been stated that danger or obstruction in public way or line of navigation whoever, by doing any act, or by committing to take order with any property in his possession or under his charge, causes danger, obstruction or injury to any person in any public way or public line of navigation, shall be punished with fine which may extend to ₹200.


In view of the above facts and circumstances, I request your kind authority to take appropriate action to remove the said Stall immediately to avoid nuisance, public inconvenience and danger in a public way.

This for your kind information and necessary action.

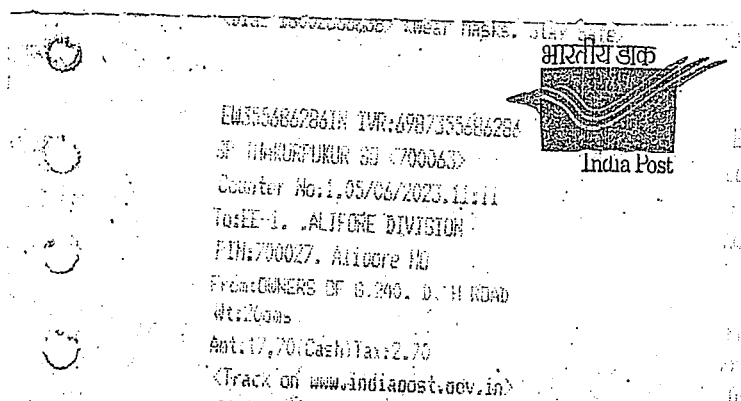

Brief facts leading to the appeal:-

1. That for the purpose of the better understanding the application u/s 6 of the Right to Information Act, 2005 dated 20.06.2023 preferred by the appellant is hereinafter called and referred to as "said RTI application".
2. That in pursuant to a letter of complaint lodged before your kind authority dated 05.06.2023, the appellant herein preferred an application under Section 6(1) of the Right to Information Act dated 20.06.2023 before the respondent authority seeking certain information.
3. Your appellant respectfully submits that it has been requested to the respondent authority to kindly provide your appellant the "information" in regard to the current status of the Letter of complaint dated **05.06.2023** lodged before the Executive Engineer- I Alipore Division, PWD.
4. Your appellant respectfully submits that it has been requested to the respondent authority to kindly provide your appellant the "information" in regard to the day to day progress as to the

action/steps taken by the concerned authority, after receiving the said letter of complaint dated 05.06.2023.

5. Your appellant respectfully submits that it has been requested to the respondent authority to kindly provide your appellant the "information" in regard to the name, particulars and designation of the officer who has been entrusted to deal with the said letter of complaint dated 05.06.2023 and what are his finding and opinion over the same.
6. Your appellant respectfully submits that it has been requested to the respondent authority to kindly provide your appellant with the "information" in regard to the reasons of law for not supplying the information to your appellant if not supplied according to under Section 7(8) of the Right to Information Act, 2005.
The photocopy of the said RTI application dated 20.06.2023 is annexed herewith and marked as letter 'P1'.
7. That the appellant most humbly states that the SPIO/Respondent authority malafide denied/refused from providing appropriate information in regard to the application dated 20.06.2023 preferred by the appellant, the respondent intentionally refused and neglected to provide your appellant the query No. 1, 2, 3 & 4 of the said "RTI Application".
8. Your appellant submits that the said letter of complaint dated 05.06.2023 by way of a mass petition has been lodged before the respondent authority, the respondent authority have received the same on 06.06.2023 according to the postal track consignment report. But have taken no steps or actions in connection with the same and thereafter your appellant preferred the said application under Section 6(1) of the Right to Information Act dated 20.06.2023 for seeking the

necessary information in regard to the status and progress of the concerned authority after receiving the said letter of mass petition.

9. In view of the above, your appellant submits before your authority that the respondent authority have refused, neglected and denied your appellant in not providing appropriate information in regard to the Section 6(1) as sought for through the said application dated 20.06.2023 under the Right to Information Act.
10. That the appellant most humbly states that the SPIO/respondent authority without going through the application thoroughly and hence deliberately avoided to put any specific comment on the aforementioned query and failed to provide the name, particulars and designation of the officer who have been entrusted to deal with the said letter of complaint which are arbitrary and in complete.
11. The appellant being aggrieved and dissatisfied by the "said Impugned reply" begs to prefer this appeal on the following amongst other grounds:-

GROUNDS

- I. FOR THAT the SPIO/Respondent intentionally acted escapist to provide your appellant with the information in regard to the current status of the Letter of complaint/mass petition dated 05.06.2023 lodged before the Executive Engineer- I Alipore Division, PWD.
- II. FOR THAT, the SPIO/ Respondent despite of the fact that the letter of complaint dated 05.06.2023 sent through speed post was delivered to the Executive Engineer- I Alipore Division, PWD on 06.06.2023 intentionally avoided to provide the relevant information to the appellant.

- III. FOR THAT the SPIO/Respondent intentionally acted escapist to provide your appellant the information in regard to the day to day progress as to the steps taken by the Executive Engineer- I Alipore Division, PWD, despite that the fact that application under Section 6(1) of the Right to Information Act dated 20.06.2023 has been received by the respondent authority on 22.06.2023.
- IV. FOR THAT the SPIO/Respondent intentionally acted escapist to provide your appellant the information in regard to the name, particulars and designation of the officer who have been entrusted to deal with the said letter of complaint dated 05.06.2023.
- V. FOR THAT the SPIO/Respondent intentionally acted escapist to provide your appellant the reasons for not providing information as sought for by the appellant through his application under Section 6(1) of the Right to Information Act dated 20.06.2023 and therefore failed to comply with the statutory provisions as laid under Section 7(8) of the Right to Information Act, 2005.
- VI. FOR THAT the SPIO/Respondent mala-fide denied/refused to disclose the materials on record and otherwise intentionally hide certain material on record by commission or omission.
- VII. FOR THAT the SPIO/Respondent deliberately neglected his lawful duties and acted improperly as a public servant by not providing the information to your appellant query No. 1, 2, 3 and 4 and other documents on records as sought for through the application under Section 6(1) of the RTI Act dated 20.06.2023.
- VIII. FOR THAT the SPIO/Respondent failed to record any cogent reason for not providing the required information to the appellant and deliberately did not respond.


12. This application is made bona-fide for the ends of Justice.

- b. For imposing penalty on the SPIO of Two hundred and fifty Rupees per day till the day the information is furnished to the Appellant.


