Disposal of all pending second appeals / complaints of Shri D. K. Bhaumik

Ref.: Notice vide memo no. 4411-WBIC-20011 (13)/528/2023-SEC-WBIC dated 20.12.2023

Date of Hearing: 25-01-2024

- 1. The WBIC issued a notice to the appellant Shri D.K. Bhaumik, 4/3K/171, Ho Chi Minh Sarani, Kolkata 700 061, vide the aforesaid memo. The appellant has submitted 43 appeals / complaints to the Commission and out of these, 30 cases are pending. Of these 30 pending cases, 22 are against West Bengal Financial Corporation only. The purport of the said notice was that the Commission intended to close all 30 pending second appeals / complaints submitted by the appellant to WBIC. The reason for the same was that the appellant is a habitual RTI applicant and has repeatedly misutilized the RTI Act.
- 2. The aforesaid notice was returned undelivered by the India Post with the remark "no such person in this address, hence not known".
- 3. The Law Officer, WBIC has submitted a report dated 24.01.2024 wherein it has been stated that several hearing Notices / Orders were sent on past several occasions through India Post on the aforesaid address. The Postal Department returned these posts with remarks "addressee left", on each occasion. It may be mentioned that no e-mail ID or phone no. of Shri Bhaumik is available in the appeals / complaints submitted by him. In 2020, the Commission published a notice vide memo no. 560-WBIC/RTI/429/17 dated 12.02.2020 on its website requesting Shri Bhaumik to provide proper address for communication. It was also mentioned in the said notice that if he fails to respond, all pending appeals / complaints will be treated as closed. A time period of six week was given to him for the purpose. However, before the expiry of six weeks, covid pandemic broke out. Now about four years have elapsed since the said notice was given on the website. Shri Bhaumik has not communicated any further. In the meanwhile, the instant notice as per reference above has also come back as 'undelivered'.
